Live video feed catches theft in progress

On Sunday, July 21, Tilla-mook 911 received a call about a burglary in progress. The victim, who lived near MP 10 of the Wilson River Highway reported that he was in Tillamook but that he could see on a remote camera that an unknown individual was attempting to kick in the door to his shop. He was also able to give a description of the individual and the involved vehicle.

When Sheriff's Deputies arrived at the residence, they cleared the area and upon his arrival, spoke with the owner who was able to provide additional information. The vehicle identified in the security camera footage was observed by law enforcement a short time later turning east onto Keening Creek near MP 17. The vehicle, a silver Dodge Durango, was stopped in the day use area of Cedar Butte and the driver, later identified as Jeffery Metzer, 42 years old from Portland, who matched the individual in the security footage, was arrested. Also located in the vehicle was drug paraphernalia and methamphetamines. Passengers in the car included Amber White, 36, also from Portland, with her 6-year-old son.

Metzer was arrested and lodged at the Tillamook County Jail. Charges for him included alleged: Violation of Probation, Criminal Mischief III, Criminal Trespass II, Reckless Endangering, Burglary II, and Unlawful Possession Methamphetamine.

Amber White was cited for alleged reckless endangering and released on scene.

HB 3309 allows public structures to be built in tsunami zones

n June 25, Oregon Governor Kate Brown signed House Bill 3309 into law. This law repeals the restriction that new essential facilities and new special occupancy structures may not be constructed in tsunami inundation zones. It also repeals the requirement that State Department of Geology and Mineral Industires (DOGAMI) Board adopt tsunami inundation zone parameters. The law overturns a

1995 prohibition on constructing new public facilities within the tsunami-inundation zone.

When the law goes into effect on January 1, 2020, municipalities will be able to build schools, hospitals, prisons, other high-occupancy buildings, firehouses, and police stations in areas that will be destroyed if a tsunami strikes.

According to DOGAMI's Interim Legislative Coordinator, Robert Houston, HB 3309 removes the

Sen. **Johnson** visits Tillamook

Senator Betsy Johnson has been busy. The Legislative Session ended at the end of June. Senator Johnson is getting reintegrated into the District and is busy with meetings, events, and public appearances. Senator Johnson is also one of three writing the budget for the state. She will also have meetings in Astoria that will span for a couple of days.

Johnson was able to attend the June Dairy Parade and was thankful for this. The capitol had been closed, which allowed her to attend the event instead of working in Salem. Johnson also attended the Garibaldi Days parade on Saturday, July 27.

Johnson says that this past Legislative Session was very difficult and unlike any others. Seasoned lobbyists and staff said they never attended a session like this. The political landscape has changed, she says. She saw evidence in this with protests for House Bill 3063 and House Bill 2020. House Bill 3063 removes the ability of a parent to decline required immunizations against restrictable diseases on behalf of a child for reason other than the child's indicated medical diagnosis. House Bill 2020 would introduce a statewide cap and trade

system to reduce carbon emissions. Hundreds of log trucks came down to the capitol with Timber Unity to protest House Bill 2020. For House

Multiple agencies react to manure spill at Port's digester operation

n Monday, July 22 the Oregon Department of Environmental Quality (DEQ) and the Oregon Department of Agriculture (ODA) received notification from the Oregon Emergency Response System (OERS) that a release occurred from the Regenisis anaerobic digester, at the Port of Tillamook Bay. First Strike Environmental responded and has been on site since noon on July 22.

According to a release from DEQ, upon further investigation, it was discovered that approximately 300,000 gallons of partially digested manure, digestate, was released and travelled from the digester to Anderson Creek. There is a 4-foot berm surrounding the digester with two entrances. According to Andrea Cantu-Schomus, **Director of Communications** for the ODA, the Port of Tillamook Bay bulldozed the entrances closed to contain the digestate.

According to Michele Bradley, General Manager of the Port of Tillamook Bay (POTB), "the bulk of the manure was contained on the digesters," she told the Headlight Herald. "Manure that was at the digester made it into the system – the POTB does not know how much, but there was 6 inches of standing manure in portions of the digester slab area that was then pushed and recycled into the digester, lessening the impact of what might have made it into the stormwater system."

Bradley could not confirm how much that may have

"The POTB does not have a total gallon number on what might have made it into the stormwater system," she said. "It was tank two, which is a finishing tank of the bay. The manure came from an overflow tank after a technical malfunction. The Port is almost 6 miles via

waterway to Tillamook bay. It is not a source of drinking water."

The POTB is the owner of the tank and is responsible for the Stormwater system via a DEQ General Permit, so it is in charge of all stormwater discharge within the industrial park.

'There has been testing from the DEQ, ODA, and Oregon Fish and Wildlife, among others," Bradley said. "A vacuum truck was brought to the location and has been sucking water out of the bay. The POTB doesn't know the impact of the downstream yet but DEQ tested on Tuesday, July 23."

The POTB's stormwater system was built by the Navy when they built the Naval Air Station for WWII. It includes groundwater as well. The Port has a settling pond near the outfall and before Highway 101 that holds millions of gallons of water. From there, it travels under the highway via Anderson

Creek, joins with South Prairie Creek, and enters the Tillamook River, then into Tillamook Bay.

"DEQ and ODA have taken and will continue to take samples from various locations in and around the site. The analysis of the samples is expected soon," Cantu-Schomus said. "Because the material is digestate and now raw sewage, there are no restrictions for shellfish operators or recreational harvesters in Tillamook Bay

at this time." As sampling results are completed, ODA will decide whether to issue any restrictions. ODA has reached out to all produces in the area to share information about the release of the digestate.

According to the release, results of water samples taken from Tillamook Bay indicate there was no impact on water quality in the bay from the release of treated manure

Rockaway's newly appointed Mayor talks future plans, events and goals

Mayor Sue Wilson was appointed mayor of Rockaway Beach at the May 8 city council meeting by a vote of the council. Mayor Wilson has plans for the small town, which include keeping the feel of a small town. Since she was appointed mayor, she has learned a lot and plans to do more as her time as mayor.

Wilson moved to Rockaway Beach in 2005. In 2007, she entered politics. She was elected to the council and ultimately ran for reelection four years later for the next term. She was subsequently voted president of the council, which is the person who steps up to lead the meeting when the mayor is absent. This helped Wilson step into the role of mayor.

There is a learning curve," said Wilson. "I'm learning more and more every day."

There are always two sides to everyone's story, says Wilson. She likes to look for the reasoning behind people's opinions and decisions. If a council member abstains from voting, she always asks them why.

Wilson says that she acts as a referee at times. She can't use her personal opinions to make decisions. She has to make decisions for the people. She has to remain neutral. The only time the mayor is allowed to vote is if there is a tie. Wilson hasn't had to do a swing vote yet.

The mayor position will be up for reelection in November 2020. The prior mayor finished about half of her term before Wilson took over.

Wilson mentions some events coming up in the town. There will be the kite festival at Rockaway Beach Wayside in August. It is a chamber of commerce sponsored event and the city will be 100 percent behind it.

One of the city official's major concerns is the Wayside's parking. People park RV's and trailers and think it is an appropriate place to park. Wilson says they are going to be dealing with this issue with signage in the near future.

There is a concern of children dashing out into the street and parking in general. Parking in Rockaway Beach is

limited. The town has one parking lot which can't be accessed by vehicles coming from the south. Wilson's hope for the parking lot, is for people to be able to park for an hour or so, enjoy the beach, and leave so others can find a parking space. The city isn't able to manufacture any more parking because the space for it isn't available.

"We think we manage our resources well. There is always room for improvement no matter where you live or what you do," said Wilson.

The council passed an ordinance in 2016, indicating that no one would be able to request usage of the Wayside three weekends of the year. These holidays are Labor Day, Memorial Day, and the Fourth of July.

"We want to give people a place to be," said Wilson.

People go to Rockaway Beach for the Fourth of July from the north and south. The train from Garibaldi this year was packed. Wilson thinks the train ride was a great idea because people didn't have to worry about the parking situation and could even stay

on the train to watch fireworks if they wished.

At the end of her time as mayor, Wilson wants to believe that she made a difference. One of her major goals is the completion of the Nature Preserve Trail. The Walkway just had its grand opening on June 15. A grant from the Department of Land Conservancy and Development paid for a deck to be built

around the giant Western Red Cedar, which helps protect the tree and its roots.

Working with the department heads is Wilson's favorite part about being the mayor. She likes being on the ground floor on making decisions. She meets with the City Manager the week before a meeting so that everything will be ready for the next meeting.

The next election for mayor is in November 2020. Wilson isn't sure if she will run for reelection or not. She owns a business in the town and is just beginning a new adventure with her daughter: a waffle food truck that will serve different variations of waffles. She will be serving these at the Tillamook County Fair this year.

prohibition on construction of certain essential facilities and special occupancy structures in the tsunami inundation zone. Decisions on locating new essential facilities and special occupancy structures within the tsunami zone occurs at the

local community level based on community needs.

The coasts of Oregon, Washington, and Northern California are exposed to tsunamis from distant earthquakes (such as the March 11, 2011 Tohoku, Japan tsunami) and local earthquake events. According to Houston, the greatest risk to Northwest coastal communities is from very large, locally generated tsunamis produced by an earthquake (magnitude 8-9+) occurring

offshore the coast of Oregon and Washington on the Cascadia subduction zone. DOGAMI has mapped the zones that would be inundated by a tsunami. Within the next 50 years, there is a 15-18 percent of a full margin rupture along the Oregon Coast and a 43-45 percent of a partial rupture along the

There are several sources available to Oregonians to prepare for a tsunami. DOGAMI's Tsunami

southern Oregon Coast.

Clearinghouse provides tsunami preparedness information for coastal residents, coastal visitors, boaters, kids and educators, community planners and scientists. Oregon Office of Emergency Management provides similar tsunami preparedness information that individuals, business and community members can use to strengthen resiliency. Local county emergency managers are available and provide

information to help enhance

community's preparedness for an emergency.

According to Houston, HB 3309 was a decision made by the legislature to restore flexibility, while ensuring that coastal communities remain safe. Passage of the bill could ultimately provide local coastal communities with an alternative path to improve public safety and resiliency, that may include adoption of the new ASCE 7-16 (Minimum Design Loads and Associated Criteria for Buildings and Other Structures) standard for constructing building within the tsunami inundation zone. Additionally, HB 3309 facilitates continued economic vitality of local coastal communities by linking essential services and the needs of the community together, said Houston.

Bill 3063, people used social media to organize people for protest. Sen. Johnson says that people who were once passive are now more engaged. More people are also shifting to nonpartisan. People feel that they need to be involved or they could be collateral damage.

Johnson attended a community event on Thursday, June 26 that was held by the Tillamook County Democrats at Tillamook Bay Community College at 5:30 p.m. This event was the Tillamook County Democrats Political Pie Party. As part of their mission to support and elect Democrats, they invited Democrats to their special meeting. They had pies fresh from Grateful Bread Bakery, and had presentations, questions, and answers from Senator Johnson and Arnie Roblan, the two State Senators for Tillamook County, along with two State Representatives, one of them being David

Johnson met with President Tomlin of Tillamook Bay Community College before the Political Pie Party.

Sen. Johnson is scheduled to have a meeting with Linda Kozlowski from the Oregon Department of Geology and Mineral Industries (DO-GAMI). Kozlowski is one of five members of the Governing Board, who sets agency policy and oversees general operations, and adopts a strategic plan every six years to guide DOGAMI's mission and objectives.

In response to Recall Kate Brown, Sen. Johnson says that "Recall is a serious undertaking" and has to be for valid reasons. Johnson doesn't think the recall will be successful. Recall proponents have until October 14 to submit just over 280,000 signatures. Johnson says that a recall is pretty extreme, and that she doesn't know the specifics of the complaint with the governor.

Sen Johnson says that she voted for the plastic bag ban

to keep the consistency of the bag ban across the state. She supports the grocery industry, and although she doesn't agree with the 5-cent charge on bags, she felt that voting for the ban was the right choice.

Sen. Johnson also has to deal with some constituent issues, such as issues with water wells. Johnson does a lot of rule writing. She serves over 130,000 people and often has people come directly to her about issues. She is proud of the constituent services they offer.

For the rest of the summer, Sen. Johnson will be busy with fairs, auctions, and regattas. Johnson buys food items from the auctions and donates them to the Food Bank. She is also working with craft distillers and the wine industry. She is working with OLCC

on those issues. One of the important issues that Sen. Johnson is focusing on is any moderation to House Bill 2020. She doesn't know if there can be a moderation, but she remains

hopeful. There will be a short sesSession will be back in session six months.

Sen. Johnson said that she has seen about 40 issues that could be on the ballot, but not all of them will make it. She said that she saw 35 petitions

for election filed with the Secretary of State and that it is possible that hopefully are out getting signatures now.



Modeling predicts blue whales' coastal foraging behavior, aiding population management efforts

Oregon State University

Scientists can now predict where and when blue whales are most likely to be foraging for food in the California Current Ecosystem, providing new insight that could aid in the management of the endangered population in light of climate change and blue whale mortality due to strip strikes, a new study shows.

The statistical model used for the predictions combines long-term satellite tracking data of the whales' movement patterns with environmental data such as ocean temperatures and depth, which helps researchers understand how climate variations might impact blue whales over time from a larger "ecosystem" view of the population.

"Most management decisions up to now have been based on locations where the whales tend to be found," said Daniel Palacios who holds the Endowed Faculty in Whale Habitats position at Oregon State University's Marine Mammal Institute and is lead author of the study.

"But it's not just where the whales are, but also the activity – are they actually eating there or simply moving through – that matters. This model can tell us which areas are the most important for actual foraging.'

The findings were pub-

lished today in the journal "Movement Ecology."

Blue whales can grow 70 to 90 feet long and weigh 200,000 to 300,000 pounds, though their diet is primarily krill - tiny shrimp-like creatures less than two inches in length. They are listed as endangered under the U.S. Endangered Species Act and the International Union for Conservation of Nature's Red

An estimated 1,600 of the world's 10,000 blue whales, known as the North Pacific population, spend time in the waters off the West Coast of the Americas. The North Pacific blue whale population can travel from the Gulf of Alaska to an area near the equator known as the Costa Rica Dome. The majority spend the summer and fall in the waters off the U.S. West Coast.

The California Current Ecosystem is the span of waters off the West Coast of North America extending roughly from the border with Canada at the north to Baja California, Mexico, at the south. Steady winds during spring and summer fuel a rich and biologically productive ecosystem. The study focused only on U.S. waters within this ecosystem.

The researchers' goal for the study was to better understand the blue whale behavior in the context of



this ecosystem by examining the relationship between feeding behavior and ocean conditions during the feeding

Palacios and colleagues used long-term satellite tracking data from 72 tagged blue whales as well as ocean condition data from remote sensing during the same period, 1998 to 2008. Little was known about the blue whale until the 1990s, when Bruce Mate, director of OSU's Marine Mammal Institute, pioneered the satellite tracking studies that produced a wealth of data not previously available.

The data used in the foraging study included several years of cool, productive ocean conditions as well

as a couple of warm, lowproductivity years, during which food was less likely to be plentiful.

The researchers found that blue whales were more likely to exhibit foraging behavior in areas known from earlier studies for hosting large whale aggregations, providing an improved understanding of the relationship between environmental conditions and whale habitat use.

"The same environmental parameters - water temperature, depth, abundance of phytoplankton - that drive hotspots of whale aggregation also drive where foraging behavior is more likely to occur," Palacios said. "While this was not necessarily surprising, it was good to be

able to demonstrate that we can predict whale behavioral states, as this helps inform management in terms of not just what areas are used more often by the whales, but also what they do once they get there."

They also found that whales were less likely to exhibit foraging behavior when they were further away from the coastline. The primary foraging hotspots are found in a few locations along the coast, where krill aggregations are typically most dense and persistent.

The study also supported findings from another recent paper by Palacios and colleagues that showed that blue whales rely on long-term memory to find the best places to forage, and return to them year after year. That makes them susceptible to climatic disruptions to their prey base, as the whales may take some time before they abandon their traditional foraging sites.

Improved understanding of the species-environment relationship, through an ecosystem view of whale behavior, can give researchers a better understanding of how climate change might impact whale feeding, Palacios said.

The study also could help with population management decisions. North Pacific blue whales tend to aggregate in three primary areas: Point Conception and the Santa Barbara Channel in southern California; around the Gulf of Farallones in central

California; and between Cape Mendocino and Cape Blanco in northern California and southern Oregon.

Two of those hotspots are in areas of intense commercial shipping traffic near Los Angeles and San Francisco. Blue whale mortality due to ship strikes is a growing concern.

"If there are some areas along the coast that are more biologically important for the whales, based on intensified foraging activity, that's important for management agencies to know, compared to areas where the whales are just passing through," Palacios said.

The researchers' next step is to look more closely at how whales' behavior shifts during years when ocean conditions are unfavorable for food production.

"How long will it take blue whales to abandon their historic feeding grounds if the food is no longer there?" Palacios said. "If they do respond to environmental changes, how do we predict that change long-term?"

Other researchers on the study include Bruce Mate and Ladd Irvine of OSU's Marine Mammal Institute; Helen Bailey of the University of Maryland; and Elizabeth Becker, Steven Bograd, Monica DeAngelis, Karin Forney and Elliott Hazen of the National Oceanic and Atmospheric Administration.



CHAMBER CHATTER

Saying goodbye to Alex and hello to housing solutions

Over the last nine months the Chamber has been fortunate to play a role in helping tackle the housing crisis within the City of Tillamook. We applied for and were accepted into the RARE program (a division of AmeriCorps) and with that came our newest staff member, Alexander Jonas.

Alex came to us as a recent graduate from Florida State where he studied political science and international affairs with a focus on economics. He was relocated to Tillamook to serve as our Housing Policy & Development Coordinator.

In this role, having Alex in this role at the Chamber has allowed us to make a housing impact greater than we could ever imagine. When we set out with this program our goal was to help make various policy changes to assist developers, but we have done so much more and Alex will have a mark on Tillamook for many years to come.

Alex was able to make great strides to help the City improve their development process. He collaborated closely with the city to put together what is essentially a System Development Charges (SDC) financing plan, which they adopted earlier this summer. This plan allows developers to finance their SDCs instead of paying them all up front. SDCs can amount to hundreds of thousands of dollars for multi-family housing de-



velopments and are typically paid in full before a building is even occupied. By deferring these costs a few years (but not waving them), this would alleviate the financial frontload for the developer without undercutting the needed long-term funds for the City. And, since the City may collect interest during the deferral period, it would theoretically equate to more long-term revenue than had the SDCs been charged upfront.

Garibaldi has had success with a similar model, as well as other Oregon cities that Alex was able to pull data from in helping draft the policy for the City of Tillamook.

To put his stake in the ground, Alex drafted a \$200,000 Oregon Main Street Revitalization Grant to build four market-rate apartments above Lisa Griener's Oregon Coast Dance Studio. This is a competitive statewide grant awarded to downtown areas in Oregon in need of economic development, and Lisa's project was awarded the grant. The current project timeline estimates that the renovation will begin next


date around the beginning of 2021.

As if that wasn't enough, having this housing program in the Chamber and its connection to the Tillamook County Board of Realtors, we were asked to assist in finding available property for a Oregon developer looking to build 50-100 market-rate units within the City. Though grinding to find property and with the City's help with a rezone always hate to count my blessings too early - but as of a phone call received just last week it looks like Tillamook should be getting another 73 unit apartment complex within the next year.

Needless to say, Alex's

time has been well spent here at the Chamber. What you can be sure of is that because of the willingness of the Chamber Board of Directors to venture into our economic crisis of housing - the funding put forward by the Tillamook County Board of REALTORS, Pacific Seafood and other generous donors - Coupled with Alex's hard work - Tillamook will have a much different housing landscape in a very short amount of time. Alex is about to transition from a Seminole to a Duck as he has decided to stay in Oregon to pursue his Masters Degree at the University of Oregon - that's a big deal that college football fans everywhere will understand. Be sure to stop in to the Chamber HQ and wish him well before he goes.



waste at the Regenis facility. As a result, analysts with the Oregon Department of Agriculture shellfish and food safety programs have determined that the release does not pose a health risk and no action is required by shellfish harvesters.

Water samples taken from the Regenis outfall pipe at Anderson Creek did show elevated levels of e coli, but downstream tests did not show elevated e coli levels. The Oregon Department of Environmental Quality is working with the Port of Tillamook Bay on

ways to further contain the contaminated water at the outfall.

The ODA will continue

to monitor water quality in the bay by taking additional samples and testing for potential contamination.



GARDENING MATTERS

On using natives



n my last column I talk-Led about some shrubs that I have found to be helpful in my own garden to set a tone and act as the bones of the garden. This week, I want to tell you about some lovely native plants that can also be used as background plants for the flower beds.

Knowing how aggressive some of our native plants can be (think salal and horsetails), I have chosen several native shrubs that are wellmannered and will stay put – for the most part – where they are planted.

The first shrub to consider

is the Buttonbush (Cephalanthus occidentalis). These are good alternatives to the invasive butterfly bushes, and can get to be quite large at six to ten feet tall and wide. This shrub likes moist soil but, once established, will tolerate a wide range of moisture and soil conditions. It does like rich soil in full sun to partial shade and will grow quite quickly to ten feet. But it also tolerates heavy pruning to keep it under control. It blooms throughout the summer months with fuzzy white globes of sweetly-scented flowers. Butterflies flock to enjoy its pollen. The glossy green oval foliage turns yellow in the fall, with clusters of dried "nutlets" staying all winter. The irregular winter silhouette can be quite attractive and foliage will emerge in late spring. This is when it can be reshaped and dead growth removed. I am also taken with the Ceanothus thyrsiflorus, also

known as wild lilac or Blue Blossom. In fact, it is one of the favorite shrubs in my garden. Considered to be

a native of California and Southern Oregon, I still consider it native to our area as it does so well and can be commonly found. In spring and early summer, it puts out masses of deep blue flowers that float like clouds above the

dark green foliage. Ceanothus flowers are said to be fragrant, but I can't say I have noticed this in the one I have. This plant is an evergreen shrub, but it, too, gets quite large at four to

Ceanothus can be used as a specimen plant, as a hedge, or when lower branches are pruned – as a tree in a small garden. The height can be easily con-

food in your pantry. Keep flashlights, lanterns and extra batteries on hand. And, in Cape Meares, know who your emergency preparedness neighborhood captain is. If you don't, find out by contacting Kathy Burke at 503-369-2055.

sidered invasive in the states surrounding the Great Lakes and California, too. Instead, try the Pinemat Manzanita (Arctosaphylos nevadensis) which is considered native from British Columbia south to California. This shrub is good to use as a groundcover as it grows one to two feet tall and two to six feet wide. It produces pink, waxy flowers in the spring that develop into red-brown berries that often stay on the plant through the winter. The oval, leathery green leaves are held upright on the plant, and hide the mahogany-colored stems. This makes a great weed-free groundcover, or cascade it over a wall. It also helps with erosion control.

Pinemat Manzanita prefers well-drained soil, even sandy or loamy soil. It does like full sun to part shade. Although it is heat and drought tolerant, ample summer moisture helps it grow better. And while it may take a few years to fully establish, it is worth the wait.

A larger, more impressive Manzanita is the Arctostaphylos Columbiana or Hairy Manzanita. This Manzanita forms tight mounds of six to ten feet tall and wide with foliage all the way to the ground. This is an evergreen shrub with small, hairy elliptical leaves of a blue-green color. Terminal clusters of white or pale pink flowers that are bell-shaped are quite showy. They turn to bright red berries that last into winter. This Manzanita can be used as a hedge, screen or specimen plant and is good for erosion control. They like moist, sandy soil (loamy is okay, too) and should be

planted in full sun to light shade. You won't have to prune this one very often, as the crown stays nice and tight. But do keep this one deeply watered to keep this tough and adaptive plant

happy.

There are, of course, some other very nice native shrubs used easily in most gardens. Ninebark (Physocarpus opulifolius), for example, has some unusual bark that makes it a year-round shrub of interest in the garden. Easy to grow as well. The American Beautyberry (Callicarpa americana) and Twinberry (Lonicera involucrate)are two more I can name that do well on the coast, are lovely in the garden and uncomplicated to






