## Oregon seeks fed emergency declaration

Oregon Gov. Kate Brown is asking President Biden to approve a federal emergency declaration for the State of Oregon due to extreme risk of significant

On Wednesday, Sept. 14, Brown released the following statement about her request.

"Last week, as Oregon faced forecasted high winds, sustained hot and dry conditions, and the potential for lightning — and with 168,000 acres burning across the state at the time — Oregonians braced for increased and worsening fires. State firefighting teams and agencies, along with local partners and resources brought in from California and Washington through the Emergency Management Assistance Compact, mobilized to prepare for a swift response and to protect lives, communities, and our natural resources.

"Thanks to science and data, we know enough in the days ahead of anticipated weather and fire patterns — just like states that prepare for hurricanes — that it is imperative to communicate with the public, pre-position resources for our fire response, and employ preventive measures, such as public safety power shut-offs. All of these efforts reflect a modernized approach to meeting the needs of fighting the fires of this century; they are proactive measures that we can take to protect communities and save lives.

"The request I made for a federal disaster declaration is critical to helping bolster our state's response, and it presents an opportunity for Oregon to partner with the Federal Emergency Management Agency (FEMA) to bridge the gaps we know exist as we work hard to protect our communities. We still have several weeks of peak fire season ahead of us, five large active fires, and 274,000 acres burning statewide. If granted, Oregon would be the first state ever to receive such a declaration for wildfire response but unfortunately, certainly not

the last to need this important assistance.

"I am incredibly grateful for the strong partnership we have with the Biden-Harris administration and with FEMA, with whom we have worked over the past several years on various emergencies. I urge their earnest consideration of my request so that, together, we can protect Oregonians and our communities, and serve as a model of federal support for states facing the ongoing threat of wildfires."

#### What's ahead

National Weather Service (NWS) Meteorologist John Bumgardner in Portland said the region is now moving toward more seasonal weather.

"It looks a lot like normal weather for this time of the year and the rain helped knocked down some of the smoke and haze from the wildfires," Bumgardner said. "The high temperatures will be in the mid 70s, which is a few degrees below normal."

Bumgardner said the NWS office in Portland recorded approximately 0.3 of an inch of rain Sept. 12 and more rain is likely by the coming weekend.

#### Fire danger persists

Oregon's wildfire season often extends into late fall, and fire district officials caution that several days of prolonged rain is necessary to ease the current threat of fire.

"We still need to be vigilant with our use of fire and preventing nuisance fires on the landscape,"

District Chief Pricher said. "In some

fire years, fire season can extend into October. In other words, caution is still needed with campfires."

"The fire danger is going from Extreme back down to High (Red to Yellow), however, this is nowhere enough rain to declare fire season over," he said. "While the 1-hour fuels (grass and pine needles) were significantly affected, the 10-hour fuels (.25 inch up to 1 inch in diameter) and 100-hour fuels were not touched. What this means is that the water will evaporate very quickly after the sun comes up."

Pricher said Columbia and Multnomah counties outdoor burn ban remains in effect. Last weekend's ban on campfires, charcoal barbecue and portable propane / patio fireplaces is no longer in effect.

Columbia River Fire & Rescue (CRFR) Public Information Representative Jennifer Motherway recommends that the public pay attention to local fire department websites and social media pages to follow potential weather and hazardous threats. 'We aren't in the clear yet from

the fire danger and our agencies are generally really great at getting any communications about hazards posted via social media to our communities, she said."

Motherway encourages residents to sign up for the CAN system, an electronic notification system.

"That is the best advice we can provide the community," she said. "The more people sign up the better chance we have at getting a larger communication out to our community.'

Pricher also urges local com-

munity members to be aware of the Ready (Level 1 evacuation), Set (Level 2 evacuation) and Go (Level 3 evacuation) in the event the area experiences a rapidly growing emerg-

ing wildfire incident. He urges property owners to make sure they have defensible space in place to best protect their homes and businesses.

"Community members should check with their local fire agencies for more information and in some cases, we will come out and survey their property on how to harden a home in the urban interface area," Pricher said.

#### Red flag warning

The NWS issued a Red Flag Warning Sept. 8 for much of Oregon and Washington, which means that critical fire weather conditions are either occurring or will shortly. A combination of high winds, low humidity and drought can contribute to extreme fire behavior, the NWS said.

Late Thursday afternoon, Sept. 8, Gov. Brown conducted a media briefing about the approaching windstorm and the extreme wildfire conditions. Brown was joined by state fire and emergency management officials and leaders of the state's two large electrical utilities.

"We are at a critical point, any additional fires would be problematic," Oregon Chief Deputy Fire

Marshal Travis Medema said. "The combination of dry conditions, high winds and low humid-

## Oregon's revenue forecast shows big kicker

he latest Oregon Revenue Forecast shows the projected personal kicker is \$3.5 billion, which will be credited to taxpayers when they file their returns in Spring 2024. The projected corporate kicker is \$1.1 billion, which will be retained for educational spending.

Overall, the forecast shows the state will see an estimated \$600 million in additional surging tax revenues.

The report by the Oregon Department of Administrative Service issued Aug. 31 to Oregon 's legislators, also comes with a warning about a national "The risks are real. The outlook

Governor Kate Brown issued the following statement about the state's September revenue forecast:

Thanks to the fiscally responsible decisions the State of Oregon has made over the last several years, we are well positioned with significant reserves to weather any economic challenges that lie ahead. Now, we must continue to make investments to benefit Oregon's working families, so that all Oregonians can feel the benefits of our strong economic recovery.

"With rising costs of living continuing to impact Oregon families and businesses, the Legislature can, in the budget for the next biennium, build on the investments we made in the last session—particularly in housing, workforce development, behavioral health, and child care.

"And, thanks to the work of Oregon's congressional delegation and the Biden-Harris administration to pass the Inflation Reduction Act and the Bipartisan Infrastructure Law, we can continue to invest federal dollars to lower costs and create jobs for working families."

#### **Revenue Forecast Executive Summary**

Economists are on recession watch. The combination of slower economic growth, high inflation, and rising interest rates has historically been problematic. That said, despite the crosscurrents in the economic data so far this year, the U.S. economy is unlikely to have entered into a recession. Employment and industrial production continue to grow.

Personal income and consumer spending are rising quickly but struggling to outpace the fastest inflation the U.S. has experienced since the early 1980s. While this may be reassuring today, the risks to the outlook are real. Inflation remains the key issue. Even as headline inflation slows in the months ahead, the underlying inflation trend is likely to remain above the Federal Reserve's target. As such, the Fed is raising interest rates further to cool the economy.

Given the impact of rate increases is generally felt one to two years down the road, getting policy just right is extremely difficult. In our office's recent forecast advisory meetings there was a strong consensus that the risk of recession was uncomfortably high.

The outlook is essentially a coin flip between the soft landing and a recession. For now, our office is keeping the baseline, or most probable outlook as the soft landing and continued economic expansion.

Employment, income, and spending continue to grow, but at a slower pace than assumed in previous forecasts. This slower growth is needed for inflation to subside. However, if inflation does not slow as expected, and the Federal Reserve raises rates even further, our office's alternative scenario of a mild recession beginning

ity can lead to explosive fire growth," Oregon Department of Forestry Fire Chief Mike Shaw said during the media briefing. "We are very concerned about the next 72 hours and what that means both in terms of what new fires will start and the larger fires on the landscape."

Shaw said the current wildfires are threatening hundreds of homes in Oregon.

State operated electronic reader boards along highways in Oregon were used to alert the public of the danger with the warning: "Extreme wildfire conditions. Use caution." Be prepared

Brown urged all Oregonians to be prepared for evacuations.

"Go to bed tonight with a plan in the event your family needs to evacuate, or you wake up without power," she said. Brown encouraged anyone who hasn't, to sign up for emergency notification alerts at ORALERT.gov.

"Now is the time to charge your devises, make sure you have batteries, have nonperishable food and water available and extra medications in case you have to go without power for a couple of days, or if you need to evacuate from your home because of fire," Oregon

Emergency Management Director Andrew Phelps said.

He also urging everyone to have an evacuation plan in place and to be ready to go if wildfires are threatening their community. Phelps said in the case of evacuations, everyone needs to be ready.

"Leave your home quickly," he said. "Have your go-bag ready to go."

Phelps also encouraged community members to check on their neighbors, friends and co-workers and to make sure they are safe.

"This is really about doing what you can, where you are, with what you have," he said.

Phelps added that being prepared will allow first responders to help others who may need help the most.

On Sept. 7 Pacific Power and Portland General Electric (PGE) alerted thousands of customers that Public Safety Power Shutoffs (PSPS) would be possible due to the increasing wildfire conditions.

"Turning off power is the last resort," PGE CEO Maria Pope said. "It is only done to protect customers, property and the communities that we serve from fire."

Pacific Power estimates that 1.700 customers north of Lincoln City in the Three Rocks area, Otis and the Rose Lodge area were impacted by the Public Safety Power Outages Friday, Sept. 9.

The electric power was restored later Saturday, Sept. 10, according to Pacific Power Public Relations Representative Drew Hanson, who added that during the PSPS, crews were hard at work.

'That allows us to get in there and clear any debris and make any repairs necessary, so once that is done, we'll get power back on," he said.

Hanson said the need for the PSPSs has been decreasing since the Sept. 10 wind event.

"We haven't seen any indication that another shutoff would be necessary, but it is all weather dependent," he said.

According to Hanson, the Pacific Power weather team had been tracking the wind event for several days, providing updates daily that indicated where the most need would be for crews to be staging, given the combination of low humidity, high winds and dry conditions.

Before the event, Pacific Power worked closely with local emergency management planners at cities and counties in the utility's districts with table-top exercises for best preparation.

The utility also planned to bring in additional crews and equipment to Lincoln City late Friday as a proactive effort to be ready to respond to any weather-related event.

"It's the normal equipment. such as polls, wires, trucks and professional line persons that we have readily available,"

Hanson said. "They will be out there inspecting, so it will be an active time as the crews work to make a quick and safe restoration of service."

He added that such events are another reminder for local residents to be prepared for power disruptions, no matter what the season.

#### Governor's caution

During her media briefing, Brown said the state's work over the past few years has helped to better prepare communities for wildfires, that there are more resources available, and healthier landscapes have been created during the off season. "This has made a huge difference," Brown said.

At the end of the briefing, Brown again stressed the urgency of the current wildfire danger.

"Our goal today is to encourage Oregonians to be prepared and have a plan," Brown said. "Each one of us can make a difference in the next 24 to 72 hours. Our goal is to save lives and to save property."

As the winds shifted Saturday, Sept. 10, smoke drifted from the wildfires in the region into Columbia County and across much of the state. The Oregon Department of Environmental Quality (DEQ) issued air quality advisories for Northeast and Southwest sections of Oregon due to the unhealthy conditions.

in late 2023 is more likely. Heading into the budget development season, growth in Oregon's primary revenue outstrip expectations. Both personal and corporate tax collections remain strong, in keeping with income gains seen in the underlying economy. The forecast for the current 2021-23 biennium has been revised upward. Although the near-term forecast calls for additional revenue, this is offset in future budget periods by a more pessimistic economic outlook.

Growth in spending and wages will need to slow to tame inflation, which translates into less state revenue growth across a broad range of taxes. The potential recession would weigh heavily on revenues over the next several years. However, even if the economic expansion persists, General Fund revenues are due for a hangover in 2023-General Fund resources

have continued to expand in recent years despite large kicker credits being issued. This growth is expected to pause in the near term, as nonwage forms of income

return to earth and gains in the labor market slow. Recent gains in reported taxable income have been driven by taxpayer behavior as well as underlying economic growth. Investment and business income are not always realized for tax purposes as the same time they are earned in the market.

Late 2021 was a great time to cash in assets, with equity prices and business valuations high, and potential federal tax increases on the horizon. Income reported on tax returns last year grew at more than double the rate of economic measures of in income. After so much income was pulled into tax years 2020 and 2021, less will be realized in the near term. And with recessionary risks rising, profits and gains could turn into losses, and a smaller share of filers could be subject to the top rate.

The bottom line is that the unexpected revenue growth seen this year has left us with unprecedented balances

this biennium, followed by a record kicker in 2023-25. The projected personal kicker is \$3.5 billion, which will be credited to taxpayers when they file their returns in Spring 2024. The projected corporate kicker is \$1.1 billion, which will be retained for educational spending. If current balances are not spent, net General Fund revenues for the upcoming 2023-25 biennium will be reduced by \$24 million relative to the June

2022 forecast. The Oregon economic forecast is published to provide information to planners and policy makers in state agencies and private organizations for use in their decisionmaking processes.

The Oregon revenue forecast is published to open the revenue forecasting process to public review. It is the basis for much of the budgeting in state government. The report is issued four times a year; in March, June, September, and December.





#### Response to Sept. 6, letter from **Oceanside True Friends PAC**

Oceanside faces a historic decision: whether to continue under County governance as it has for 100 years, or to form a new city and manage its own affairs. We are the community leaders who initiated the incorporation petition. To earn a place on the ballot, the law required us to obtain signatures by at least 20% of Oceanside's voters. We exceeded that. Then we had to compile an extensive "Economic Feasibility Statement" (EFS) for the County Commissioners to approve. Our EFS demonstrated that by 2024, the City of Oceanside will enjoy over \$1 million a year in revenues, including \$600,000 in TLT funds that now goes to the county. It also showed that this would amply cover the city's anticipated service costs.

At the county hearings, Oceanside True Friends PAC furiously tried and failed to discredit our EFS. Instead, after six months of intense

scrutiny, the Commissioners unanimously approved our economic projections.

Having lost that argument, the "True Friends" wants to change the subject from Oceanside's overall fiscal health to focus on a single side-issue they've raised as a scare tactic: Who will pay to upgrade Oceanside's storm drains 20-30 years from now? Most Oceansiders are far more concerned about the three hotels that might be built in the next few years than what could happen in 2050, but we do need to clear this Oceanside, like many

coastal communities, has aging storm drains that will need updating two or three decades from now at a cost of \$200-\$300 million. This will happen regardless of whether Oceanside incorporates. True Friends, however, is telling Oceanside voters that we can avoid that cost if they vote against incorporation because the county would pay for it. This is a recklessly false red herring. They know that the County has flatly said it will never have the general funds to pay for such a project, in

Oceanside or elsewhere.

Instead, such large projects are usually financed in one of two ways: state/federal grants or voter-approved bond levies (loans). Voter-approved bonds are least likely, because they are the most difficult to get passed, but let's start there. If we incorporate and Oceanside voters approve a bond, then of course they would make the payments. But if the county orchestrates such a bond for the unincorporated community, Oceansiders would STILL pay for it because county-wide voters would rightfully reject any such ballot measure. Instead, Tillamook County Public Works Director Chris Laity predicts that the county would help organize a "special storm drain district" that would administer the bond and bill Oceanside property owners for the payments. In other words, Oceansiders would pay for any bonds regardless of whether we incorporate. The suggestion that the County would do so is beyond ridiculous.

For these reasons, it is far more likely that the either the County or an incorpo-

#### of Oceansiders are opposed to incorporation

Oceanside is predominantly a retirement and vacation community with approximately 300 full- time residents. An overwhelming number of property owners are not fulltime residents (most of whom are registered to vote in their primary residence location) yet will be affected by the incorporation measure on the November ballot. Consequently, most of the property owners outside of the Village proper will have no say in the

The whole of Oceanside comprises a number of smaller neighborhoods outside of the Village, each having its own origins with individualized covenants, codes and restrictions. These neighborhoods are comprised of the Radar Road, Avalon, Hillsdale and Grand communities together with the subdivisions of Trillium, Terrasea, Camelot, and The Capes. Not surprisingly, it is a small faction of proponents in the Village proper that has pushed for the incorporation measure as they need the tax dollars of property owners outside of the Village to fund their desired city.

The petitioners are pushing several alleged benefits for incorporation. These include road maintenance, tourism, traffic management, strategic planning and regulation of short-term rentals. Many of these issues are concentrated in the central Village of Oceanside and not the greater neighborhoods outside the Village. Even so, the proponents do little to provide for the budgeting of such items within the proposed tax increase. For instance, their budget provides for pothole repairs instead of necessary road resurfacing and for regulation of non-existent hotels and subdivisions ahead of crucial storm drain repair, leaving the potential for a catastrophic mudslide for another day. This short-sightedness is troubling and reason enough not to incorporate.

## The vast majority

From the outset, those outside of the Village have tried to make their opposition known to the Tillamook **Board of County Commis**sioners (TBOCC). The

Capes had the foresight and financial resolve to retain legal counsel to avoid having their fiscal fate being determined by a minority of voters outside of their community. The Capes' attorney successfully argued that The Capes should be excluded from incorporation for among other things, their CCRs and HOA self-governance. The arguments made by the attorney were glaringly applicable to other HOA controlled neighborhoods such as the Terrasea and Trillium subdivisions. Similarly, property owners of Radar Road argued that their roads were either owned privately (Radar Road itself) or by the county (i.e., Cape Meares Loop Road), and therefore wouldn't need city

maintenance at all.

On July 28 of this year,

the TBOCC held a final public meeting to determine whether the petition to place the incorporation measure on the November ballot was warranted. The process included a request for input from residents within the proposed boundaries in order to gauge the desire for incorporation. The Commissioners received written testimony from 228 Oceanside residents. Of those responding, 159 property owners were against incorporating and only 69 were in support. Despite the opposition of 70% of the respondents, the Commissioners decided to allow the measure to be placed on the ballot. The vast majority of property owners who are within the proposed incorporation boundaries have no say in the outcome despite being asked

The bottom line is the property owners of areas outside the Village of Oceanside are rightfully concerned that they will be taxed to cover expenses that, in actuality, benefit only a small contingent of voters in the Village itself. Those unable to vote or living outside of the Village would stand to receive feint consideration for the distinct issues, services and provisions already being reasonably addressed and sustained by the county and their respective HOAs. Property owners do not see the value of a guaranteed increase in their property taxes should Oceans-

to pay more for less.



Stroll through downtown Dallas these days and you'll be astonished at the resurgence. Five formerly dilapidated historic commercial buildings housing ten storefronts are undergoing major remodels and already the new shops are bustling.

What may be even more astonishing is that every one of those projects has been spearheaded by one couple, Don Sheely and his wife Debbie Boone, although Don is quick to point out that it's been a team effort", citing the invaluable contributions of local tradespeople, city officials, their real" estate leasing agent, even his bank.

There is of course a backstory and it's fascinating. Both native Oregonians, Don and Debbie became financially stable by working hard for others. Starting as a butcher, Don climbed up the ladder to become an executive at Unified Grocers. But when his job required a move to California, Don and Debbie decided that living in Oregon was more important to them than a steady paycheck.

By mortgaging their beach house and borrowing from Debbie's parents, they acquired the starting capital to begin to purchase and remodel commercial and residential properties in small Oregon towns, creating businesses, jobs and brightening communities. They were hands-on developers, participating in the renovations and often working in the businesses they were developing. mentored employees and eventually sold them the businesses. Businesses that all continue to thrive.

You could call Don and Debbie both prolific and risk-averse, because in their 22 years of development the couple has continually gambled their own savings to purchase, renovate and develop five grocery stores, two restaurants, a shopping mall and dozens of homes in ten small Oregon towns, creating well over a hundred permanent jobs.

Don and Debbie, who live locally and still own and operate a Dallas restaurant, have long considered the revitalization of Dallas' historic downtown to be an important step for the community. Each of the five buildings they purchased were in very bad condition, requiring nearly total renovations. But all had unique character that Don and Debbie were adamant to preserve. Much of the work has already been done, but when the project is completed, more than 25,000 square feet of commercial space will again serve the community.

This is an example of a private-public partnership that has truly worked. Don credits Charlie Mitchell, who manages the city's urban renewal funds, and Brian Latta, Dallas' City Manager, for their positive assistance. "Charlie and Brian are very long-term thinkers," explains Don. "They believed in the importance of the downtown revitalization as much as we did and helped us apply for partial urban renewal grants that made the projects more economically feasible. They also continue to help with the myriad of practical considerations such as providing adequate parking for customers visiting the ten new local businesses.

Don and Debbie's projects have served as a catalyst for further downtown Dallas revitalization. Currently six other downtown commercial property owners have begun building facelifts partially funded through urban renewal grants. To use a term popular in the media these days, you could say Dallas is having a moment. "There's a lot of home building happening in town and it makes sense," says Don. "We're just a short commute to Salem and you can't beat the quality of life in Dallas. Revitalizing downtown just makes the community even more appealing.

Each day about twenty skilled tradespeople can be seen working on the buildings. Complete Home Maintenance is the main contractor, while locally-owned Priority Plumbing, Home Comfort and DC Electric are also heavily involved.

In Don's words, "this project never would have succeeded without Jennifer Hand," the local commercial leasing manager who worked with the ten businesses housed by the revitalized buildings. "It's a great mix and they're all A-rated tenants," points out Don. Some of the businesses are already in operation. Two Wolves Tap Room is pouring Oregon microbrews and serving food to a rapidly growing customer base. Technical Genius, a computer service store that employs five, is busy on a daily basis. Well Within, a popular juice bar, has already surpassed initial sales goals. Hundreds Acres Academy, a private school, is initially occupying the old Dallas Post Office on Main. Eventually academic classes will be taught in the 5300 square foot Carnegie Library that Don and Debbie are remodeling, while the academy's foundation will be housed in the revitalized post office. Also among the new tenants who have leased commercial space are a marketing company and a floral shop.

Suffice it to say that such an extensive commercial development project takes considerable funding, but Don and Debbie knew that they would have the support of their longtime bankers. "Oregon Coast Bank has provided funding for us on dozens of occasions," explained Don. "They believe in small towns, they're not afraid to fund unique projects and they've always provided rapid hands-on service. I made one phone call to Jill Meengs, Oregon Coast Bank's Senior Vice President, and explained how complicated remodeling five historic buildings would be. The next day, Jill was here in Dallas along with Lance Nunn, Oregon Coast Bank's President. They got real creative and by the time we sat down for lunch they had figured out how to fund the entire project. It never would have gotten off the ground without their support."

ide be allowed to incorporate. This guaranteed tax increase won't include the costs of additional bonds issued which will certainly be required to cover big-ticket expenditures. The bonds will be needed to cover items including the \$20 million Maxwell Mountain storm water drainage project, capital improvements for roads, accounting and auditing fees, IT support, and law enforcement services to name a few. The petitioners have a short-sighted and unrealistic budget and despite having heard the concerns of those outside of the Village they

have provided little clarity as to how these major expendi-

tures will be paid. Taking a part-time vacation community and forming a city to address locally isolated, community concerns is not a smart and fiscally sound long-term resolution. This is one of the many reasons why the vast majority of Oceanside property owners are opposed to this measure., Likewise, those in the Village who have studied both sides of the issue agree that incorporating Oceanside is not the answer. Voting No on the measure in November is the best means of securing Oceanside's future.

wo candidates for the L upcoming Rockaway Beach elections are putting together a series of listening sessions for residents who have questions or ideas about the city's programs and leadership.

Based on a well-attended series of these events in nearby Wheeler, city council candidate Cindy Kay Gregory and mayoral candidate Charles McNeilly have scheduled three of these listening sessions for Rockaway residents in September and October. I recently spoke with Cindy about the purpose and plans for these sessions.

"One of our observations is that people feel that they are not heard," Cindy said in response. "Some feel their input isn't heard or just doesn't matter."

To address this, Gregory and McNeilly plan to hold the first listening session on Wednesday, September 28, in the Neah-Kah-Nie School District administration building, 504 N. Third, from 6 - 8 PM.

The second session is currently scheduled for October 15 at 10 AM at the eagerly awaited Rockaway Roastery, 165 S. Miller, which intends to be open by then. "We might be their soft opening," Cindy said with a laugh.

A third session is being planned for the later part of October, to be held over Zoom. The time, date, and viewing links will be announced when



the details are settled.

It's important to note that this is not a candidates' forum. "Let's hear what you have to say," Cindy stressed. "We just kind of planned on that as our campaign." The intention is to invite all Rockaway Beach residents to come and share their experiences with city government, or what is important

I asked Cindy about the expected results of these listening sessions.

"If we are elected," she answered, "we will find ways to continue community conversations, town halls, or special meetings. We would like to reinstate a physical newsletter-not everybody's on social media. We're inviting participation in the processes.

The goal is to make citizen involvement a good experience, so that residents know they're communicating their views and wishes to someone who will

And that sense of accountability to citizens is part of the

long-term plan, starting with these listening sessions but extending into ongoing city government. Cindy explained:

"One of the other things we want to do is that when someone speaks at a city council meeting, we plan to have someone right then be assigned to follow up and let that person know, that everybody has a contact on city council. That's just something I'd really like to see instituted.

"We're going to be looking at and hearing what people want us to pay attention to."

As for the results of these listening sessions and their effect on plans and programs, Cindy went on.

"We will be organizing those into more of a platform, so that our platform is derived from what we've heard. We will be representing all voices in Rockaway. It's non-partisan, and that's how it should be. We should be working together to create the best possible situations."

Most important, all residents are welcome to attend, to share their concerns, and to learn what other issues affect residents here.

"I just want to make it clear that all Rockaway citizens are invited, even if they can't vote." Cindy said. "We'd like to hear the community issues." She stressed once again, "This is a non-partisan listening ses-







## How to cultivate resilience & grit in children and young adults

As we step into a new school year, we may find ourselves feeling stressed or overwhelmed in the transition back into fall routines. We thought this might make for a good time to re-share a blog written last year by Karen Sheelar, a Behavioral Health Clinician at the Tillamook County Community Health Center, who offered some valuable and relevant guidance for any community members who are interacting with kids and adolescents.

Families, teachers, friends, and neighbors all contribute and reinforce positive traits in young people in our community. Here are some handy tips to consider when supporting young people during any difficult or stressful period of their

#### **Key Concepts:**

Grit is the sustained drive that maintains commitment despite obstacles and time. Think about determination, perseverance, and believing in oneself. Good character references include Moana, Frodo, and any movie starring Clint Eastwood. Resilience is the ability and

gumption to recover from difficult set-backs. Think bouncing back, getting back on a horse, and pulling up your bootstraps. Good character references include Justin Beiber, Venus and Serena Williams, and Forrest Gump.

The following are a few ideas on how to cultivate these traits in young people; especially during large transitions and stressful situations.

#### Harvest a growth mindset

How we speak about our goals, failures, and victories not only shapes our reality, it lays foundations for them too. Steering these conversations can be difficult but these tips can help you prepare to plant seeds of resilience.

- Normalize failure. It is a valuable part of the process and makes room for reality and humility. It can be helpful to throw in stories of your own experience with obstacles and how you recovered.
- Value progress over product. Perfectionism in a final result can overlook the importance of experiential learning. This process is where children learn essential skills

like creation, communication, and resource utilization.

- Focus on language. Try to avoid blame, shame, and indifference with your children's setbacks. Approach these opportunities to discuss what we can learn from what happened.
- Harness curiosity. One of the strongest and purest things young people have is an unrelenting thirst for knowledge and understanding. It's a motivating emotion which maintains momentum despite adversity.

#### Introduce problem solving skills

In order to teach children to overcome obstacles we must slow down and communicate how and why we make decisions as adults. Children do not have the same insight or tools that you and other adults have accumulated over your well seasoned problem solving

- Narrate your thought process aloud to demonstrate your strategies. Not only does this explain your rationale, it also gives you an opportunity to ask for their feedback and foster a climate of trust.
- Identify the problem and how you feel about it. This helps young minds learn the

differences between objective and subjective experiences.

- Brainstorm possible solutions; pick the top three to seriously consider. There is more than one way to break an egg- so help promote a young person's analytical and creative side by considering a variety of options.
- Discuss consequences. This means investigating both pros and cons equally. It may take some extra time but it pays off later in life when the stakes get higher.
- Test drive possible solutions and debrief how things went. Young people are scientists and like learning through experimentation. When it's appropriate, consider ways to provide hands-on opportunities to learn.
- Create a safe place where asking questions is encouraged There are no stupid questions, only embarassed kids. Often folks opt to save face over truly understanding what is being asked of them. Empower young people to ask questions instead of being left in the dark. Let them know you value their curiosity.

Practice optimism Maturing brains are develop-

ing insight into how full or empty their glass is by listening to the people around them. It is understandable to become discouraged when things are unpredictable and unfair, as life regularly is. In order to forge a steady sense of stability we

## Enough is Enough: Bad Behavior by Coaches, Parents and Fans Must Stop

We've all seen it: the yelling, harassing, berating, disrespecting and even physically assaulting high school referees, umpires and other officials during and after games. And oftentimes, the harassment continues on social media. Perhaps you've witnessed it firsthand or even been one of those offenders

Not only is this behavior unacceptable and embarrassing, but it's also having serious consequences on the future of high school sports.

That's because another unfortunate trend is sweeping the nation: a critical shortage of high school officials in every state. The #1 reason? You guessed it: Coaches, parents and fans mistreating officials.


