AFFIDAVIT SUPPORTING COMPLAINT

COMES NOW THE UNDERSIGNED BEING OF LAWFUL AGE, AND BEING DULY SWORN UPON HIS OATH DEPOSES AND SAYS:

Your affiant is employed as a peace officer in Natrona County and acted in that official capacity at all times,

INITIAL INFORMATION:

On June 11, 2015 at approximately 3:37 a.m. Officers ALBRECHT and COLE responded to 1207 E. 2nd Street, Casper, Wyoming, Wyoming Medical Center (WMC) MRI, in response to a report of a fire assist. Officers were advised that a fire alarm had been pulled at point 5 signaling a code red which alarms the building occupants that there is a fire inside the facility.

INVESTIGATION:

On arrival Ofc. ALBRECHT was informed by WMC staff that there was no fire located inside the facility. Security staff subsequently informed Officers that video surveillance of the hallway where the fire alarm was pulled showed a white female with dark long hair wearing a red shirt, black skirt and white and pink tennis shoes pulling the alarm prior to leaving WMC. Officers were further advised that the same female was observed crossing 2nd Street and walking toward the dentist office near Conwell Park.

Officers ALBRECHT and COLE searched the area around Conwell Park, and Ofc. COLE located the described female inside a red 1999 Dodge truck (WY REG _____) registered to Tim MILLER parked in the alley driveway of _____ S. Washington. Officers made contact with the female who was clutching gold glasses, a toy sheriff badge, a reflector, and a small piece of metal. The female stated that her name was Felicia MILLER, and that she was allowed to use the truck. Officers later made contact with the truck owner Tim MILLER, who stated that he did not know the female and that she was not allowed her to use or get into his truck. The female true identity was later discovered to be Alisha ELROD.

Ofc. ALBRECHT asked ELROD why she had pulled the fire alarm at WMC, and ELROD explained that she thought the light on the fire alarm would signal her sister who she was looking for and bring her coffee. ELROD denied using any drugs, and stated that she was _____ and felt like her _____. Ofc. ALBRECHT observed that ELROD was unable to control her movements, as her entire body would twist and jerk uncontrollably. Ofc. ALBRECHT further observed that ELROD would grind her teeth and that her speech was rapid and disorganized as not much of what ELROD said made sense. Ofc. ALBRECHT further observed that ELROD appeared to be foaming from the mouth as she had white film around her lips and mouth. Ofc. ALBRECHT observed that ELROD had needle track marks on both of her arms (which is common for intravenous drug users) ELROD explained to Officers that she felt like she was going to pass out if she did not receive medical attention, and Ofc. ALBRECHT asked ELROD to sit down while they waited for medical personnel. ELROD sat down in the grass, and stated thank you Batman as she pull up grass and rubbed it on her hands and arms.

When medical personnel arrived ELROD was informed that her _____ needed to be checked, and ELROD attempted to pull away and fight medical personnel by attempting to kick at them. Ofc. ALBRECHT and medical personnel held ELROD down as her _____ was checked. Ofc. ALBRECHT was informed that ELROD's blood sugar was within normal ranges, and Ofc. ALBRECHT placed ELROD in handcuffs as she continued to struggle with Ofc. ALBRECHT and medical personnel. ELROD then stated that she had used a lot of meth, and that she drank a can of coke while in the truck that probably had meth in it. Due to ELROD's physical and mental state, Ofc. ALBRECHT informed ELROD that she would have to be examined at the hospital, which ELROD agreed to. As Officers escorted ELROD to Ofc. ALBRECHT's patrol vehicle ELROD began to push back against Officers and stated that she would not get into a police car. Ofc. ALBRECHT informed ELROD that she was under arrest and that she had to ride in a police car due to her combative state. ELROD continued to push back against Officers, and as Officers attempted to put ELROD into the prisoner cage of Ofc. ALBRECHT's patrol vehicle, ELROD used her legs to kick and brace against the door and door frame of Ofc. ALBRECHT's prisoner cage. Officers removed ELROD's legs from the door and door frame and again attempted to place ELROD inside the prisoner cage; however, ELROD kicked her legs out and climbed up the door frame and onto the roof of Ofc. ALBRECHT's patrol vehicle (with only her legs) as Officers held onto ELROD's arms and shoulders. Officers pulled ELROD off of the patrol vehicle, and were able to push ELROD into the prisoner cage. Ofc. ALBRECHT transported ELROD to WMC for a medical clearance. After being treated at WMC for drug use ELROD was taken to the Natrona County Detention Center.

PUBLIC RECORDS DISCLAIMER: This document is provided pursuant to Wyoming Public Records Act W.S. § 16-4-201, et seq. These charges are only indicative of how the defendant was booked in to the Natrona County Detention Center. The defendant may be formally charged by the Natrona County District Attorney's Office. All defendants are presumed innocent until they are found guilty following the formal filing of charges and trial.

Ofc. ALBRECHT spoke with Tim MILLER, who stated that his vehicle appeared to have been damaged by ELROD, as none of the entire damage existed prior to ELROD being inside the vehicle. MILLER further stated that he was not sure if the items that ELROD was clutching at the time of her arrest were from his vehicle. The following damage was caused by ELROD while she was inside the vehicle.

- Ripped out visor mirror from visor.
- Ripped off and broken rear view mirror.
- Ripped out and broke sun glasses holder.
- Ripped out ash tray holder.

Officers further found that ELROD had searched the vehicle, as property was scattered throughout the truck. MILLER informed Officers that the truck was left unlocked, and that the vehicle did not currently run. Officer KOCH and RODEN photographed and processed the vehicle. Ofc. COLE obtained a medical release form from ELROD for her medical records.

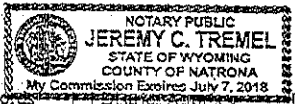
