We have agreed to move the football game between Clemson and Wyoming scheduled for September 18, 2021 to September 25, 2021.



**ATLANTIC COAST CONFERENCE
NON-CONFERENCE FOOTBALL CONTRACT**

THIS AGREEMENT entered into this 11th day of July, 2013 by Clemson University hereinafter designated as the HOME TEAM and the University of Wyoming hereinafter designated as the VISITING TEAM.

WITNESSETH that:


1. The said parties mutually agree to cause their respective (varsity) teams to meet in the city of CLEMSON, SOUTH CAROLINA on September 18, 2021 and there and then engage in the game of Football. Game time will be decided by the HOME TEAM, but shall be no earlier than 12:00 p.m. local time and no later than 8:00 p.m. local time unless mutually agreed.
2. The eligibility of all players in said game shall be determined by the rules and regulations of the NCAA and his institution as well as the rules of the athletic conference of which his institution is a member, if such affiliation is held.
3. The HOME TEAM agrees to pay to the VISITING TEAM the minimum sum of \$1,100,000 as a guarantee for playing said game not later than February 15, 2022.
4. The VISITING TEAM shall be allowed 300 complimentary tickets.
5. The VISITING TEAM shall be allowed 50 sideline passes.
6. The bands and cheerleaders of each team shall be admitted in uniform and shall not be included in Items 4 or 5.
7. Ticket prices shall be set by the HOME TEAM.
8. Television: The parties acknowledge and agree that all television rights for games played pursuant to this agreement are subject in all respects to television agreements entered into by the Atlantic Coast Conference on behalf of their membership.
9. The radio broadcast of the game shall be under the control of the HOME TEAM. The rights of each team are as follows: The HOME TEAM shall retain the revenue from and full control of radio rights, but with the understanding that the VISITING TEAM shall have one outlet free-of-charge and the revenue derived therefrom.


10. Game Officials: ACC
11. The HOME TEAM is to have the program and concession rights and all other forms of game revenue.
12. Either party failing to comply with the conditions of Item 1, either by cancellation or failure to appear, shall forfeit:
 - a. Money in the amount of \$0 if such cancellation shall be by mutual consent in which case this agreement shall be null and void.
 - b. Money in the amount of \$1,100,000 if such cancellation is made without mutual consent of both parties.
13. Payment of the applicable fee described in Item 12 shall be made no later than 30 days following the scheduled game.
14. This Agreement shall be governed and construed in accordance with the laws of the State of South Carolina. Any action brought by any party to this Agreement shall be brought and maintained in a court of competent jurisdiction in South Carolina.
15. The VISITING TEAM will have the option of purchasing up to 1,000 tickets. All unsold tickets should be returned to the HOME TEAM by September 6, 2021.


