The Violations alleged are:

Conflict of Interest in Public Contracts (GC 1090)

As a result of a Public Records Act I obtained the attached documents regarding Ms. Nancy Young, an elected City Council member in the City of Tracy, and her activities associated with attempting to obtain a permit to sell fireworks in the City of Tracy during the 2018 July 4 fireworks season on behalf of three Non Profit organizations which she is affiliated with, and receives personal financial benefits.

#### Background:

For the past several years the City of Tracy has held a lottery to allow nonprofit organizations to sell safe and sane fireworks. Ten firework stand permits are issued and the nonprofit organizations staff and sell fireworks in order to raise funds for their organizations. Substantial monies are raised, well in excess of 100 thousand dollars. The City of Tracy has adopted an ordinance for the fireworks lottery and the Tracy Fire Department is tasked with overseeing the process by which the lottery is conducted and the fireworks stands are operated.

City Councilwoman Young operates "One Living on Purpose", a Non Profit, along with her husband, Benjamin James Young. Ms. Young is listed as the Chief Executive Officer and her husband is listed as the Chief Financial Officer.

Councilwomen Young is associated with the Tracy African American Association, a Non Profit, and is listed as the Chief Financial Officer and Agent for Service.

City Councilwoman Young and her husband operate "His Image Praise and Worship", a Non Profit. Mr. Young is Chief Executive Officer and Councilwoman Young is listed as the Chief Financial Officer.

City Council Member Young applied, or participated in, the application process for three of the ten available fireworks stand permits on behalf of the Tracy African American Association, His Image Ministries and One Living on Purposes. All three organizations

were suspended by the Franchise Tax Board and/or the Secretary of State at the time of the applications.

Ms. Amy Rae, the Fire Marshall, was tasked with vetting the 70 or so, applications for fireworks stand permits and discovered the suspensions during that process.

Councilwoman Young was advised her applications would be rejected because her non profits were suspended and therefore could not legally participate in the lottery, or perform any activities until they were in good standing.

A series of Emails and telephone conversations followed between Ms. Young, Ms. Rae, Fire Chief Bramell and the City Attorney, Mr. Watson. It should be noted that Ms. Young's Emails contained the tag line, "A Proven and Effective Voice for Tracy City Council!"

Councilwoman Young visited the Fire Administration Building and personally spoke with Ms. Rae, the Fire Marshall, to have her non profits included in the lottery the day before the deadline for applications. Ms. Rae wrote an E-mail regarding her conversation with Councilwoman Young which is attached. In that E-mail, Ms. Rae stated, "I will preface my dictation with the fact that I was very uncomfortable with the conversation, as I felt that Ms. Young should not have been advocating for applicants in her current position. Her inquires and the context of the conversations and phone calls made me and my staff uncomfortable. One of my staff made the comment that she hoped her job wasn't going to be affected because of Ms. Young and her inquires, because one of the groups she was asking about was being denied for the lottery. My staff should not have been placed in that position. Honestly, I am a little uncomfortable with this request." The City of Tracy held the lottery and the Ten permits were allotted. One Living on Purpose, Councilwoman Young's non profit was allowed to participate in the lottery and was listed as an alternate according to the records I obtained from the City Clerk. Ultimately, her organization was awarded a fireworks stand permit and financially benefited.

On June 21, 2018 at 441 PM an email from Admin@taaa.net was sent out. It states in part, "Remember that Treasurer, Dr. Nancy Young's non-profit, One Living on Purpose was awarded one of the fireworks stands for this year. Nancy has invited TAAA to partner with her and share in this fund raiser. The dates are June 28-July 4. This is a lot of work but it can significantly impact our ability to fund scholarships. It is just 8 days of hard work and we could end up with as much as \$5,000 or \$6,000. But we can not do this without you."

Councilwoman Young's form 700, (copy attached) lists One Living on Purpose and His Image and Worship Ministries as assets/income. She indicated she was the CEO/Owner of One Living On Purpose and Co-Founder Pastor of His Image and Worship Ministries. Upon learning about this situation I spoke with the City Attorney, sent an e-mail and made a complaint directly to the City Council during a City Council Meeting. I subsequently made a written complaint to the City Attorney regarding Ms. Young and City Councilwoman Ranson. To date, my complaint has not been investigated or resolved. I received the attached E-mail from Thomas Watson, the City Attorney indicating his office does not have the authority to investigate City Council Members and such requests would not be accepted from a member of the public.

There appears to be a violation of the City of Tracy's municipal code regarding the issuance of a fireworks stand permit to Ms. Young's nonprofit. There also appears to be a

violation of 1090 of the government code. Additionally, the Tracy African American Association, a suspended entity, conducted business on behalf of Ms. Young's nonprofit, and financially benefitted from those activities.

I have attempted to have the City of Tracy resolve, or at least investigate this matter. The City Attorney was directed by a vote of the City Council to file an FPPC complaint but has not. I believe this matter seriously erodes the public's confidence, it obviously concerned the affected fire department staff and it should be noted the fire departments union was engaged in contract negotiations during the time of this incident. discussed this process with Chief Bramell. Ms. Young and I discussed the application and its references to the ordinance; she was concerned that the layperson could not be expected to know to reference the ordinance for the application. I assured her that we had numerous applications that were complete when they were submitted, so there was the availability for the applicants to have completed packets when they submitted them. I also expressed that it was the responsibility of TNT and Phantom to assist their applicants with the process.

One of her concerns was

the denial of one of her affiliated organizations, which had their exempt status 501© suspended with the IRS. According to her she had sent in paperwork to try to rectify the suspension. She felt that her submitting her documents should suffice for clearance of their suspended status. I told her that the paperwork, had to be reviewed and approved prior to being cleared, just sending in the paperwork did not guarantee clearance. She stated that she felt people should have been given more notice to fix what was missing from their

applications., I let her know that the applications were required to be complete at the time of submittal and we had spent many hours of staff time verifying information so that we could have accurate documentation for our denials/approvals. She mentioned what had occurred in the past several times and how she pushed for changes in the ordinance in years past. Het her know that I was not familiar with what happened in previous years, as I was not here, and neither was my staff. I told her my direction to my staff was to follow the City ordinance to ensure consistency and fairness for all applicants.

Today I received emails from SOS verifying filing for One Living on Purpose and Tracy African American Association (attached), but both are still showing in the system as suspended. Their is nothing else to do but wait for them to process and clear in the system.

I've spoken with Tom Watson regarding the application versus the ordinance. He has not seen an application. Officially, as a council member I've been bombarded with concerns and unfairness by numerous organizations who've complied with the application, but a different set of guidelines are being applied based on the ordinance.

As a council member, I am concerned as I said before about the time frame given for organizations to correct especially when any boards are changing and a previous treasurer, etc may have not kept all things in order. 

Today I received emails from SOS verifying filing for One Living on Purpose and Tracy African American Association (attached), but both are still showing in the system as suspended. Their is nothing else to do but wait for them to process and clear in the system.

I've spoken with Tom Watson regarding the application versus the ordinance. He has not seen an application. Officially, as a council member I've been bombarded with concerns and unfairness by numerous organizations who've complied with the application, but a different set of guidelines are being applied based on the ordinance.

As a council member, I am concerned as I said before about the time frame given for organizations to correct especially when any boards are changing and a previous treasurer, etc may have not kept all things in order. Another major concern are organizations, especially in our schools that are impacted because the application requirement of a 501(c)3 letter was submitted along with letters from their principals, but are being denied because of not having a state exemption or state corporation which is not required. On that note, our ordinance needs to be revised and I will request that officially at our next meeting.

However, with the lottery being tomorrow, in all fairness, we've set a precedent with past applications and acceptances; plus our application should be all inclusive for the everyday citizen. As long as the non profit is a school or church which both by definition is considered a non-profit apply...they are technically not in need of a state or federal letter to qualify. If they are a real entity benefiting our community, they should be allowed to be in the lottery to raise money to continue to fill in where our government can't and won't.

Given the short notices for other organizations to fix deficiencies, we should give them consideration to be in the lottery, especially if they've made an effort to correct. They again, are doing excellent work for free for many of our citizens and should have this opportunity.

There is a verification process even after the lottery and if in fact the needed paperwork based on our application - if not in good standing by then, and if they are chosen, will automatically default to the alternates.
