My name is Dave Roy. I am a Board Member of the Quail Creek Republican Club. I served as a poll observer on November 3, 2020 at the Lutheran Church in Green Valley, AZ. After reading in the Arizona Star on Friday, November 27, 2020 about the continued investigation of the polling process in Arizona I felt it was important to convey to you my thoughts and experience. On Friday, October 30, 2020 I attended a training session at the Pima County Republican office in Tucson. The bottom line on that session was pretty simple. **Do not talk and do not touch anything. If something looks irregular call the supervisor.** I was certified. When I reported to my poll assignment I was told the same thing and was escorted to a far corner of the polling area by the manager and was told to stay seated and call if any issues were noted. My proximity to any voting machine was probably 25 feet from which I could not observe any close up voter activity. During my shift no abnormal voter activity was noticed, but there is no way any issues could be observed from that distance. I think this is important for you to know.
