I, Detective Shane Barrett, being first duly sworn upon my oath, depose and say:

1. I am a Detective with the Tucson Police Department. I have been employed by TPD since April 1998. During my tenure with the Tucson Police Department, I have been assigned to various units including but not limited to: Patrol, DUI, Neighborhood Crimes and

Traffic Investigations. I am currently assigned to the Special Investigations Division - Organized Crime Unit - Asset Forfeitures.

- 2. My primary duties include the investigation of Racketeering offenses investigated by the Tucson Police Department for the purpose of performing Asset Forfeiture analysis and then the seizure of assets obtained through illegal means as defined under A.R.S. 13-2301. My duties include the investigation of the sources of property and/or cash, use of the property to facilitate a Racketeering offense, and whether or not the property and/or cash were the proceeds of a Racketeering offense or were purchased with the proceeds from a Racketeering offense. Your affiant is also responsible for the management of the property, sale and/or use of the property during the Asset Forfeiture process.
- Arizona Law Enforcement Training Center. During the academy, I received training in criminal investigations. During my nearly 17-years with the department, I have attended numerous trainings and schools in the following areas: Detective/Investigator School, Interview and Interrogation, Crime Scene Investigation and Management, Forensics, Drug Symptomology, Search and Seizure, Homicide Investigations, Traffic Investigations, Drug Recognition and Narcotic Identification training. Training received specifically related to my current assignment includes Financial Investigative Techniques, Money Laundering and Asset Forfeiture Training. I also attend quarterly training updates specific to Asset Forfeiture to keep abreast of current local and national Asset Forfeiture related investigative techniques, trends and court related decisions.
 - 4. Based upon my training and experience, your affiant has developed the requisite

5. I am familiar with the following facts which I believe show the indicated property is subject to forfeiture based on my review of the reports of the investigating officers.

FACTS:

- 6. On November 29th, 2011, the Tucson Police Department began receiving complaints regarding the operation of an illegal massage business known as "BY SPANISH" to include prostitution related activity and operating without proper licensing. The Tucson Police Department began a long term investigation on the organization and identified CLARISSA LOPEZ and ULISES RUIZ as the operators of the business and has several employees operating the business under their supervision/guidance.
- 7. Information regarding the location of the business, the operation of the business, the main operator of the business and its employees was obtained during the investigation through anonymous tips, formal complaints, two confidential informants (one a former employee and the other a client), an undercover Officer and surveillance operations.
- 8. BY SPANISH is advertised on Tucson Backpage.com under the therapeutic massage section. Neither the business, BY SPANISH, nor its operators, CLARISSA LOPEZ or ULISES RUIZ, have the proper licensing required by city ordinances and state statutes.

- 9. Detectives identified a total of fifteen (15) female employees, including CLARISSA LOPEZ and ULISES RUIZ, working under the business name of BY SPANISH. An average of six to seven (6-7) female employees work per day with an average of three to four (3-4) clients per day out of four (4) locations. BY SPANISH provides services every day of the week including holidays such as Christmas.
- 10. The investigation revealed services such as "happy endings," oral sex and sexual intercourse were readily available for a price. A "happy ending" is a common term used within the illegal massage/prostitution industry to describe the manual stimulation of the male client's penis until he reaches orgasm. These services are advertised as the "VIP Treatment" by BY SPANISH. During the "VIP Treatment" massage, the female employee is fully nude.
- 11. The same two phone numbers are listed on all of the Backpage.com ads for the female employees working for BY SPANISH and contact is usually made via text messaging. The phone numbers listed for BY SPANISH are answered by CLARISSA LOPEZ. The common price for a "VIP Treatment" massage is \$160 plus a \$40 tip for a total of \$200. A 1-hour "VIP Treatment" massage routinely consists of a 45-minute massage and then a "flip." Once the client is flipped from lying on their stomach to lying on their back, the sexual act is performed. After the sexual act has been completed, the client is allowed to shower prior to leaving the business.
- 12. CLARISSA LOPEZ and ULISES RUIZ receives a "cut" of the proceeds earned by each employee for each service provided in exchange for providing the female employees with advertisement services, scheduling services, a location to work out of, supplies to perform

- 18. The residence located at 1201 S Palo Verde Rd, Tucson, Arizona is the residence of CLARISSA LOPEZ and ULISES RUIZ. The residence is heavily fortified with a wall and metal gate surrounding the property. There has been prior Law Enforcement contact with CLARISSA LOPEZ and ULISES RUIZ at this residence reference a Home Invasion Robbery where a large sum of US currency was taken.
- 19. Officers conducted trash collections from this location and located several items of evidence; mail/indicia, torn open cash deposit envelopes, and other items that connected the residence to the other locations associated with the operation of BY SPANISH.
- 20. Officers and detectives noted the residence appeared to have been remodeled on the interior and exterior, giving the residence an upgraded look/feel compared to the other residences in the neighborhood. The exterior of the residence was also outfitted with video surveillance equipment. The interior of the residence was furnished with large flat screen TV's, newer leather furniture, curio cabinet containing high-end liquor, bedroom sets, and other high end items. The kitchen was overflowing with appliances and excessive amounts of food products. The bedroom closets were packed full of new, unused and expensive clothing and shoes. The garage was full of Costco type bulk quantity items, such as laundry supplies, colognes and perfumes.
- 21. The monthly mortgage payment for the Palo Verde residence is \$1495 per month and the average combined utility bills are approximately \$450 per month.

22. CLARISSA LOPEZ was contacted when she drove her Dodge from away from the 1201 S. Palo Verde residence.  - 25. The monthly rental payment for the Calle La Malinche residence is \$875 per month and the average combined utility bills are approximately \$185 per month.

All items within the location appeared to be set up for the purpose of client comfort and to enhance their experience.
- 34. The monthly rental payment for the Stone Ave residence is \$1000 per month and the average combined utility bills are approximately \$200 per month.

- 41. The monthly rental payment for the Stone Ave residence is \$1025 per month and the average combined utility bills are approximately \$80 per month. Receipts show payments for equipment, sale price of \$7,000.00, and an up-front deposit of \$1025.00. The following items were located and collected from the Speedway business: indicia for ULISES RUIZ, Pre-paid Visa cards, massage table, (I3) towel warmer, (I4A-C) and go-go style boots.
- 42. The 2006 Dodge Charger, AZ#992XMB, VIN: 2B3KA43G66H236972 has been identified as being associated with CLARISSA LOPEZ and ULISES RUIZ. This vehicle has been identified as the primary means of transportation for CLARISSA LOPEZ. The vehicle is registered to CLARISSA LOPEZ. There is no lien on the vehicle. This vehicle has been observed driving to/from the locations associated with BY SPANISH. CLARISSA LOPEZ, ULISES RUIZ and other identified female employees have been observed driving this vehicle. Drivers/occupants of this vehicle have been observed delivering supplies to the locations and removing garbage from the locations. The following items were located within the Dodge: bulk quantities of hygiene supplies, paper towels, toilet paper, laundry supplies, massage lotion, snacks, water, box of new/unused key ring advertising tabs for massage services, several of the cash deposit envelopes, condoms, and (EC6) new/unused sheets and pillow cases.

As a Police Officer since 1998, based upon my training and experience, I believe the above listed facts are consistent with the facilitation of Prostitution, Participating in a Criminal Syndicate and Money Laundering. The above listed items were used for or the result of felonious activity for financial gain and are subject to forfeiture for the following reasons:
- 47. It is common for those involved in prostitution activity to hide their true business intent under the guise of legitimate massage therapy and to use Backpage.com as a means of advertising their services and availability.
 - 48. It is common that such business lack of proper city and state licensing to operate a

- 49. It is common for those persons who are involved in prostitution activity instead of legitimate massage therapy to be in non-compliance of city and state licensing statutes.
- 50. In this case the confidential informants admitted the inner workings and business structure of BY SPANISH along with the identification of multiple persons involved in the operation of the business.
- 51. The structure of the business is consistent with that of a prostitution enterprise where a partnership, association, or any group of individuals associated in fact although not a legal entity engaged in providing prostitution services.
- 52. Surveillance conducted at 2095 E Calle La Malinche, 1041 E Water St #1, 1041 E Water St #2 and 3900 N Stone Ave that showed behavior consistent with illegal massage and prostitution related activity such as; identified female employees entering the residence via a key ahead of scheduled appointments, large volume of males entering/exiting the location on a recurring basis.
- 53. The locations are consistent with that of a house of prostitution; any building, structure or place that is use for the purpose of prostitution or lewdness or where acts of prostitution occur.
- 54. Identification of additional locations associated with BY SPANISH such as 1201 S Palo Verde Rd, 4604 S 6th Ave (FishCom) and 5834 E Speedway Blvd (Apia Salon) were evidence related to illegal massage/prostitution and money laundering were located.
 - 55. Items found in the 1201 S Palo Verde residence such as massage tables, massage

The confidential informants and CLARISSA LOPEZ made admissions to the undercover officer regarding the operation of the business and the structure established between herself and her employees regarding her expectations and payment in exchange for providing advertisement services, scheduling services, a location to work, supplies to perform their work and clean-up services.
- 60. A business structure set-up consistent with the organization, design, perpetuation and/or control to operate and maintain the furthering of the aims of the enterprise to include providing financial support by paying utilities, rent, maintenance costs or advertising costs, supervising activities or work schedules.
- 61. The location of reviews of BY SPANISH on known internet based forums where male clients commonly and openly discuss prostitution activity.
