Hi Ms. Golden,

Thank you for your time. Before I go any further I would like to request anonymity in this correspondence-- I would not like my name getting back to Hope Christian Church regarding this conversation. Thank you.

The reason I have contacted you is that, over a dozen (and counting) former members of Hope Christian Church have come together to file a report regarding HCC with the University. We believe that, in a number of different ways, HCC is harmful to the ASU campus.

The report is getting quite lengthy, but I am trying to set a soft deadline of July 1st for submission to the Dean's Office, who has requested we send them the finished product. My questions are as follows:

- a) Would you permit us to also send you a copy of the finished report-- without it becoming available to HCC? (to protect the identity of the contributors)
- b) Hope's mother church, Faith Christian Church in Tucson received similar complaints at the University of Arizona, and the religious council there responded by providing literature to students at orientation regarding "red flags" for religious groups, and a list of various organizations (FCC and its affiliates) to be wary of. FCC's membership was also revoked. Would it be possible for you to consider similar action being taken regarding HCC, once you have had a chance to survey the concerns being put forward by ASU students?

Thus far, our report contributors have identified four categories of ASU code of conduct violation committed by HCC, a large handful of practices which create a negative environment for student life and/or exploit the University, seven ways in which they enact psychological/emotional abuse upon students, traced HCC's church lineage on the first, second, and third levels to organizations widely considered religious cults, and have identified roughly 40 indicators, as identified by psychological/sociological research, and Christian leaders which are indicative of religious cults, that are embodied by HCC.

Let me know what my next steps should be and if you are interested in further correspondence. Thank you again.

On August 13, 2013 at anomylmately 7:55p, Community Assistant Add approached by residents of the Early Start Program telling Fields about what they described as a "cult like group" here in Taylor Place and at ASU. The Early Start residents explained that on move in day they were approached by two men named Victor and Sean and were asked for their cell phone numbers. The residents were invited to play dodge ball the YMCA but said they denied the offer. The Early Start residents were invited to a BBQ put on the "comedy club" at Vista Del Sol. The residents clairned it was "rented out" by the club but it turned out to not be a BBQ and the members of the "club" described them as "creepy". The only reason the residents knew the BBQ was put on by the Outlaw Comedy Club because of their T-shirts. The residents explained that the members did not talk about the club at all but talked briefly about Hope Church. They claimed most of the members were already graduated except Jesse (possibly the female Jesse). As the residents tried leaving the event, the members of the club told them they had to leave their contact information which included their room number, phone number, and residential halt. The residents said they were "cornered" and felt "pressured" by the members and put down false information. The residents gave Hamby's number to Community Director Beard and were told that if they did not want to be contacted by the Cutlaw Comedy Club that they needed to inform the club to stop, and if they do not leave them alone to contact the security desk or ASU PD and let CD Beard

Returning to the desk, CA remembered that he had seen several people he recognized as members of Hope Christian Church earlier near the desk, and so CA and CA went to the Honors Hall front desk to collect more information.
	CA had previously (September 8, 2010) dealt with Non-Student Chad Lee Pentecost of Hope Christian Church on a previous occasion (JAMS #01931-2010) after he walked the floors of Agave without escort, inviting male residents to a bible study group and attempting to recruit members for his church. At that time, he had said Barrett Community Assistant (Agave) had given him permission to walk the halls.
	At the front desk, after learning the Hope Christian Church members had left, CA called CA to ask if he knew anything about the situation. CA reported that he knew Non-Student Pentecost had been in the building (and very probably was the mar reported by the resident) without escort, and that he had urged him to leave. CA asked CA to call Non-Student Pentecost to the front desk so they could get both sides of the story.
	Non-Student Pentecost arrived at the desk a short time later and said that he knew he was in the building without escort, but he had had a meeting with his "friend" Resident in Agave and was going to see him. After giving several contradictory reports, Non-Student Pentecost said that Resident wasn't there, and had he had "banged on the door for awhile." He denied speaking to other residents, and had no explanation for why a resident had called the front desk.
	Non-Student Pentecost did not seem to understand how his actions have repeatedly made residets feel unsafe. He continues to insist that he has "meetings" with "friends" who seem to not show up, and he does not seem to understand how this pattern of behavior can badly affect the community of the floor he continues to visit against policy (as a non-resident, he needs an escort). CA reminded him of these policies, and asked him to leave the complex for the afternoon.
