Greetings fellow Republicans,

I was just forwarded an e-mail last night that you all received from a person claiming to be John R. Dalton Jr. using the e-mail address 'editor@azdailyherald.com.'

There are three things I want to make very clear :

1. This person who claims to be John R. Dalton Jr. is not John R. Dalton Jr. I am the real John R. Dalton Jr. and to my knowledge, the only John R. Dalton Jr. in Tucson. I reside at 2550 East River Road #15102, Tucson, Arizona 85718. My phone number is [\(248\) 277-2278](tel:2482772278). I moved here to Tucson from Michigan in 2015 and have been somewhat active in AZ politics.

2. I have nothing, nor have ever had anything, to do with any part of the current scandal surrounding Supervisor Ally Miller and her staff member Timothy DesJarlais. It wasn't until my name was strangely mentioned by Supervisor Miller and I started receiving comments on my Facebook wall from her about an FBI investigation. I later learned through the news what was going on. Note: I do not know Supervisor Miller, but I did shake her hand a few months ago at a 4Tucson event.
