Dear Maricopa County Elections:

I am writing regarding the following issues:

1. Formal Demand my Provisional Ballot be counted
2. Lodge Formal Notice I am victim of Identity Theft
3. Concern with how my Provisional Ballot was processed

BACKGROUND:

I retired, due to health issues, and relocated to Scottsdale in the Summer of 2019. I previously resided in Tempe, Yuma, and Tucson (during College).

When I changed my address for purposes of voter registration, a letter was received from your office, while I was hospitalized. My son replied noting my address (2) TWO separate times.

For the record and for obvious reasons for the last 10 years I have always had a separate mailing address due to my service as a Judge and now retired, for security purposes. This is especially relevant now as I do not want my prior career to possibly bring danger

My son informs me he replied (2) TWO times to your office informing your office I have resided since June 2020, at . My mailing address (secure Box next door) :

Note: I am a retired Judge and have served the Salt River Pima Maricopa Indian Community and also served (appointed by the Governor) on the Arizona Commission of Indian Affairs.

EVENTS OF NOV. 2,2020:

On November 2, 2020, I had a medical appointment on Scottsdale Road, afterward I was advised there was a voting location down the road, thus I decided to avoid the lines and proceed to vote.

The Voting Location in question was: the Scottsdale Worship Center at 6508 E. Cactus Road, Scottsdale, Az 85254

Upon entering, a Poll Worker attempted to check me in by inputting my Arizona Driver's License.

To my surprise, when my Arizona Driver's License number was inputted by the Poll Worker, the number linked to another individual, I believe by the name "Murrillo", I may have this exact name incorrect as I did not write it down, but as I recall this also showed what appeared to be a Tolleson, Az address.

For the record I am NOT this person, have never used this name NOR have I ever resided in Tolleson.

It is clear my identification documents have been cloned, sold, or coopted. I am presently the victim of Identity Theft, the defendants having been caught outside Maricopa County and both are presently criminally charged, however this individual in Tolleson is not the name of those currently criminally charged.

The Poll Worker called for her Supervisor who attempted to address the issue and manually type in my information.

However when he did, upon using my Driver's License Number, your System defaulted to the fraudulent person using my Driver's License Number OR when the Supervisor used my address, it defaulted to a Goodyear Address. Please note, I have NEVER resided in Goodyear, Az.

In the end, the Supervisor issued a Provisional Ballot, but once at the Voting Booth, I noticed it had candidates outside of Scottsdale i.e. the Polling Supervisor gave me the ballot associated with the Goodyear address. I was able to vote for the major offices and Statewide Ballot Measures, which are indeed most important to me, but the incorrect ballot should be noted. It was issued by the Polling Supervisor despite my informing the Supervisor of its being incorrect.

As a result of learning my driver's license is being used illegally by the person in Tolleson, immediately after I left the Polling location, I filed a Fraud & Identity Theft Report with the Scottsdale Police Dept, Officer Sodeman

I have no idea how my driver's license came to be obtained and illegally used by the individual who has now been using it fraudulently, I did advise the Scottsdale Police to contact your office as when it is inputted in your system, it links to another person (not me) and to an address (never resided at by me).

CONCLUSION:

I am and have been duly domiciled in Scottsdale since the Summer of 2019 (upon my medical retirement)

I ask that all necessary steps be taken to correct this situation, that your office cooperate with the Scottsdale Police Dept as to the fraudulent use of my Driver's License number, and my vote be counted as I should NOT be prejudiced due to circumstances I am not liable for.

Notice by Affidavit

Comes now Affiant, one of the people (as seen in the Arizona Declaration of Rights Article 2 Section 2 Arizona Constitution) Sul Juris, in this court of record, do make the following claims:

I Voted in person Tuesday, November 3rd, 2020 at 107th Avenue and Camelback Road Phoenix, AZ Maricopa County.

Upon receipt of my ballot I witnessed another voter struggling with the poll worker to feed the ballot into the scanner. After multiple times of the ballot being spit back out the voter asked for another ballot but was denied. His ballot was fed one more time and spit back out by the voting machine then put in a mail looking slot in front of the bin that the voting scanner was sitting on.

I proceeded to vote with the provided sharpie marker and based on how messy it was moved to another booth but sharpie markers were the only option. My ballot had bleed through marks that made both sides unlegible. I proceeded to the voting machine and told the poll worker I was concerned it wouldn't be read due to the stray marks on both sides. He said it would read my ballot. I asked which direction to feed the ballot and the poll worker said any direction is fine. I fed it front side up/forward. Surprisingly the ballot did not come back out. I am concerned that ballots in the front slot did not get counted.

Any man or woman who denies these claims are true must rebut them under penalty of perjury in the form of a sworn affidavit. Any man or woman who decides to suppress this affidavit agrees to pay \$30,000 and any disputes by any public officials or private actors who are bound by contract to the Arizona Constitution agrees to have these matters heard before an Arbitrator of my choice. Any man or woman denying these claims are true must rebut these claims point by point within (3) days (72 hrs). Failure to respond means that by acquiescence you agree that all claims are true.

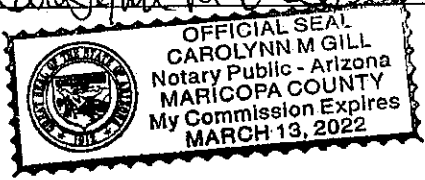

2020 AZVoteSafe Guide for Native Americans

Recommendations for Arizona Voters in Tribal Communities

Due to COVID-19, the Secretary of State's Office is encouraging all voters to request a ballot-by-mail to ensure they have a safe and reliable option for voting. Tribal members historically participate in voting on Election Day as a civic and community event, and many tribal members face challenges to voting by mail due to limited mail service and language assistance needs. However, because of current public health concerns, it's more important than ever to plan ahead and have back-up options available. Use the steps below as a quick reference guide to making your plan for voting in 2020 and ensuring your voice is heard in our democracy.

STEP 1 – REGISTER TO VOTE

- Register to vote by filling out a voter registration form, which you can download at Arizona.Vote or call your County Recorder to request a mailed form. If you have an AZ Driver's License or ID, you can register to vote online at www.servicearizona.com.
- If you're already registered, confirm your registration status at Arizona.Vote and update your address or other information if needed.
- The deadline to register to vote or update your voter registration is October 5, 2020.

STEP 2 – REQUEST A BALLOT-BY-MAIL

- Getting a ballot-by-mail should be part of every tribal member's voting plan. It is your choice how you ultimately decide to vote. Even if you prefer or plan to vote in-person, requesting a ballot-by-mail will ensure you have a safe and secure back-up option for voting this year – an option that doesn't require waiting in line to get a ballot or needing to vote at a potentially crowded polling place.
- If you have a mailing address or P.O. Box and are not already on the Permanent Early Voting List (PEVL), request a one-time ballot-by-mail for the 2020 General Election or join the PEVL as soon as possible so you have enough time to receive the ballot, get language or other assistance if needed, vote it, and return the ballot on time.
- Call your County Recorder or go to Arizona.Vote to request a ballot-by-mail. The deadline to request a ballot-by-mail or join the PEVL is October 23, 2020.

STEP 3 – VOTE AND SIGN YOUR BALLOT-BY-MAIL

- If you need language assistance when you get your ballot-by-mail, contact your County Recorder's Office or Elections Department (listed below) to learn about available resources. Certain community organizations may also have language assistance resources.
- After voting your ballot, put your ballot in the return envelope and make sure you sign the affidavit envelope. You should also provide a phone number in the appropriate space on the envelope so elections officials can contact you if there are any issues with your ballot.

KNOW YOUR OPTIONS — MAKE SURE YOU HAVE A VOTE PLAN

STEP 4 — RETURN YOUR BALLOT BY 7:00 P.M. ON ELECTION DAY

- If you voted a ballot-by-mail, your best option is to return your voted ballot to any voting location in your county on Election Day. You can also drop off your ballot at your County Recorder's office, any early voting location in your county, or any other designated drop-off location in your county. Contact your County Recorder or visit [Arizona.Vote](https://www.arizona.vote) to find all available drop-off locations.
- Ballots must be received by county election officials by 7:00 p.m. on Election Day to be counted.
- If you cannot drop off your ballot yourself for any reason, a family member, household member, caregiver, or election worker can help return your voted, sealed, and signed ballot for you.
- If you need to mail your voted ballot back, make sure you mail it early enough to arrive at the County Recorder's office by 7:00 p.m. on Election Day. The state's recommended last day to mail back a ballot is October 27, but if you live in a rural area with slower mail service, you should build in more time.

STEP 5 — VOTING IN-PERSON

- If you did not receive a ballot-by-mail or otherwise choose to vote in-person, we encourage you to vote early. To learn about in-person early voting options, contact your County Recorder's office.
- If you choose to vote in-person on Election Day, confirm your correct voting location by contacting your county elections department (see below) or visiting [Arizona.Vote](https://www.arizona.vote). Curbside voting may be available.
- Whether you're voting early or on Election Day, remember to bring valid identification to vote in-person. For information on valid identification, visit [Arizona.Vote](https://www.arizona.vote).
- In-person voters should take precautions to help protect themselves, other voters, and poll workers:
 - **Come prepared.** Review and mark a sample ballot so you can vote quickly and minimize the time you need to spend at the voting location.
 - **Wear a face covering.** If it can be safely managed, wear a cloth face covering when you go to vote to help protect yourself and those around you.
 - **Bring your own pen.** Bring your own pen to the voting location to minimize contact with surfaces others may have touched. Some voting locations may have single-use pens available, but bringing your own pen will help keep you safe and minimize waste.
 - **Maintain physical distancing.** Stay at least 6 feet away from other voters and poll workers whenever possible (except for caregivers and members of the same household).
 - **Wash your hands.** Wash your hands with soap and water (for at least 20 seconds) before and after voting. If facilities are not readily available, use hand sanitizer with at least 60% alcohol.
 - **Don't touch your face.** Avoid touching your eyes, nose, and mouth with unwashed hands.

PHOENIX – Ahead of National Voter Registration Day, the Secretary of State's Office is proud to announce an upgrade to ServiceArizona.com that allows voters to register or update their voter registration online even if their residence location does not have a standard address.

If a residence address cannot be found using traditional validation methods, the voter can enter a non-standard address, such as a description of residence location, Google Plus Code, or latitude and longitude as their residence address.

"This new option allows voters who may not have a traditional address the opportunity to register to vote and participate in the election process," Arizona Secretary of State Katie Hobbs said. "Many voters in rural and tribal communities do not have a standard address, and this allows them to register online. Our office is continually working to ensure a more inclusive process."

The Secretary of State's Office has also released a new voter information and safety guide developed specifically for indigenous communities ahead of the Nov. 3 General Election. The [AZVoteSafe Guide for Native American Voters \(https://azsos.gov/file/2121\)](https://azsos.gov/file/2121) is the latest guide developed as part of the office's [#AZVoteSafe Initiative \(https://azsos.gov/about-office/media-center/press-releases/1201\)](https://azsos.gov/about-office/media-center/press-releases/1201), aimed at helping voters in Arizona vote safely and securely in the 2020 elections.

"Native American communities have historically participated in voting in-person on Election Day as a civic and community event," said Hobbs. "Due to current public health concerns, it's now more important than ever to plan ahead and have back-up options for voting."

The guide provides step-by-step recommendations for Native American voters in tribal communities to ensure they can vote and that their vote is counted. The recommendations include:

- Registering to vote or updating registration information as early as possible, and by the October 5, 2020 deadline
- Joining the Permanent Early Voting List or making a one-time request for a ballot-by-mail as early as possible, and by the October 23, 2020 deadline
- Developing a plan for voting, whether it is through a ballot-by-mail, voting early in-person, or voting on Election Day
- Returning a ballot-by-mail as early as possible, and utilizing secure drop-off options where available
- Following safety precautions when voting in-person

October 5, 2020 is the last day to register to vote for the November 3, 2020 General Election. Eligible Arizonans who have an Arizona driver's license or state identification card are encouraged to register online at www.ServiceArizona.com (<http://www.ServiceArizona.com>). Those who cannot register online through ServiceArizona may call the Secretary of State's Office at 1-877-THE-VOTE to request a voter registration form or for further assistance.

Registered voters can join the Permanent Early Voting List or make a one-time request for a ballot-by-mail at [Arizona.Vote \(http://www.arizona.vote/\)](http://www.arizona.vote/).

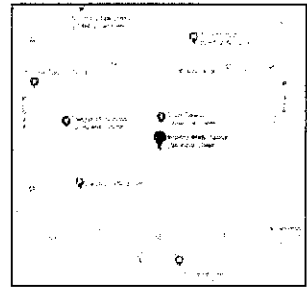
