

***Summarization of Cases from August 31, 2013 in which an immigration status check, as mandated by SB1070, was completed via a TPD TWX operator.***

1308310003 – Assault incident in which suspect was arrested for 1 count of misdemeanor assault. He was arrested/cited and released at the scene of the incident. Immigration check completed as a result of the arrest.

1308310009 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310057 – DUI investigation in which driver was arrested/cited for DUI offense(s) (misdemeanor(s)). Driver was arrested/cited, and a ride was arranged to pick him up. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310060 – DUI investigation in which driver was arrested/cited for DUI offense(s) (misdemeanor(s)). Driver was arrested/cited, and a ride was arranged to pick him up. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310127 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310140 – Investigation regarding a criminal damage and possible assault incident in which the suspect was ultimately arrested for 1 count of criminal damage, a misdemeanor offense. The suspect was arrested/cited and released at the scene of the incident. Immigration check completed as a result of the arrest.

1308310179 – DUI investigation in which driver was arrested/cited for DUI offense(s) (misdemeanor(s)). Driver was arrested/cited, and a ride was arranged to pick him up. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310225 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving without a driver's license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310233 – Shoplifting investigation and arrest in which the suspect was arrested for shoplifting, a misdemeanor offense. The suspect was arrested/cited and released after leaving the scene, but admitted to the offense. Immigration check completed as a result of the arrest.

1308310298 – DUI investigation in which driver was arrested/cited for DUI offense(s) (misdemeanor(s)). Driver was arrested/cited, and a ride was arranged to pick him up. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310312 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310320 – Shoplifting investigation and arrest in which the suspect was arrested for shoplifting, a misdemeanor offense. The suspect was arrested/cited and released at the scene and admitted to the offense. Immigration check completed as a result of the arrest.

1308310322 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310341 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310357 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310358 – Motor vehicle collision in which it was discovered that one of the drivers was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310387 – Investigation regarding a suspicious male in a parking lot. He was found to be in possession of marijuana and paraphernalia, both misdemeanor offenses. He also urinated in public, a misdemeanor offense. The suspect was arrested/cited and released at the scene. Immigration check completed as a result of the arrest.

1308310403 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310407 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the

scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310408 – Emergency mental health petition served on a patient, who was transported as a result of doctor's orders to a mental health facility. No arrest made. \*\*\*NOTE: The case report regarding this incident (TPD case #1308310408) made no mention of any immigration check being completed. Upon further investigation, it was determined that a couple of numbers were inadvertently transposed on the TWX immigration check paperwork. The correct case report should have read "1308310480." Under that case report, an officer conducted a traffic stop during which it was discovered that the driver had a suspended license. The driver was also in possession of marijuana and paraphernalia. He was arrested/cited for the misdemeanor violations and released at the scene. Immigration check completed as a result of the arrest. \*\*\*

1308310422 (x2) – Traffic stop for unknown traffic violation in which the driver and passenger were both discovered to be in possession of marijuana and paraphernalia, both misdemeanor offenses. Both were arrested/cited and released at the scene.

1308310449 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310451 – Investigation of a loud party in a City Park. Party organizer was civilly cited for violation of permit. \*\*\*NOTE: Through further investigation regarding the reason behind the immigration check, it was learned that the officer mistakenly initiated the check after issuing a civil citation. However, after consulting with his supervisor, he was reminded that the immigration check was not mandated by law for civil violations. No further action was taken.\*\*\*

1308310459 – DUI investigation in which driver was arrested/cited for DUI offense(s) (misdemeanor(s)). Driver was arrested/cited, and a ride was arranged to pick him up. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310460 – Male sitting in vehicle with open container of alcohol, a misdemeanor offense. He was cited/arrested and released at the scene. Immigration check completed as a result of the arrest.

1308310461 – Traffic violation regarding excessively loud music. The driver was found to be driving on a suspended license as well as in possession of marijuana and paraphernalia, all misdemeanor offenses. He was arrested/cited and released at the scene. Vehicle impounded as a result of mandatory impound law.

1308310491 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.

1308310503 – Traffic stop for a misdemeanor traffic violation of reckless driving. The driver was arrested/cited for the misdemeanor traffic violation and released at the scene. Immigration check completed as a result of the arrest.

1308310513 – Traffic stop for unknown traffic violation in which it was discovered that driver was driving on a suspended license, a misdemeanor offense. Driver was arrested/cited and released at the scene. Immigration check completed as a result of the arrest. Vehicle impounded as a result of mandatory impound law.
