# A BILL

To designate the station of the United States Border Patrol located at 2136 South Naco Highway in Bisbee, Arizona, as the “Brian A. Terry Border Patrol Station”.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Brian A. Terry Memo-  
5 rial Act”.

6 **SEC. 2. FINDINGS.**

7 The Congress finds the following:

1           (1) A native of Flat Rock, Michigan, Agent  
2 Brian A. Terry served his country proudly with the  
3 United States Marine Corps and continued his serv-  
4 ice as a police officer with the cities of Ecorse and  
5 Lincoln Park, Michigan, prior to joining the United  
6 States Border Patrol.

7           (2) Agent Terry was a member of the 699th  
8 Session of the Border Patrol Academy assigned to  
9 the Naco Border Patrol Station within the Tucson  
10 Sector.

11          (3) On December 14, 2010, Border Patrol  
12 Agent Brian A. Terry was conducting a Border Pa-  
13 trol Tactical unit (BORTAC) operation in the area  
14 of “Peck Wells”.

15          (4) At 11:15 p.m., near Rio Rico, Arizona, and  
16 about 15 miles north of Nogales, Arizona, Agent  
17 Terry and his team spotted a group of individuals  
18 approaching their position.

19          (5) Shortly thereafter, an encounter ensued and  
20 gunfire was exchanged that left Agent Terry mor-  
21 tally wounded.

22          (6) Agent Terry succumbed to his injuries on  
23 December 15, 2010.

1           (7) Agent Terry is survived by his mother, fa-  
2           ther, stepmother, stepfather, brother, and two sis-  
3           ters.

4 **SEC. 3. DESIGNATION.**

5           The station of the United States Border Patrol lo-  
6           cated at 2136 South Naco Highway in Bisbee, Arizona,  
7           shall be known and designated as the “Brian A. Terry  
8           Border Patrol Station”.

9 **SEC. 4. REFERENCES.**

10          Any reference in a law, map, regulation, document,  
11          paper, or other record of the United States to the station  
12          referred to in section 1 shall be deemed to be a reference  
13          to the “Brian A. Terry Border Patrol Station”.
