### **New Courses Developed**

The Social Power of Leadership for the 21st Century

The Modern University. Undergraduate course was developed in conjunction with the officers

of the Associated Students of the University of Utah. It included a core curriculum on the history, functions and role of modern universities and guest lectures from state and university leaders on their work, the challenges of the future, the role of the University of Utah in the state education community, and leadership in the university community.

<u>Design Studio for Educational Leadership</u>. Graduate course that changed the traditional Seminar in the Principalship and restructured it as a problem-based experience requiring students to directly apply knowledge obtained in their academic program to problem solving in schools. Expert coaches worked with students whose work was critiqued by a panel of experts.

Collaboration and Conflict Management in Education. Graduate/Undergraduate. This course was collaboratively developed using a cross-disciplinary model for studying and applying collaboration, conflict management, and problem solving. Faculty co-teach (not turn-teach) the course and model the principles of collaboration and conflict management. Problem solutions and action are a major focus of the course. Cross-listed with Educational Psychology, Special Education, and Educational Studies.
