But, the signature panel, when lightly touched auto-produced a massive illegible scribble. We rejected the signature, registered the voter again, same problem. Tried later another day had success with a reasonable signature.  
Reported this glitch via Twitter and email to Adrian Fontes and had no response.  
Here are the screen grabs if the voter signature glitch. Wondered how many online PEVL voter signatures are legible. Online, nobody acknowledged the problem posted a fix to social media or explanation for the problem.

I am a legal registered voter in Maricopa County, registered at NO PARTY. Early October I received my mail in ballot at my P O Box. I kept blank with me.

On October 27th, 2020 around noon, I voted in person with my husband at 2626 E Pecos Rd., Chandler AZ 85225, a voting office located in Chandler-Gilbert community College. The voting center verified my AZ id, and my personal information, I E-signed my signature, they printed out a ballot for me. I made my vote to Mr. Trump and voted some other selections, I sealed the envelope and dropped it in at the ballot collection box. On that day I had my early mail in ballot with me, it was blank, I told the vote center worker this and they took my blank ballot, I used their print out ballot to vote Mr. Trump. Lately I checked my vote status through Arizona state website, and found out that there were two early mail in ballots under my name, one is cancelled, the other showed it was sent to me on October 22nd, and was accepted on October 24th. These comments are my own and I am willing and able to prepare an affidavit certifying the following.

Answers to date fail to address my actual concern on what happened with some ballots on election day at the voting location I visited on 11/03/2020. (Arrowhead Mall, Glendale, 85308) I was 6th in line when doors opened at 6am.

I am a firsthand witness to in person ballots failing to be tabulated and immediately placed in the tub under the tabulator as if they were counted. These votes were tabulator rejected due to bleed through and placed in a slot under the front of the tabulator. The voters I witnessed (roughly 20-30 over 15 minutes) were not offered to spoil the ballot and re-vote as I personally asked to do. I was a volunteer poll worker previously and understand the terms and process. I refilled a new ballot in black ball point pen and it passed the tabulator first scan. I believe many voters were unaware of what was happening, and the poll workers were not well trained on this issue. I do not believe poll workers were in collusion or intentionally perpetrating fraud, but I believe these votes were rejected and left uncounted. The poll workers contacted their assistance line by phone, but at one point 2 or more poll workers had tabulator reject ballots in hand while the voters had left thinking they voted. I do not know the outcome of these voters ballots.

### concerns.

1. If a ballot is rejected, and placed in the same bin as tabulated ballots, how does that ballot ever get counted? I saw this happen repeatedly.
2. Why did I have to ask to spoil my ballot and revote. This was not offered to me or others. They allowed poll workers to place their rejected ballot into the same tub as counted ballots.
3. I retrieved my own personal ball point pen to vote. The poll workers had ball point pens but were only offering Sharpie Fine Point markers. After calling the assistance line, poll workers offered pens and the fine point sharpie brand markers.
4. Upon casting my ballot completed with black ball point pen, no issue. Most other voters I witnessed were not offered this opportunity to fix their ballot.
5. The ballot paper used at in-person voting centers was substantially thinner than standard ballot paper. Like comparing printer paper to card stock for mail in ballots. This paper bled through easily with Sharpie Marks. I had this problem, and my ballot was rejected. Everyone in front of me had been rejected, except 1 man who brought his own pen and was commenting that Sharpies were not to be used per the voter instructions. He was quite upset and said he would file a complaint.

Dear Senate President,

Thank you, so much, for setting up this email and being willing to HEAR the voices of your constituency regarding voting irregularities in this most recent election.

I had provided a declaration to Kory Langhofer in connection with the Trump v. Hobbs case (CV2020-014248), however, was never called to testify. I don't know if you have previously seen my declaration, so I have attached it; please note, this copy includes an edit I requested which they included in the final version.

In short, while my ballot was accepted without incident, within about 10-15 minutes I witnessed/heard 6 to 7 instances of other voters experiencing the over-vote issue which resulted in their ballot being cast via the poll worker pushing the green button. What I believe is of note to my observations at the polling site was that the poll worker was only giving the over-vote voters the option for a provisional ballot, which I believe is against the A.R.S. rules/procedures.

Additionally, if the frequency of the over-vote flag can be interpolated from my experience at the voting center, the degree of impact is quite sizable. If as many as 6 voters' ballots in a 10 minute period were flagged, during 11 hours, and across as many as 175 voting centers, then, the number of voters impacted could be in the tens of thousands (not the 190 votes claimed by state's attorneys yesterday). In other words, avg 36 per hour x 11 hours x 175 voting centers = 69,300 ballots potentially impacted! Surely, this warrants further evaluation.

Clearly, a full audit/hand count is in order to investigate the depth of this issue during this election. I am an Arizona native and have voted in Arizona for at least 40 years and have never before doubted its integrity. However, if this election travesty is not adequately addressed, I doubt I will ever be able to vote in Arizona – with confidence – again.

I, Nancy L. Wigton, make this Declaration consistent with 28 U.S.C. § 1746 and under penalty of perjury and state that all statements herein are true and accurate and that I have personal knowledge of all statements herein. My name is Nancy Lynn Wigton, I am of sound mind, capable of making this Affidavit, and have personal and direct knowledge of the facts herein stated and if called to testify I would provide the same testimony.

1. I am a citizen of the United States of America, the State of Arizona and of Maricopa County, Arizona.

2. I am a registered voter in Maricopa County, Arizona.

3. On November 3, 2020, I went to the voting center at 3930 E UNIVERSITY DR, MESA, AZ 85205 in Maricopa County, Arizona (the "Voting Center.").

4. After receiving my ballot, I proceeded to the area where voters were to make their selections on the ballot ("voting booth"). The voting booth consisted of an open table with dividers providing privacy for the voter to make selections on the voter's ballot.

5. My voting booth was approximately six feet from the ballot tabulator machine (the "Tabulator") where voters would insert their ballots after completing them inside the voting booth. Due to (1) the proximity of the voting booth to the Tabulator and (2) social distancing measures, the pollworker assisting voters at the Tabulator was within ~~several~~ a few feet of me while I completed my ballot at the voting booth. I could hear the conversations between the pollworker and voters clearly.

6. The Tabulator had two options: (1) a red button and a (2) green button labeled. The red button said "Return" and the green button said "Cast."

7. During the process of completing my ballot at the voting booth, I overheard approximately six or seven voters encountering problems as they attempted to cast their votes at the nearby Tabulator. These individuals had their ballots rejected by the Tabulator after they had been inserted into the ballot scanner on the Tabulator.

8. These individuals were told by pollworker attending the Tabulator that their ballots had been flagged as “over-voting on one or more items.” The pollworker, however, did not identify which item on the ballot had been flagged.

9. I overheard the pollworker presenting two options to voters. The pollworker first told voters that they had the option of taking additional time to complete a “provisional ballot.” I did not hear any voter accept that option.

10. After these voters declined to fill out a provisional ballot, I heard the pollworker indicate that the ballot could still be cast. I would then hear a noise indicating that the Tabulator had accepted the ballot.

11. At no point did I hear the pollworker advise any voter of the option to have their ballot set aside and stored in a separate tray for re-scanning or individual evaluation. Voters were advised only that they could either fill out a provisional ballot or cast the ballot (i.e. press the green “Cast” button) to have the Tabulator accept their ballot.

12. After I filled out my ballot, I proceeded to the Tabulator. There was a voter at the Tabulator encountering a problem, again, with their ballot. I heard the pollworker tell the voter that their ballot had been flagged as having one or more over-votes but that the Tabulator was not indicating which item had been over-voted.

13. The voter asked the pollworker: “Well, will all the other votes count?” The pollworker replied: “Sure, it’ll be fine. Are you ok with me submitting the ballot?” The voter consented.

14. The pollworker then depressed the green “Cast” button on behalf of the voter. The voter’s ballot was accepted by the Tabulator.
