ALLEGATION: Libby Wright and the Giving Tree Outreach Program are fraudulently obtaining / appropriating Supplemental Nutrition Assistance, commonly called food stamp benefits, from DES clients.

FINDING: Unsubstantiated

INVESTIGATIVE DETAILS & SUMMARY

The Department of Economic Security (DES), through the Director of Communications received information from an Arizona Daily Star Investigative reporter of possible fraudulent use of food stamps by Libby Wright and the Giving Tree Outreach Program. The Division of Benefits and Medical Eligibility (DBME) conducted an inquiry / query of Libby Wright and the Giving Tree Outreach Program. The results of this inquiry / query identified (44) DES clients residing at The Giving Tree (GT) and receiving Food Stamp Benefits. Most of the DES clients were scheduled for telephonic interviews. Three clients were scheduled for FAA Office interviews. This investigator planned to talk to the three scheduled for office interviews, however, none of them appeared for the interview. The fact that these clients listed the Giving Tree as their residence was not by itself an indication of fraud; therefore, investigations into these clients were not pursued. The clients who had already identified themselves to [REDACTED] were contacted and interviewed.

The Giving Tree Outreach Program is a non-profit, faith based community organization serving Tucson's homeless and needy since 1988. Libby Wright is the Founder, Director and CEO of the Giving Tree. Ms. Wright has been associated for 30 years in working with the needs of the homeless and less fortunate individuals of our society.

This investigator interviewed a number of DES clients and former clients. People affiliated with the Giving Tree were also interviewed. DES does not have the jurisdiction, authority or the responsibility to investigate the Giving Tree Outreach Program's potential violation of the Federal Nutrition Service (FNS) Supplemental Nutrition Assistance Program (feeding facilities) guidelines. The Office of Internal Affairs (OIA) primary focus was to determine if Libby Wright, who is not a DES client, and people connected with The Giving Tree Outreach Program effectively participated in the Food Stamp Program in any fraudulent manner within the jurisdiction of DES.

DES has authority to issue benefit assistance to eligible DES clients. DES clients are legally entitled to use their benefit assistance as they please within the intent and scope of the program. Once an eligible client has received the food allotment, the client may share the food purchased with others, therefore, the DES clients could allow others to eat food purchased with their food stamps.

Some of the DES clients who had resided at The Giving Tree Outreach Program indicated they had falsified information on their benefit application in order to obtain and use Food Stamp Benefit Assistance at the direction of Libby Wright and/or the Giving

Tree staff, however, no file documentation could be found to support their statements. In addition the investigation could not locate any documentation to support and substantiate the allegations of fraud against Libby Wright and/or Giving Tree Staff.

Giving Tree Organization - Child Welfare Activities

The following information has been developed during the course of OIA's investigation of Libby Wright and the Giving Tree Outreach Program, indicating that Ms. Wright is in fact operating an unlicensed Child Welfare Agency.

Investigative leads established that [REDACTED] a 15 year old female, [REDACTED] along with [REDACTED] have been residing at the Giving Tree Outreach Program since November 15, 2008, possibly longer. On this date the [REDACTED] executed a release and waiver of liability document to the Giving Tree Outreach Program. This document does not make Ms. Wright the legal guardian of [REDACTED].

On March 26, 2009, [REDACTED] was reported as a Runaway Juvenile from the Giving Tree Outreach Program, [REDACTED].

On March 29, 2009, Tucson Police Department apprehended Runaway Juvenile [REDACTED] at approximately 10 AM. [REDACTED] was detained under ARS 8-303 and released to Libby Wright Director of the Grace Group Home, [REDACTED], Connect-up Report Numbers [REDACTED] and [REDACTED]. During Tucson Police Department's contact with [REDACTED], [REDACTED] complained of not feeling well but refused treatment at that time.

Later this date, Libby Wright took [REDACTED] to St Joseph's Hospital because [REDACTED] was not feeling well. At St. Joseph's Hospital, [REDACTED] submitted a "Treat and Release Application" for AHCCCS medical benefits for [REDACTED] and [REDACTED]. On the AHCCCS application [REDACTED] listed Libby Wright as [REDACTED] "Authorized Representative." During the hospital visit [REDACTED] told the nursing staff that [REDACTED] had been sexually assaulted. ST. Joseph's Hospital Nursing Staff reported the sexual assault to the Tucson Police Department [REDACTED]. Present at St Joseph's Hospital during the medical examination and the subsequent TPD interview was Libby Wright [REDACTED] "representative" from the Giving Tree Outreach Program.

[REDACTED] was released from St. Joseph's Hospital and transported by Libby Wright to the Children's Advocacy Center for a forensic interview. The interview was completed and [REDACTED] left with Libby Wright.

Documentation from the DES Treat and Release AHCCCS Application, Libby Wright's Giving Tree Missing Child alert e-mail and the Tucson Police Department reports are provided for your review.

Investigative Note: Ms. Wright's Missing Child alert e-mail sent on Sunday March 29, 2009 at 8:06 AM. stated the following; [REDACTED] brought them to the Giving Tree Outreach Program and left them while [REDACTED] went to the store. Ms. Wright stated that [REDACTED] never came back. This statement is contradicted by the fact that [REDACTED] executed a release and waiver of liability document that purports to transfer custody of [REDACTED] to the Giving Tree Outreach Program before [REDACTED] left.

All documentation supports the determination that Ms. Wright is in fact operating an unlicensed Child Welfare Agency.



A preliminary inquiry revealed the complainant's allegations are in sync with Ms. Wright's usual method of operation, which is to open or operate homes established to shelter vulnerable children and adults. Once accepted into the home, Ms. Wright persuaded parents and vulnerable adults to transfer guardianship, executor, or payee status over to her. Once received, Ms. Wright retains the resident's SSI, Direct Express Debit Card, EBT card, or child support payments as random - as the complaint has alleged.

In the past, Ms. Wright was the director of The Giving Tree, which transferred ownership under questionable circumstances. Ms. Wright was also involved in operating The Grace Home, The Promise Home, and is linked to Cross Country Ministries. *[REDACTED]*

DHS, OLCR, CPS, and the Tucson Police Department are very familiar with Ms. Wright and her questionable practices. Although Arizona Corporation Commission records reveal Ms. Crystal Hart is the Statutory Agent for Cross Country Outreach, information gained by a member of the Office of Child Welfare Investigations (OCWI) demonstrates Ms. Wright is probably operating Cross Country Outreach as an unlicensed group home.

As of this date, OLCR, DHS and DDD report neither Cross Country Outreach nor Ms. Wright retain a current State license. Additionally, DHS reports "halfway homes" are not required to obtain a State license.

The Arizona Department of Health Services (Department) has concluded its investigation of the above referenced complaint. The Bureau of Residential Facilities Licensing determined whether the issue(s) that were raised in your complaint corresponded to the rules or statutes that regulate The Givng Tree.

Through the Department's investigation process, one or more surveyors conducted interviews with staff of the facility, residents that received services from the facility, and anyone else who may have been able to provide pertinent information. Surveyors also made observations during their time on site and reviewed records. The investigation may have also included the review of hospital, police, and other facility or state agency reports.

The Department was not able to find enough evidence to verify your allegation(s); however, it is appreciated that you took the time to make the Department aware of your concerns.
