### SUPPLEMENTAL NARRATIVE:

Initial Case Narrative by R. Moraga #5688 on 08/13/25 at 1254 hrs. Total Dictation Time = 7:04 mins.

NOTE: I did not make contact with an individual by the name of Steven Aiken. He was the pastor for \_\_\_\_\_\_\_. The reportee in the matter wanted to document suspicious nature in which the pastor had been acting lately.

## NARRATIVE:

At 1140 hours on 08/13/25, the Pima County Sheriff's Department (PCSD) received a telephone call from Margaret Schaub. She advised that she would like to meet up with a deputy on the parking lot at the PetSmart at

I responded to that location, and per my radio log, I arrived there at about 1204 hours. Upon arrival, I made contact with that individual who was in her black Jeep Patriot. At which point in time, we then made contact. At that point in time, I asked her if she had any identification. She provided me with her Arizona driver's license, which she was identified as Morgan M. Schaub.

At that time, I asked her if she would explain to me what she would like to document. She advised me of the following. She advised that she was now an ex-employee of

She stated she was doing the audio and video for the church. During services, she would put up on the screens and the music, whatever the Pastor, Paster Steven Aiken, would like. She stated that it had been well documented that the pastor, Steven Aiken, was in a currently law suit against the Sahuarita Police Department (SPD), in the town of Sahuarita. She wanted to report was that the pastor had been acting a little strange. She stated he had been coming to work with a bullet proof vest. He had weapons in his church he carried, and he also invited his parishioners to carry weapons. She stated he had the regular service, but after the regular service, he then started to have side services, in which he would start showing video clips, that she stated he edited, on the screens, showing the issue between him and SPD. She stated it was unfortunate that he was editing the videos, and not showing the parishioners the full true video, and she believed the individual was somewhat acting like a cult. He was showing things so the parishioners of his church would see it his way one sided,

and be against the town of Sahuarita, and SPD.

She did not indicate any threats verbally to the chief of police for Sahuarita, or any of its officers. She indicated that it was strange and weird, and she stated Pastor Steven Aiken was very intimidating. She stated just today, she left the business, she quit. She stated today, he basically called her into a room with other individuals. She felt uncomfortable, and at that time, the pastor, Steven Aiken, basically told her today was about her and what we wanted from her was to cooperate and be on their side, and do as they said.

The reportee, Morgan Schaub, stated that she was not on board and she walked out. She did not indicate there were any threats on her from the pastor, or anybody else threatened her. She walked away. She walked away from the church and her job. She stated that what she believed he was talking about was he had her edit videos and put things in there to make it look one-sided on his end, and she did not like that. She told him, and at point in time, she stated she did not feel comfortable, so she left the business.

At which point in time, after gathering information, she provided me with a card with her name and telephone number on it. She stated to me that she had been driving around, and parking at the Circle K in SPD jurisdiction, waiting for a SPD officer so she could provide that card to them, so she could provide it to their captains or chiefs, higher above, so if they wanted to contact her and let her know what she experienced with Pastor Aiken, then she could advise them of that.

I advised her that I could pass it on, her name and number, to a Sergeant at that time. If they entertained on calling her, they would do so, but I could not tell her if they would. She stated that was fine. At which point in time, she left. I contacted Sergeant Rivera with SPD. He was the Sergeant working. I provided him with the name. He advised SPD were well aware of Steven Aiken. What he did was put the name and number down of the reportee and advise that he would pass it up to higher chain. Once I was done speaking with the individual, I cleared the call.
