I was assigned this case for follow-up on 052499. I did a computer work-up on the suspect vehicle, a 1996 Kia Sephia 4-dr, blue in color with AZ plates 116-BRM. I obtained drivers license information on the suspect. On 052599 I drove to the suspect's home and left a business card for him to call me. The suspect called me at 1730 on 052599 and again at 0700 on 052699. He then finally spoke to me at 0900 on 052699 and I told him the purpose of my visit to his home. He said that he was off on Wednesday 051999 and may have been at ElCon Mall, but could not remember. He said that to his knowledge, no one drove his car but him. I asked at he make an appointment to come down. He suggested today, 052699 afternoon hours. I suggested 2:00 PM.

The suspect appeared at 1345 and I conducted him to an interview room. There, I took a taped statement from him and advised him of his Miranda warnings, on tape. He agreed to talk to me. He admitted being off on 051999. He said that he now did not believe he was at ElCon. He said that he had gone to Phoenix early that day and returned about 12:30 in the afternoon. He said that he ate lunch at Tucson Mall and then went to a movie at the American Home Furnishings building. He could not remember the movie. He agreed that he fit the physical description listed in the police report. He said that his car was not blue, but actually gray. The car I had seen at his residence with the 116-BRM plate was the same shade of blue as his shirt. He agreed that was so. He said he could give no reason why anyone would falsely accuse him. I then told him I was going to issue him a citation after he was fingerprinted and photographed. I conducted him to ID and he was processed. He as allowed to sign the citation and escorted from the building.
