- 4) Waited in line to receive printed ballot. 2 small stacks of ballots, 2 election persons handing them out. Asked for my name, then looked through the ballots to find my ballot. I did not see any name or identification on ballot.?
- 5) Sharpie markers provided.
- 6) Had bleed through from marker on both sides of ballot.

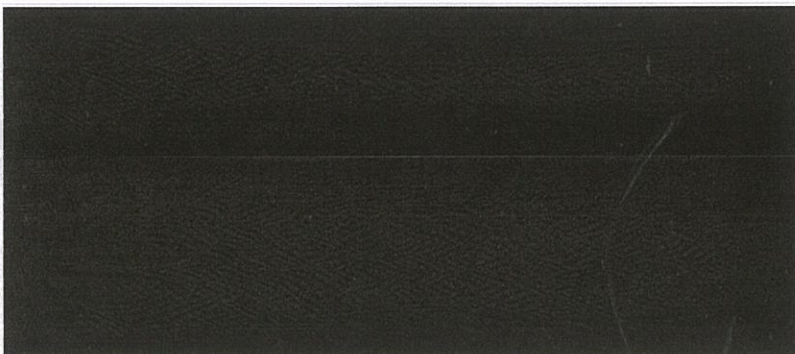

I was seated 20' away from the dual position electronic voting computer.

I noted that voters who were standing in line after completing their registration process, were offered the option of using either the computers or paper ballots.

The voters that selected the computer would approach either side of the unit, handed their documentation to the operator, who set the unit for the new voter.

After the voter entered their computer screen selections, THE OPERATOR REMOVED THE VERIFICATION SLIP FROM THE COMPUTER AND THEN **FOLDED IT IN HALF**, HANDED IT BACK TO THE VOTER AND INSTRUCTED THEM TO CHECK OUT AT THE DOOR.

The issue is that that subtle action in virtually every voter I watched, led them to never actually look at the paper record to confirm that it was an accurate representation of how they voted.

## Miller, Christy cause needless doubt with 'no' votes on election canvass

The two Pima County supervisors didn't allege anything went wrong with the local vote count.

One supervisor argued the different sets of instructions were contradictory when explaining which pens to use to mark ballots. The other thought something terrible maybe-possibly- definitely happened in elections outside of Pima County, so he had to take a brave stand here. When it came time Tuesday to make the usually routine decision of whether to certify the canvass of the vote in Pima County, they voted no. Fortunately, they were outvoted 3-2.

These local 'no' votes were part of a nationwide tsumami of hogwash that penetrated decision centers all around the country last week, as President Trump and his supporters grasped for ways to keep him in power. The most detestable case was in Wayne County, Michigan, where Republican members of the board of canvassers tried to block the votes coming specifically from Detroit, a largely black and Democratic city.

In Pima County on Tuesday, the perpetrators were Supervisors Ally Miller and Steve Christy, the board's two Republicans.

They made themselves the local equivalents of Rudy Giuliani and Sidney Powell. Those two Trump supporters gave a wild news conference in Washington, D.C., on Thursday in which they claimed, among other things, that the long-dead Hugo Chavez of Venezuela had somehow plotted to hijack American election software and flip votes.

Christy, who was just reelected in District 2, gave this tortured rationale Tuesday for why he was voting against certifying Pima County's vote tally.

'The canvass of Pima County's election results is a part of a statewide canvass that is in turn a part of a nationwide canvass,' he said via Zoom. 'There is too much evidence that there is at best statewide and national irregularities and at worst out-and-out voter fraud,' Christy said, putting on a serious-man face. 'I would be derelict in my duty to vote to certify the canvassing of any votes at any

level.' Christy did not, of course, offer any evidence of irregularities or fraud in the state or the country. Nor did he even allege such a thing happened in Pima

point out that the process was not going right, at least at the state level.'

Asked what went wrong at the state level, Christy pointed to contested instructions the Maricopa County Recorder's Office gave voters about how to fix mistakes on ballots, and the length of time counting took in Maricopa County.

On Friday, the Maricopa County Board of Supervisors, which has a 4-1 Republican majority, unanimously certified that county's canvass, 5-0. Consider that: The Republicans of the Maricopa County supervisors unanimously approved the vote count that went against Trump, but Pima County's Republican supervisors rejected our own vote count due to supposed problems in Maricopa County.

On Friday, a judge also unceremoniously dismissed the last of the election lawsuits in Maricopa County.

County, which is after all his jurisdiction. Instead, flipping logic on its head, he claimed responsibility for the integrity of the nation's vote count. But Christy's job, and that of all local officials responsible for elections, is simply to ensure that their jurisdictions' elections run right and votes are counted correctly. Which, even by his account, they were in Pima County.

Miller, who is leaving office soon, made somewhat more sense. She pointed out that Pima County's instructions for mail-in ballots said that voters should use blue or black ink and not use Sharpie-style pens. At the polling places, though, election officials provided felt-tip pens, which Miller said created confusion, since the felt tips are similar to the Sharpies that mail-in instructions recommended against.

Miller said she received complaints about this from voters. Fair enough if true — there was at least something local of substance in that concern.

Brad Nelson, Pima County's election director, responded that he thinks the instructions for mail-in ballots, which are provided by the Pima County Recorder's Office, are old and should be changed, because they predate the tabulation machines the county bought in 2014. Now, he said, the machines can read just about anything, even pencil marks.

Where Miller veered off track was when she brought up Maricopa County's experience. At Maricopa County polling places, voters were offered Sharpie pens that in some cases bled through their ballots, making some voters concerned, though election officials and the courts have dismissed the concerns as groundless. Also, as Miller acknowledged, Pima County and Maricopa County use different tabulation systems.

Pima County's contradictory pen instructions, Miller said, 'created a lot of grief for a lot of people, and now they're not trusting the elections in Pima County because of the elections in Maricopa County.'

None of that, of course, is a good reason to vote against certifying the canvass here. In fact, it's a good reason to vote 'yes,' since the results were trustworthy and should have been acknowledged as such to reassure the voting public.

There hasn't been a single lawsuit in Pima County about the election. Beyond the confusion about which pens to use — when any of them would do — there was no significant problem.

It turns out people claim things in news conferences, in public meetings and in interviews that attorneys and witnesses don't dare to say in court. That's because there is a penalty for making stuff up in court.

Christy told me he would have voted against certification in Pima County even if he were part of a majority rejecting certification of the canvass. In other words, he's willing to disenfranchise Pima County voters over inchoate concerns about 'irregularities' or 'fraud' elsewhere.

I asked Christy if he wasn't functionally undermining our local election system by raising concerns that don't apply here and voting against certifying a local election that he had no complaints about.

'I don't think it undermines anything,' Christy said. 'I think it fortifies the resiliency of our system, that we can object to parts of how the election proceeds, and that there's a process.'

Theoretically that could be true, but only if a person bases their objections to the elections on something, anything real. He and Miller had nothing.

It was a seamless process from "the end of early in person voting" to "emergency voting". In fact, there was no difference at all.

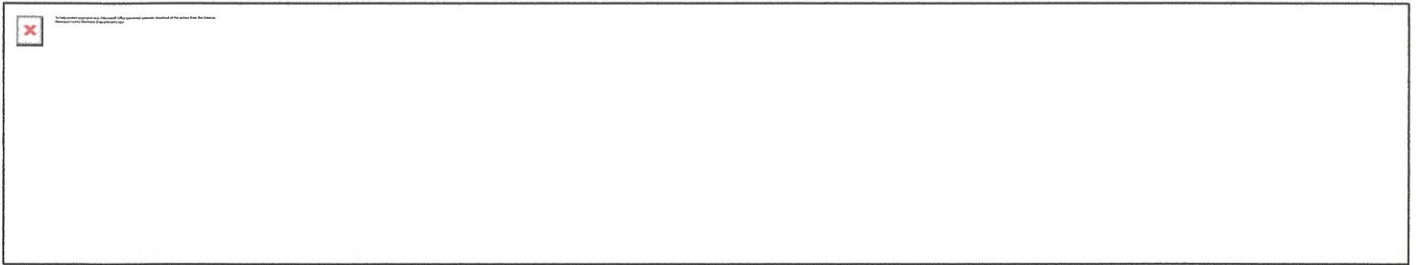

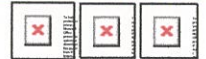

**Maricopa County Vote Centers Are Open This Weekend**

**October 29, 2020** (Phoenix) —Maricopa County voters who have an issue preventing them from voting in-person on Election Day can visit any of the Vote Centers beginning at 5 p.m. Friday, Oct. 30 through Monday at 5 p.m.

State law requires that a voter must provide identification and sign a statement attesting that they have experienced an emergency preventing them from voting on Election Day. It is up to the voter to decide what qualifies as an emergency. Voters do not need to have an emergency to drop off their early ballot in its signed and sealed affidavit envelope over the weekend at any Vote Center or secure drop box across Maricopa County.

The Maricopa County Board of Supervisors approved the [Election Day and Emergency Voting Plan](#) on September 16, 2020.

Nearly 100 locations are open Friday, October 30 and Saturday, October 31. Around 20 locations will be open on Sunday, November 1, and nearly 150 locations will be open on November 2. Find a location at [Locations.Maricopa.Vote](#).

Voters are no longer assigned one location. On Election Day, voters can choose from any of the 175 Vote Centers open across Maricopa County.

Maricopa County is expecting historic voter turnout with nearly 2.6 million voters eligible to participate. Maricopa County has already seen an increase in early ballot returns, with more than 65 percent of early ballots requested already returned, totaling more than 1.4 million ballots.

The Elections Department has implemented [enhanced safety protocols](#). In-person voters can expect to see locations large enough to allow for physical distancing. Poll workers are required to wear masks, face shields and gloves, and frequently clean high-touch surfaces and sanitize pens after each use. Masks and gloves are available for all voters should they not bring their own.

For voters who have not returned their early ballot, they can still drop it off at a secure ballot drop box or at any Vote Center now through Election Day on November 3 at 7 p.m. Voters also have the option to return their early ballot to any of the drive through drop boxes located throughout the County. Find a drop box location at [Locations.Maricopa.Vote](#).

Voters can track their early ballot by texting "Join" to 628-683 or visiting [BeBallotReady.Vote](#). We notify voters when their ballot has been received, signature verified and sent to be counted.

November General Election Day is Tuesday, November 3, 2020.

Dear Sir or Madam,

After receiving a Provisional Ballot for voting in this past General Election (where I voted in person at the Elk's Lodge, Prescott Valley) I attempted to verify via <https://my.arizona.vote/PortalList.aspx> that my vote had in fact been counted. When I entered my old Voter ID# and other personal information, my ballot could not be found.

Earlier today, November 25, 2020, I called your Voter Registration Department and spoke with Matt Webber.

After much research we believe the following to be true:

- 1) Someone falsely requested that my voter registration be canceled. Matt provided me a copy of the document that had been returned to your office, time-stamped June 26, 2017. This document was not requested by me, I never moved out of Yavapai County, I did not receive it in the mail at my then current address : nor is it my signature on the document.
- 2) I proceeded to vote in the Primary Election in August of this year, again in person at the Elk's Lodge, where there was some confusion as to why I did not have a ballot there. After proving my identity, filling in forms given me to make my official address change, I was issued a Provisional Ballot. I assumed this mix-up was due to my having moved late 2018. I did not attempt to verify that my ballot had been counted, but assumed that it had. I also felt certain that these documents were ensuring my registration.
- 3) Today's conversation with Matt brought to light that I SHOULD HAVE BEEN NOTIFIED at this point that I was no longer registered to vote. I never received such information.

- 4) On November 3, 2020 when I was told once again that I was not registered, basically the same steps were gone through as at the Primary and I voted via the Provisional Ballot. Matt explained that because your rejected Provisionals are not followed-up on until well after elections, it is probably awaiting processing by your office.
- 5) Apparently, there are TWO files in your system on myself. Matt believes that the original August Provisional Ballot was not associated with my canceled registration. Possibly the other file was looked at at that time and nothing was done.

Matt assured me that he would follow up with Elections to find out more information.

It is puzzling to me that anyone who knows someone's name, birthdate and address can request a form be mailed to THEM allowing them to cancel someone else's Voter Registration. I think this is a very serious offense.

I would like to know that a system will be put in place to prevent this sort of thing from ever happening in the future. There are many institutions that provide a secondary verification of received information, whereby a notice is sent via USPS to the *old* address. This ensures that the correct person is notified of the change.

Further, I would like verification that you did in fact attempt to contact me upon receiving my Provisional Ballot from the Primary Election.

Dear Senator Leach,

Thanks for setting up this line. I have reported the following to everyone who might listen to me -- EIPAz and AZGOP-- and have received no response. Perhaps that is because what I witnessed is not that important. I will let you judge.

I am a precinct committeeman in Tempe and a regular poll-worker. I worked at a Gilbert polling place on Monday and Election Day. At about 6:30pm on Election Day, a lady dressed as a USPS employee brought us a tray about 2 feet square full of green ballot envelopes. (How many is that? 100? 200?) She explained to our Inspector, Fran Heinle, that if these ballots were handled normally they would not arrive in time to be counted. The envelopes were deposited in the blue urn along with all the other drop-offs that day. An acquaintance, who was working at another polling place in Maricopa County, said the same thing happened at her location.

My job as precinct committeeman was to find people in my precinct who had not yet voted and encourage them to vote. In order to identify the non-voters, I received data from two sources: Campaign Sidekick and trugop. I normally preferred the trugop data because it seemed to be less stale. I received updates at least daily until Oct 30. I think the trugop data was normally 2-3 days stale, so my final dataset is a snapshot of my precinct no later than Oct 28. Then the data stopped. I have requested a final update and have received no reply.

About 25% of the registered voters in my precinct are phantoms. I define phantom as someone who did not return a ballot in the general elections of 2016 and 2018. (That definition would not even include the non-residents who regularly vote, like Mitzi Epstein's son Daniel.) Most are grown children still registered at their parents' address. Many are people who once lived at that address but have no connection to the current residents. I know of cases where parents sign their childrens' ballots so I believe the signature recognition software is permissive. The turnout in my precinct is too high to believe. Many phantoms voted. I fear I cannot get final voted data because it would reveal that.

I did everything humanly possible to vote in the 2020 General Election - only to have that vote disappear off the face of the earth...

- 1.) Having no issues casting a ballot since 1996, I was very surprised to find out in late September that I was no longer a registered voter.
- 2.) On September 26th, I re-registered through [servicearizona.com](http://servicearizona.com), specifying that I wanted to VOTE IN PERSON.
- 3.) On election day, I was told that I'd been sent a MAIL-IN ballot; that I needed to turn it in. I told the worker that I'd been taken off the registry, that I re-registered, that I specified I wanted to vote in person - and that I DID NOT receive a mail-in ballot.
- 4.) I was given a provisional ballot and voted.

The outcome? - utilizing the numbered receipt, the status of my vote says : "Provisional Ballot not found".

Oddly enough, my voting history states that I voted in the 2020 General Election.

I am angry and very concerned...

Though the little Huachuca City community center had a "lot" of people in it (compared to other elections), there was no line. I walked right up to get my ballot.

As I voiced my concerns - being taken off the registry, needing to re-register, specifying I wanted to vote IN PERSON, being told I'd been sent a Mail-In ballot when I did NOT want one and did NOT receive one - the worker (named Pamela) shook her head and told me "the same thing had happened to a LOT of people" (she emphasized the word "lot").

Even as I was being given my provisional ballot, there was an elderly man to my left who was growing loud with agitation, saying, "I always vote! What do you mean I'm not on the roll???"...

After voting, I turned around after walking away from the machine and saw that - in the brief time it took me to fill out my ballot - there was a short line of people behind me, waiting to cast THEIR provisional ballots. I stopped and looked around the whole room... our little community center held 27 to 30 people in the process of voting - and EIGHT of us were in the area for provisional ballots!

(There were also 2 additional women standing at the end of the line which I didn't count; spaced a bit from the others (social distancing?))

Between my experience, what I saw, and what the worker stated, I don't believe for one minute this was a "glitch"... Such issues would never be noticed in a larger voting center, but were blatantly obvious in that small room. With so many people receiving provisional ballots, it leaves me to wonder... how many of those other ballots - like mine - were "not found" when the counting was over?

Concern also arose when I read in the Sierra Vista Herald on November 4th that Cochise County halted vote counting around 10:00 pm on election night. On November 5th, they reported that no additional ballots were counted Wednesday; they were collecting mail-in ballots dropped off at voting centers on Tuesday instead. So many odd things went on - and I wonder... at what point in all of this mess did my vote disappear?

I can't take these concerns to Secretary of State Katie Hobbs; I don't even trust the Cochise County recorder anymore.

I am left devoid of my VOTE - and devoid of ANY confidence in our election processes.

Thank you for your time and consideration with this matter.

This election needs to be audited and the certification needs to be reversed. Sydney Powell, a respected former US Attorney, and current lawyer advised of probable cause (PC) that in a number of states 35,000 votes were added to Democratic candidates at the beginning of tabulations.

The Maricopa County Republican Chairwoman sent the following email with instances of irregularities. Here are some highlights and the complete email follows:

General Election voting days and during the tabulation process. And in many cases, employees and observers have reported to us that they filed challenges or raised objections with supervisors, but little to no corrective actions took place.

**Here is a sampling of the irregularities reported :**

Signature verification irregularities are among the most serious given that the signature verification process is the BACKSTOP to unmasking signature ballot abuse and fraud (and specifically prohibited by Ariz. Rev. Stat. § 16-1005). That said, here are a few of the signature verification problems reported:

- Signature verification problems with ballots signed on November 1-2 at polling centers after proper, verified voter identification that was later rejected at the Elections Office during the signature verification process.
- Signature verification standards repeatedly lowered as workers became more and more challenged as the pool of early ballots overwhelmed the system, or supervisors directed employees to process more and more quickly - from using a standard of looking for approximately 15 points of similarities to compare, to a minimum of 3 similarities, then lowered to one, and ultimately to none – just pass each ballot thru without any verification!
- Challenged signature similarities on multiple ballots indicating possibly the same person was writing multiple signatures were not believed to be reported for investigation, and actually approved.
- Instances where envelope signatures were not even in the name of the voter, but still were passed through.
- Since employees in this room worked by themselves, not in pairs, and were able to determine the voter's political party, several employees reported they observed or heard that some employees only passed through those sharing their political party affiliation, and rejecting all others, regardless of the accuracy of the signatures. Again, observers reportedly had no observable access to those employees.
- There were insufficient numbers of Observers assigned to the signature verification room, those there had to remain at the back of the room so they had restricted and limited access to observe what the employees saw or did, especially those in the rows further away from the observers – some observers brought in binoculars, but that didn't appear adequate for transparency purposes to actually observe the process.

**URGENT - MCRC Executive Board Resolution on Election Integrity**

Dear Supervisors,

As the New Maricopa County Republican Party Chairman, I am writing to you on behalf of the MCRC Executive Board with respect to the General Election and the widespread reports associated with numerous irregularities occurring at the Maricopa County Elections Office during the election tabulation process with ballots, early ballots, as well as the Dominion Voting System and software.

Pursuant to your authority to address election matters under your Title 7, Ariz. Rev. Stat. § 16-1001 to 16-1022 authority, that includes the administration, oversight, review of alleged misconduct and irregularities, as well as referrals to the County Attorney and Attorney General under § 16-1021, we petition the BOS to conduct a comprehensive countywide investigation of all votes, audit and manual recount of all legal votes in the 2020 General Election results, observed by authorized representatives of each political party, and as further described below.

The MCRC Executive Board unanimously passed on November 15, 2020, that:

Resolved, That the Maricopa County Republican Committee Executive Board calls on the Maricopa County Board of Supervisors to conduct a comprehensive countywide investigation, audit, and manual recount of all legal votes in the 2020 General Election results, observed by authorized representatives of each political party.

The resolution was prompted by the questionable data and information you likely have been receiving since at least June of 2019 from County Recorder Fontes and others with a partisan interest in designing a 2020 election scenario to overwhelm the County Elections Office with majority mail-in ballots, and make it possible for the outcome of the Presidential election to be controlled... with the objective of President Trump losing in those states where election offices would be employing Dominion Voting Systems and software for tabulations; and where election offices or their supervisory departments had established early voting or mail-in voting programs, and therefore, would be more amenable to further expansion of those programs and reducing the traditional local precinct-based polling operations with the day of election secret ballot voting.

Based on publicly available information, including the disclosure of previously confidential information by those orchestrating what many now refer to as "theft of an election", we submit that the election office irregularities that may not have been disclosed to you by elections staff, the statistical anomalies that occurred, as well as the apparent non-disclosure to you of the historical built-in vulnerabilities, lack of security, and abuse potential in the Dominion Voting Systems and software that facilitates the manipulation of election vote outcomes without leaving obvious evidentiary trails. And what we share below, not only happened in the Maricopa County Elections Office, but oddly enough in the other key 5 swing states.

Affidavits today were disclosed from Dominion insiders that the software was specifically designed for Venezuela and South American Countries to enable those in power to manipulate or rig election outcomes, using the very same actions that we have seen here where votes appear to be manipulated by increasing one candidate's votes, reducing another candidates votes, and pausing or stopping ballot counting for no apparent reason (such as on election night) to provide time for a secret software reset to create brand new votes needed to overcome any vote deficiency by the intended winner. (See attached articles)

And in case you didn't know, Dominion is a foreign corporation, and its computer servers storing US election voting data reportedly are also located in Germany and Spain, in an apparent violation of US law on foreign country election interference.

Further, we suspect that leading up to your approval of the Dominion Voting Systems and software in June of 2019, and thereafter, you were not informed by Elections Office staff, the Dominion Sales Team, nor the Secretary of State or Director of State Elections, of Official State Election Reports questioning the security and vulnerability of the Dominion Voting system and repeatedly denying certification (e.g., Texas Secretary of State Voting Examinations in January 2019 and November 2019, attached); the existence of US Democratic Congressional led investigations over similar concerns, including elections with reports of votes being switched by voting machines after being inputted, rejection of legal ballots, and other vulnerabilities ("These problems threaten the integrity of our elections and demonstrate the importance of election systems that are strong, durable and not vulnerable to attack." 12/06/19 Senate Congressional Letter at p.13, attached); the outside hacking vulnerabilities reportedly noted in the Dominion Operations Manual; and reports of other security issues.

So, but for not knowing, and assuming you didn't know, would you have proceeded initially with the \$1.6 Million 3-year contract without insisting on adequate remedial safeguards, or later kept the system going?

We submit it was obvious that once Recorder Fontes took office, his mission was to fundamentally change and transform County elections into a vote by mail or electronic voting system, displacing entirely local precinct controlled secret ballot voting. Why? Because even the United Nations, the US State Department, and prior bi-partisan Commissions viewed mail-in voting as most vulnerable to fraud and manipulation of outcomes. Indeed, the US State Department fails to recognize the results of foreign elections conducted solely by mail-in ballots.

So for the 2018 election cycle, against the backdrop of a disputed ballot harvesting law, Fontes unilaterally marketed the expansion of early voting way beyond the original absentee ballot program, unilaterally created emergency voting centers primarily in heavily Democratic areas, and we believe he created opportunities for early ballots and emergency ballots to be harvested for ballot fraud purposes (for example, Democratic operatives would fill out or change previously filled out ballots) at nursing homes, apartment complexes, homeless shelter and soup kitchens, as well as facilitate opportunities for non-citizens and out-of-state citizens to vote. We all remember the 40,000 emergency center ballot envelopes being removed and destroyed despite explicit BOS orders to preserve them and separate out those votes for inspection. AND let's not forget the similarities on the evening of the 2018 election when most State Office candidates were leading when we went to sleep, only to see the next day that overwhelming leads were overcome by early ballots, and the Presidential election here. **2018 was a test for the Democratic machine.**

Yet despite the changes implemented by the BOS after the 2018 election fiasco in 2019, few addressed the need for internal changes in the voting tabulation process at the Elections Office in case of a repeat of 2018 in 2020, or worse.

The China Virus presented Fontes and the Democrats with a "Perfect Storm" in 2020 to accelerate their goal of mail-in only votes, and with the active complicity of the mainstream media's fake narratives of the inherent risk to voting at a local polling center, despite the limited risk of going to grocery stores, liquor stores or other designated "critical" businesses, Fontes and the Secretary of State both encouraged going to mail-in voting only during the 2020 Primary Elections. I recall Fontes even printing early ballots with the intent to mail them to all registered voters, despite no authority to do so; and unilaterally issuing instructions on crossing out voting errors, creating an entirely new way of possible ballot changes after the original vote! Then, we have the Elections Office experiencing difficulties finding local polling locations, so Fontes sought to expand centralized voting centers. And for the General Election, Fontes expanded early voting at centralized locations where anyone could vote (no need for precinct assigned voting and secret ballots) to practically a month, and making election day 3 days, with only the last day being traditional secret ballot voting, but at centralized, non-precinct based locations.

But, we don't recall any changes at the Elections Office, or from the BOS, to enable staff to timely and appropriately handle the anticipated exponential increase in early ballots. So if the increase in mail-in and early voting ballots "overwhelmed" the system, only one of two things would happen: the tabulation process would slow down, thereby incurring possible blowback; or the tabulation process would speed up, just to meet the goal of quickly getting the votes counted, but possibly sacrificing the integrity of the process of determining all "legal votes" and counting all "legal votes."

So the ability of the Dominion Voting system to be manipulated or hacked in favor of certain candidates; together with mail-in and early voting overwhelming the Elections Office tabulation personnel, especially those permanent and temporary workers in the “signature verification” room; and given the media sparked fears of the COVID resulting in many of the most experienced Temporary Workers refusing to risk sickness by working at the Elections Office so lots of inexperienced and untrained Temporary Workers from both political parties; and the failure of Elections Office Officials to inform the BOS of what was happening or likely to happen so the BOS could take early corrective actions, we had a “Perfect Storm” created for massive election irregularities undermining the integrity and accuracy of the vote.

As for the “irregularities” that have been reported that the BOS may not have been advised of by Election Office Officials, the best sources are the actual permanent Elections Office employees, the Temporary Elections Office employees, and the observers appointed by the political parties at the Elections Office during any of the General Election voting days and during the tabulation process. And in many cases, employees and observers have reported to us that they filed challenges or raised objections with supervisors, but little to no corrective actions took place.

#### **Here is a sampling of the irregularities reported to us:**

Signature verification irregularities are among the most serious given that the signature verification process is the BACKSTOP to unmasking signature ballot abuse and fraud (and specifically prohibited by Ariz. Rev. Stat. § 16-1005). That said, here are a few of the signature verification problems reported:

- Signature verification problems with ballots signed on November 1-2 at polling centers after proper, verified voter identification that was later rejected at the Elections Office during the signature verification process.
- Signature verification standards repeatedly lowered as workers became more and more challenged as the pool of early ballots overwhelmed the system, or supervisors directed employees to process more and more quickly - from using a standard of looking for approximately 15 points of similarities to compare, to a minimum of 3 similarities, then lowered to one, and ultimately to none – just pass each ballot thru without any verification!
- Challenged signature similarities on multiple ballots indicating possibly the same person was writing multiple signatures were not believed to be reported for investigation, and actually approved.
- Instances where envelope signatures were not even in the name of the voter, but still were passed through.
- Since employees in this room worked by themselves, not in pairs, and were able to determine the voter’s political party, several employees reported they observed or heard that some employees only passed through those sharing their political party affiliation, and rejecting all others, regardless of the accuracy of the signatures. Again, observers reportedly had no observable access to those employees.
- There were insufficient numbers of Observers assigned to the signature verification room, those there had to remain at the back of the room so they had restricted and limited access to observe what the employees saw or did, especially those in the rows further away from the observers – some observers brought in binoculars, but that didn’t appear adequate for transparency purposes to actually observe the process.

In the “dupe rooms” spoiled ballots after being reentered into the computer were observed to be switched over to a different ballot, pre-populated with an entirely different set of vote selections, usually from a Trump vote to a Biden vote and Democratic slate.

In the adjudication room, there was confusion over how to proceed with the over and undervotes – for example, some supervisors instructed to follow “voter intent” at all times, even where the voter had placed the circle for a candidate and also wrote the same candidate’s name below it and this was accepted; while other supervisors instructed in that same instance to reject the ballot as an overvote, and to reject all overvotes. Additionally, there were reports that some employees rejected outright any undervotes, even undervotes where not all the judges were voted on for retention purposes.

In nursing and assisted living homes, there were reports of no voting assistance for nursing and assisted living home situations by relatives or friends unable to gain admittance and assist the person with their early vote, bring their early vote from home or even be permitted to leave the ballot and arrange to pick it up later. Reports that Elections Office was limited to 2 party Special Election Boards (SEB), but with few exceptions, given the hyped COVID fears, even SEBs where protective suits were available were not permitted to enter facilities. Workarounds reportedly were rejected by Election Office Officials, leaving some 2000 facilities with multiple patient voters unlawfully disenfranchised from their Constitutional right to vote. While we

believe there were workable solutions that eliminated the COVID risk, Elections Office Officials reportedly were overwhelmed with other election issues and not responsive. **If you do the math, we are talking about upwards of 20,000 to over 100,000 voters denied the right to vote!**

The Ballot Box at the Elections Office reportedly was observed unattended at various times during the day, and there were reports of it being accessible and unattended at night and the early morning, too. Reports of observed people pulling up stuffing in large numbers of multiple ballots. Unclear if there was a camera recording 24-7 that box, and if so, whether it was reviewed so that those ballots in the box were given proper signature verifications.

Additionally, there are reported statistical anomalies that should be investigated, including close attention to the ballots that reflect these anomalies. For example, on election night after the Elections Office closed down until the next morning, as did the other 5 swing states' election offices, votes actually were tabulated by someone or were recorded as votes by the Voting System, without the presence of any observers. All these votes should be located and subject to audit to determine the legality of the voting here. Further, there are reports of up to 42,000 "single-shot" ballots for Biden – this anomaly needs investigation, and all such ballots need a close signature verification of ballots and applicable envelopes as there were few if any "single-shot" ballots for Trump; and given that there were 4 significant and contentious votes on the ballot (President, US Senator, a marijuana legalization proposition, and an education tax proposition), why would legal citizens voting in Arizona just vote for president while intentionally ignoring these 3 other critical races; and if indeed reports of under voted ballots being either rejected by tabulators or adjudicators or defaulted by software to Democratic ballots, we submit that all these ballots should be closely investigated, audited and manually recounted for election integrity purposes.

This all comes down to preserving election integrity, ensuring that votes cast are securely received, that only legal votes are counted, and fighting for our sovereignty by preserving our state and constitutional republic...

**So unless the BOS was aware of what we've discussed above, then in simple terms, you were "set up" to take the blame here as everything eventually will come out, as what happened here is not isolated just to Maricopa County, but throughout the other 5 swing states and likely even more states.**

And the only way to cure the perceptive of election irregularities and potential fraud committed upon the BOS, is to consider the proposal from our Executive Board for:

- A quick investigation of irregularities by interviewing all Elections Office workers and observers with the assistance of attorneys and investigators from the County Attorney's Office and perhaps even the Attorney General's Office asking the simple question of whether they have "personal or first-hand knowledge of any irregularities while at the Elections Office" – even with several hundred permanent and temporary employees and poll observers, several hundred attorneys and investigators should be able to complete these short interviews within just a few days.
- An audit with appropriate observers given complete viewable access to the audit tables, of all early ballots and envelopes, and early voting day ballots and envelopes, with instructions to avoid irregularities found from the investigative interviews.
- Then a manual recount of all legal votes identified during the audit with appropriate observers given complete viewable access to the recounting tables.
- With respect to the nursing and assisted living homes and perhaps hospitals, the BOS needs to quickly come up with a workable solution that can quickly be implemented, **as disenfranchising citizens from their Constitutional right to vote even over COVID, amounts to some 20,000 to over 100,000 voters, and those votes clearly are capable of influencing not only the Presidential race, but many downline ballot races and propositions, too.** Related to this problem, is the reports of ballot harvesting and ballot fraud operations at nursing homes where staff operatives collected requested early ballots, or actually requested ballots themselves for patients, and in both instances, they voted the ballots in the patient's name – a simple comparison of registered voters with nursing home or assisted living addresses and those whose ballots were received can be checked and verified in some sampling.
- With respect to the Dominion Software, to the extent either the County Attorneys' Office or the Attorney General's Office has a forensic computer investigator on staff or access to an independent one, we believe that giving them access to the software logs and reports on election activities might be helpful, although not necessarily conclusive if nothing is found since there are reports that the Dominion Software was designed to hide all manipulation of data changes. Plus, we have reports of possible defective settings in the tabulation equipment on alleged sensitivity of the

machines reading ballpoint pen markings, verses sharpies, thereby creating programmed defaults where ballot selections were defaulted either to a preestablished ballot or rejected. Finally, there is a November 13 2020 Congressional letter to Attorney General Barr reporting on election anomalies involving the Dominion Voting Systems in Arizona and other States, coinciding with reports of votes being switched or entirely deleted, in States using Dominion Voting Systems equipment (copy attached).

For those concerned that there is not enough time or resources to get this done, this entire process can “quickly and easily” be done between now and the end of the month; and since the critical date for the electors is actually December 8<sup>th</sup>, other intervening dates can easily be adjusted given the extenuating legal circumstances presented here.

And the MCRC stands ready to help you with this process, including helping to provide the necessary observers for the audit and manual recount process.

Based on the above, we submit this is the only way for the BOS to restore the integrity of the election voting process and the legitimate, legal votes cast by citizens of Maricopa County.

Sir,

I sent you an email a few days ago with very legitimate concerns about this election and concerns with the Dominion Voting System. I can only assume you are still investigating my concerns because I have not heard back from you.

This morning I woke up to see an article that the County is going to certify the election 13 days before the statutory requirement. Fields Mosely, the Counties Communications Director, says "The evidence overwhelmingly shows the election was accurate," My question is, what evidence? I have not heard of or seen any evidence that this was an "accurate" election. The "evidence" I sent you shows the contrary.

The county installed a foreign owned Dominion Voting System with Communist Venezuelan created operating software. (Me - Cathy): I am taking this opportunity to make a submission. I wonder if there will be many submissions since we don't know if it will seriously be looked at or just thrown down another rabbit hole. I related to the Maricopa County Board of Supervisors about in the 2020 Primary and General election of voters receiving multiple ballots but nothing was done. The doctor that sent me pictures was never contacted. And this being Thanksgiving week, one of the busiest weeks of the year, people may have missed this announcement.

But here is what I want to submit:

1. TRACEY GROSSMAN: At our LD1 Republican district meeting Nov. 23, we were informed by one of our members of irregularities she encountered as a poll watcher in Maricopa County. 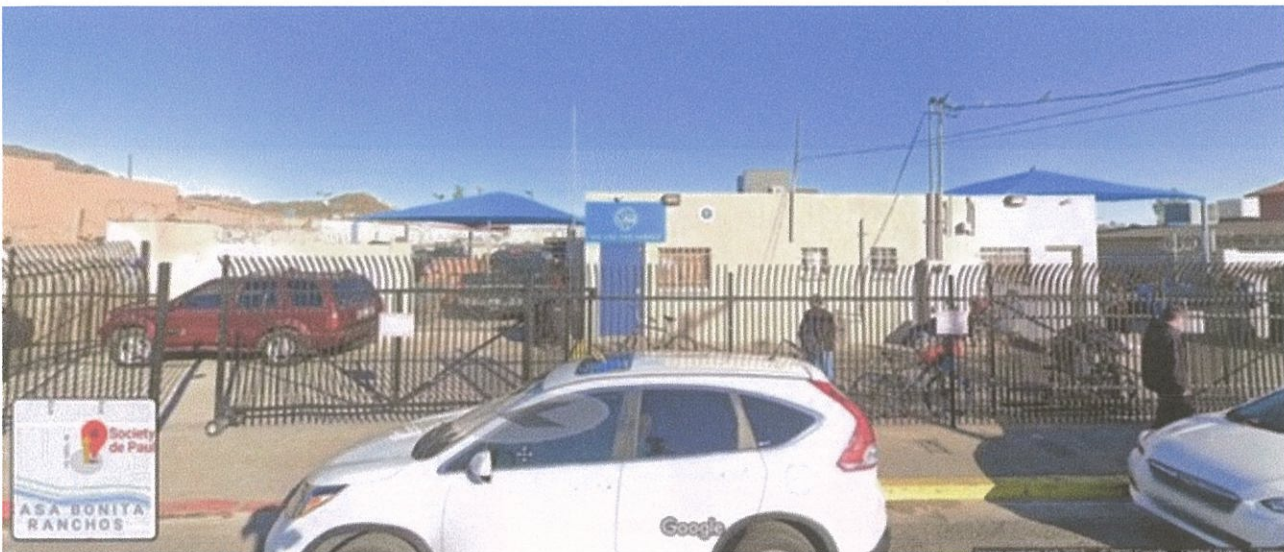

Below is the response I am sending to those who have emailed me. With respect to the hearing on Monday, the Arizona Senate has already set up a dedicated email account [2020election@azleg.gov](mailto:2020election@azleg.gov) asking the voters to email us with their concerns and documentation of fraud and irregularities so we can act upon that information. Apparently Representative Fincham decided he wanted to have his own hearing to gather information as well. We will be glad to share the Senate information and welcome him sharing any information he is able to gather as well. We are all working hard to make sure this election was fair and accurate.

Thank you for contacting my office regarding the election outcome and the integrity of the voting process. We have received many inquiries and will endeavor to make every effort to ensure that the election results were properly and legally conducted. To address the requests made for legislative action I hope the following information is helpful. Please forgive this mass reply but I'd like to respond as quickly as possible to all of you.

First and foremost, please understand that all states have different election laws and procedures so what may work in Pennsylvania may not be legally allowed in Arizona or other states.

For those of you asking to not allow the certification to happen on Monday, November 30<sup>th</sup>, please be aware that President Trump's legal team cannot file their lawsuit until the election HAS BEEN

Certified. Pennsylvania has already certified their election. Once the lawsuits have been filed, the Az House and Senate members can then see what issues are being cited which will give us a path to move forward.

-Presidential Electors: the eleven electors were selected by a vote of you, the people, on November 3, 2020 as part of the vote for President of the United States. The Legislature cannot retroactively modify the current statutes on the selection of presidential electors. Additionally, the Legislature does not have the authority to prevent the Arizona Secretary of State from certifying the canvass. Please see below the legal explanation provided by Legislative Council.

-For those of you asking us to convene a Special Session: there are only two ways a special session can be convened. One is the Governor calls us in for a special session for a specific issue. The second way is the legislators can call ourselves in with a 2/3 vote of all members with no specific agenda. Since we only have 31 R's and 29 D's in the House; 17 R's and 13 D's in the Senate, we would need the Democrats to vote to convene to receive the required 40 and 20 votes. We do not have the votes to call a special session and we do not have the votes to pass the election changes some are asking for.

-Audit of vendor: the Legislature can convene a "special committee" that utilizes its investigatory powers to do a forensic audit by an independent expert to address issues related to the accuracy of the voting machines. We are investigating this option in coordination with the information we are being provided by the voters and the lawsuits being filed.

In addition, moving forward, a comprehensive overview of our elections proceedings is crucial to make any necessary reforms in the hopes of restoring public confidence in the elections system. We have created Senate and House Government (and elections) Committee that will be introducing legislation to ensure the credibility of future elections. We sincerely understand the concerns raised and share in your frustration. The election results in Arizona and other battleground states have created a collective pursuit and call to action to ensure that all votes are legally counted. The results of court proceedings and other administrative remedies will most certainly impact the overall outcome of the presidential election.

Again, thank you for reaching out and voicing your concerns. They are indeed heard. As the actions outlined above play out we will have a better understanding on the best course of action for Arizona and the integrity of the elections process.

Selection of Presidential Electors (R-54-142) ARIZONA LEGISLATIVE COUNCIL MEMO

TO: President Karen Fann

FROM: Ken Behringer, General Counsel

This memorandum is in response to your questions about the appointment of presidential electors and the ability of the legislature to change this process for the current presidential election.

In regard to presidential electors, the United States Constitution provides:

Each State shall appoint, in such Manner as the Legislature thereof may direct, a Number of Electors, equal to the whole Number of Senators and Representatives to which the State may be entitled in the Congress: but no Senator or Representative, or Person holding an Office of Trust or Profit under the United States, shall be appointed an Elector.

U.S. Const. art. II, § 1, cl. 2.

Under this authority, the legislature may select the presidential electors, it may allow the voters to select the presidential electors and it may change how the electors are selected. *McPherson v. Blacker*, 146 U.S. 1, 35 (1892); *Bush v. Gore*, 531 U.S. 98, 529-30 (2000). However, the constitution provides that Congress determines the time of choosing presidential electors. U.S. Const. art. II, § 1, cl. 3. The Court in *McPherson* and *Bush* did not address this Congressional authority because it was not an issue in those cases.

Under its constitutional authority, Congress has directed that "[t]he electors of President and Vice President shall be appointed, in each State, on the Tuesday next after the first Monday in November, in every fourth year succeeding every election of a President and Vice President." 3 United States Code § 1.

The Arizona legislature has prescribed the method of appointment of presidential electors for this state by enacting several statutes, including Arizona Revised Statutes (A.R.S.) section 16-212, which provides in part:

1

November 6, 2020

A. On the first Tuesday after the first Monday in November, 1956, and quadrennially thereafter, there shall be elected a number of presidential electors equal to the number of United States senators and representatives in Congress from this state.

B. After the secretary of state issues the statewide canvass containing the results of a presidential election, the presidential electors of this state shall cast their electoral college votes for the candidate for president and the candidate for vice president who jointly received the highest number of votes in this state as prescribed in the canvass.

The statutes also provide that the chair of the state committee of each political party that qualifies for a column on the general election ballot must appoint the candidates for the office of presidential elector for the respective political party. A.R.S. section 16-344.

To change how presidential electors are appointed, the legislature would have to amend these statutory sections. However, the changes that the legislature might make to these statutes could not be applied to the current election, because the day for selecting presidential electors (November 3, 2020) has passed.

The current statutes on the selection of presidential electors were in effect on November 3, 2020 and the people voted pursuant to statute to make the selection on that date. If there is a question about the conduct of the election, the election would have to be challenged in the courts. The legislature cannot change the 2020 election results through changing the statutory selection process for presidential electors.
