NARRATIVE: ON 8-27-15 (Thursday) AT APPROX 1315 HOURS, I WAS DISPATCHED TO 39580 S LAGO DEL ORO PKWY (SIERRA TUCSON) IN REFERENCE TO A MEDICAL.

GOLDER RANCH FIRE ARRIVE ON SCENE AND ADVISE US THAT IT IS A POSSIBLE SUICIDE.

I ARRIVED AT SIERRA TUCSON AT 1349 HOURS. EMPLOYEES FROM THE FACILITY DIRECTED ME BACK TO THE CRESCENT MOON BUILDING LOCATED ON THE NORTH SIDE.

I WAS DIRECTED TO ROOM 34. INSIDE THE ROOM I OBSERVED THREE MEMBERS OF GOLDER RANCH FIRE IN THE ROOM. IN THE BATHROOM AREA I OBSERVED A SUBJECT LAYING ON THE BATH ROOM FLOOR WITH A WHITE SHEET OVER HIM. HIS LEGS WERE PART WAY IN THE BATHROOM CLOSET. I SPOKE WITH THE GOLDER RANCH FIRE PERSONNEL, [REDACTED], [REDACTED] AND CAPTAIN [REDACTED]. CAPTAIN [REDACTED] ADVISED THEY TOOK OVER CPR FROM STAFF EMPLOYEES, UNTIL DR. [REDACTED] FROM THE ORO VALLEY HOSPITAL PRONOUNCED THE SUBJECT DECEASED AT 1344 HOURS.

AS I WAS IN THE BATHROOM, CAPTAIN [REDACTED] LIFTED THE WHITE SHEET UP FROM THE SUBJECT. I OBSERVED A WHITE MALE WITH LIGATURE MARKS AROUND HIS NECK. I ALSO NOTICED TUBES IN THE SUBJECTS MOUTH CONSISTENT WITH MEDICAL PERSONNEL RENDERING AID.

IN THE BATHROOM SINK I OBSERVED TWO WHITE SHOE LACE'S TIED TOGETHER IN THE SINK WITH A REDDISH STAIN ON THEN CONSISTENT WITH THE COLOR OF BLOOD.

I ADVISED GOLDER RANCH THAT I WOULD TAKE OVER FROM HERE. WHEN THE FIRE CREW LEFT THE ROOM I MADE SURE EVERYONE WAS OUT OF THE ROOM AND THEN I EXITED THE ROOM AND CLOSED THE DOOR.

THE RUN NUMBER FOR GOLDER RANCH FIRE DEPARTMENT WAS C1522549.

I NOTIFIED SGT. RAMIREZ OF THE INCIDENT AND HE LATER INFORMED ME A DETECTIVE AND AN ID TECH. WERE EN ROUTE.

I DID SPEAK WITH PERSONAL AT THE FACILITY IN WHICH THEY PROVIDED ME WITH A SHEET WITH THE VICTIMS PERSON INFORMATION. THE SUBJECT/ VICTIM WAS IDENTIFIED AS [REDACTED] [REDACTED] OF CALIFORNIA.

I THEN SPOKE WITH [REDACTED], A CLINICAL TECH AT THE FACILITY. [REDACTED] WAS THE ONE WHO LOCATED [REDACTED]. WHILE SPEAKING WITH [REDACTED] I COULD TELL [REDACTED] WAS VISIBLY SHAKEN UP OVER THE INCIDENT. I ASKED [REDACTED] TO TELL ME WHAT HER PART WAS INVOLVING [REDACTED] SAID THAT [REDACTED] MISSED HIS 1300 APPOINTMENT AT THE FACILITY AND AROUND 1315 HOURS SHE WENT TO HIS ROOM TO CHECK ON HIM. WHEN [REDACTED] WAS IN HIS ROOM SHE DID NOT SEE HIM UNTIL SHE OPENED THE CLOSET DOOR LOCATED IN THE BATHROOM. [REDACTED] SAID THAT SHE SAW [REDACTED] HANGING BY A WHITE STRING. [REDACTED] SAID THAT IT TERRIFIED HER AND SHE WENT CALLING FOR HELP. I ASKED [REDACTED] WHEN WAS THE LAST TIME [REDACTED] WAS SEEN ALIVE. [REDACTED] STATED THAT [REDACTED] (UNKNOWN LAST NAME) THE TECH AT THE FACILITY SAW HIM AT 1230 HOURS.

AFTER SPEAKING WITH [REDACTED] I INFORMED THE STAFF THAT NO ONE IS ALLOWED IN [REDACTED] ROOM UNTIL THE DETECTIVES AND MEDICAL EXAMINER ARE DONE.

STAFF MEMBERS DID PROVIDE ME WITH A LIST OF THE NURSES THAT PROVIDED MEDICAL AID TO [REDACTED]. THIS LIST WAS LATER TURNED OVER TO DET BONUCCI.

WHEN DETECTIVE BONUCCI AND ID TECH H. CARINO ARRIVED ON SCENE I ADVISED THEM OF THE INCIDENT. DETECTIVE BONUCCI REQUESTED I STAY ON SCENE.

[REDACTED], THE PINAL COUNTY MEDICAL EXAMINER ARRIVED ON SCENE SHORTLY AFTER.

AFTER ID PROCESSED THE SCENE, THE MEDICAL EXAMINER REQUESTED THAT I INITIAL THE SEAL ON THE BODY BAG. THE SEAL NUMBER IS 0001684.
