

DEFERRED PROSECUTION AGREEMENT

IT IS HEREBY AGREED between the undersigned parties that all prosecution in the above-styled cause will be deferred for a period of **six (6) months** from the date of this Agreement. This Agreement is a result of investigation into the charge of Disorderly Conduct. This Agreement is based upon the following conditions:

01. The Defendant, after being advised of his/her rights, hereby waives all rights to a speedy trial pursuant to Rule 3.191 of the Florida Rules of Criminal Procedure.
02. The Defendant shall refrain from violation of any law; local, state or federal.
03. The Defendant shall immediately inform the State Attorney's Office or his/her attorney of any change of address or employment.
04. The Defendant shall pay **\$500.00 in diversion fees, payable to the State Attorney's Office, by money order or cashier's check.**
05. The Defendant shall not have any contact with the victim, William Gray.
06. The State Attorney may prosecute the Defendant for this offense/these offenses if he/she violates any of these conditions for the next six (6) months. Failure to complete the conditions of this agreement will result in a *capias*/warrant being issued for defendant's arrest.

If the Defendant complies with these conditions during this period of State Attorney's deferred prosecution, the charge(s) will be dismissed.


