Project Objectives

Preserve and prolong the service life of the existing structure by reducing the rate of deterioration of the identified deficient bridge elements through cost effective rehabilitation strategies.

Proposed Alternative

The proposed alternative is to make isolated concrete repairs on the underside of the superstructure slab, fascias, substructures and replacing rebar as needed; install waterproofing

membrane on the top of the structure; and replace bridge rail, transition rail, and guiderail to meet current standards.

Work Zone Traffic Control

The majority of work included under this project will occur beneath the existing bridge and will not require work zone traffic control. Installation of the waterproofing membrane, replacement of the asphalt wearing surface and replacement of the bridge and approach railing will be completed using lane and shoulder closures.

Anticipated Schedule

Design Complete – September 2025 Start Construction – May 2026 Complete Construction – July 2026




