1. On one or more occasions, between February 18, 2025, and June 10, 2026, in Lee County, Florida, did unlawfully make, post, or transmit a threat in a writing or other record, including an electronic record, to conduct a mass shooting or an act of terrorism, in a manner that would allow another person to view the threat, contrary to Florida Statute 836.10,

contrary to the statute in such cases made and provided, and against the peace and dignity of the STATE OF FLORIDA.

AND it appears to the Court that probable cause for the issuance of this warrant has been shown and the Court being satisfied of the existence of the grounds thereof.

NOW, THEREFORE, you are commanded forthwith to arrest the said Joseph Antonio Baer and bring him before me or another County or Circuit Judge with jurisdiction to be dealt with according to law.

Before me, a Notary Public in and for said County, personally came Detective Jo Ann Werbalis, who, being duly sworn, deposes and says that on the 4th day of December, A.D. 2025, in the County aforesaid, one: JOSEPH ANTONIO BAER did violate the laws of the State of Florida, to-wit:

**TERRORISTIC - STATE OFFENSES - WRITTEN/ELEC THREAT MASS  
SHOOTNG/TERRORISM ACT  
F.S.S. 836.10 (2)**

On Thursday, December 4, 2025, Detective Jo Ann Werbalis of the Fort Myers Police Department, who is assigned as a Task Force Officer (TFO) to the Federal Bureau of Investigation (FBI) Safe Streets Task Force in Lee County, Florida. TFO Werbalis became aware of the following threat-to-life investigation.

On February 18, 2025, the FBI became aware of an X.com account operating under the username "SamsaraAddict." A review of the account revealed numerous posts glorifying mass shooters, promoting white supremacist ideology, displaying firearms, and advocating violence against racial and religious minorities. Through investigative means, the account was identified as being utilized by Joseph Antonio Baer (DOB: June 13, 2005), of 4219 Lemongrass Drive, Fort Myers, Florida.

On February 26, 2025, FBI Special Agents interviewed BAER at Florida Gulf Coast University. Baer is currently enrolled in FGCU and is an engineering student. During the interview, BAER admitted ownership of the SamsaraAddict account. Although BAER denied any intent to commit violence, subsequent investigation revealed his continued involvement with online extremist communities promoting racially motivated violent extremism (REMVE).

In October 2025, the FBI received information indicating BAER was actively participating in online forums and Discord servers associated with neo-Nazi

accelerationist organizations, including FashFront.org and individuals affiliated with the Injekt Division. Investigation revealed BAER was utilizing the Discord account "ehwaz18" and other related accounts to communicate with like-minded extremists.

[To be noted: **Injekt Division** is an active neo-Nazi, accelerationist organization that promotes and incites real-world, organized violence, primarily through online propaganda and networking on platforms. **Fashfront.org** describes themselves as a place for "fascists to network."]

A review of BAER's communications revealed that he repeatedly advocated for violence, terrorism, armed revolution, and the destruction of governmental institutions. BAER openly stated that his goal was to "radicalize" other users and recruit them to support violent accelerationist ideology. BAER regularly encouraged others to commit acts of violence and expressed support for prior mass attackers.

On or about November 2025 through January 2026, while utilizing the Discord account "ehwaz18," BAER made numerous statements including:

- "The only action is an attack."
- "My goal is to destroy America."
- "Bomb government buildings."
- "We should destroy America."
- "Armed struggle and violent revolution."
- "We are revolutionaries. We want the state to be destroyed."
- "I will die fighting for the banner of Hitler."
- "im literally in the midst of helping put together an all white commune and writing NS literature what have you done?having a commune makes it easier to work organize and also gives us a place where our existence is secured. And what i'm currently working on is compiling essentially the entirety of fascist doctrine across probably hundreds of sources into one piece of literature, and obviously it would help if people in our movement could be authentically NS without having to waste all their time being scholars it would be distributed to ppl in our org which would organize on the commune no, it makes it so feds can't monitor us because we would be organizing irl away from any surveillance our idea is essentially an evolved form of what manson did barker ranch."
- "In the end we will win"
- "All violence is good violence"

These statements were made within the context of discussions regarding violent revolution, terrorism, racial conflict, and the collapse of the United States government.

On January 14, 2026, while utilizing the Discord account "GTKRWNWP (Gas the Kikes Race War Now White Power)," BAER posted, "Every Christian needs to hang," and further stated, "Join us or perish with the rest." BAER also wrote that a future National Socialist state would be established "by any means necessary" and that after America collapsed, "we'll hang every single one."

From March 19, 2026, through May 2026, BAER continued to post extremist propaganda on X.com under the username "wyrddvce." During this period, BAER shared material advocating terrorism and political violence. On April 8, 2026, BAER reposted a message stating, "The only way to fight this government is with terrorism style attacks. Sneak a bomb into an essential building and set it off before anyone sees you. Track down any important people, politicians, military leaders, etc., and try to assassinate them." This is a quote from Thomas Crooks, the individual who attempted to assassinate (at the time) former President Donald Trump.

During further review of BAER's X.com account, wyrddvce, investigators identified propaganda being shared and branded as 'Siege 2.0.' The Siege 2.0 ideology is an evolution of James Mason's publication 'Siege,' which BAER has continuously encouraged others to read. Mason's writings encouraged decentralized groups to commit REMVE attacks in support of their belief in the superiority of the white race. The followers of Siege 2.0 seemingly spread propaganda compiled from past mass attacks by white individuals in an attempt to encourage others to commit lone-wolf-style violent attacks. They believe any violent attack by white individuals will contribute to their goals and accelerate the collapse of the Zionist Occupied Government (ZOG)

In April 2026, a sensitive source of information provided the FBI with screenshots from a private messaging application that indicated BAER desired to become a "Saint," a term used within the Siege 2.0 accelerationist movement to refer to individuals who commit acts of mass violence. BAER advised that he was preparing a manifesto, provided photographs he hoped would appear on news broadcasts, and stated he intended to acquire firearms upon turning twenty-one years old on June 13, 2026.

Investigation further revealed that BAER repeatedly praised and glorified individuals who committed mass casualty attacks and advocated for future acts of violence. On May 18 and May 19, 2026, after an extremist (REMVE) attack at the Islamic Center of San Diego, BAER publicly praised the attackers, referred to them as "Saints," and disseminated propaganda celebrating the attack.

On or around June 10, 2026, a sensitive source of information provided the FBI with screenshots from a private messaging application that indicated he reiterated his intent to purchase a firearm on his twenty-first birthday (June 13, 2026). Baer indicated that if he had an issue at the gun store, he would possibly utilize other means, the confidential source, to obtain a firearm. Baer further elaborated that he wanted to acquire a Bushmaster XM 15. Baer advised that he wanted that particular firearm due to it being the firearm that Lanza (Lanza refers to Adam Lanza, who conducted the mass shooting at Sandy Hook Elementary School) and Gendron (Gendron refers to Payton Gendron, who conducted the mass shooting at Tops Friendly Markets in Buffalo, New York). Baer stated that it was "cool to base your load out after someone else's."

Based on my training, experience, and review of the communications described herein, I believe BAER's statements constitute "true threats" and are not merely protected political speech, hyperbole, ideological advocacy, or abstract discussions of controversial beliefs.

The investigation revealed that BAER repeatedly communicated statements advocating violence, terrorism, murder, armed revolution, and the destruction of governmental institutions. BAER did not merely express support for controversial political views; rather, he repeatedly promoted violent action as necessary and desirable. Among other statements, BAER declared, "The only action is an attack," "Bomb government buildings," "Armed struggle and violent revolution," and "My goal is to destroy America." BAER further stated, "Every Christian needs to hang," "Join us or perish with the rest," and asserted that after the collapse of America, "we'll hang every single one." These statements were made in discussions centered on violent revolution, terrorism, racial conflict, and the use of force to achieve ideological objectives.

The investigation further established that BAER's communications were accompanied by conduct demonstrating that the threats were serious expressions advocating violence. BAER openly stated that his goal was to "radicalize" others, recruit individuals into extremist organizations, and encourage support for violent accelerationist ideology. BAER actively participated in online communities associated with neo-Nazi accelerationist movements that promote real-world violence. He repeatedly glorified prior mass attackers, praised individuals who committed acts of terrorism, disseminated propaganda celebrating extremist attacks, and encouraged others to study literature advocating violent acts in furtherance of ideological goals.

The investigation also revealed evidence that BAER was moving beyond mere advocacy and toward preparation for future violence. BAER advised others that he desired to become a "Saint," a term used within the Siege 2.0 accelerationist movement to describe individuals who commit acts of mass violence. BAER stated that he was preparing a manifesto, provided photographs he hoped would appear in future media coverage, and repeatedly discussed obtaining firearms upon turning twenty-one years old. BAER

specifically identified the Bushmaster XM-15 rifle as the firearm he intended to acquire and explained that he selected that weapon because it was used by Adam Lanza and Payton Gendron, two perpetrators of notorious mass-casualty attacks. EAER further stated that it was "cool to base your load out after someone else's."

Viewed collectively and in context, BAER's statements constitute more than generalized political advocacy or offensive rhetoric. A reasonable person reviewing the communications would interpret them as serious expressions advocating and threatening violence, terrorism, murder, and mass casualty attacks. The statements were specific, repeated, and made within extremist forums dedicated to promoting real-world acts of violence.

Further, the circumstances demonstrate that BAER possessed the requisite mens rea required for a true threat. BAER openly acknowledged his desire to radicalize others, recruit individuals to violent extremist causes, glorify acts of terrorism, and encourage future attacks. By repeatedly communicating statements advocating bombings, executions, terrorism, and violent revolution, while simultaneously discussing the acquisition of firearms, preparing a manifesto, and expressing a desire to emulate prior mass attackers, BAER knowingly communicated messages that he understood would be perceived as threats of violence.

Based upon the totality of the circumstances, there is probable cause to believe BAER knowingly and willfully transmitted written and electronic communications containing threats to kill, inflict bodily injury, or commit acts of terrorism, and that he intended such communications to be viewed as threats, in violation of Florida Statute 336.10(2).

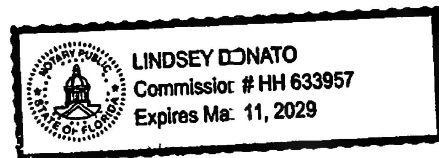
