NARRATIVE

On 12/16/16 at approximately 1000 hours Sgt. Wingo was conducting surveillance in the area of Palm Springs Blvd and Radio Road. Information was previously received about a white Ford Escort that had a bad tag bearing 9959UZ. This tag was run and came back listed to a black GMC utility not a ford. On 12/14/16 and again on 12/15/16 a drive by of 696 Pine Vale Drive was conducted and a white Ford Escort was seen bearing 9959UZ which is not assigned to that vehicle.

Knowing this information and the vehicle description Sgt. Wingo was conducting further surveillance in the area on this date and at approximately 1019 hours observed the white Ford Escort driving E/B on Radio Lane and turned N/B on Palm Springs Blvd. Sgt. Wingo observed that the tag on the Ford was 9959UZ. Knowing that this tag was still bad Sgt. Wingo conducted a lawful traffic stop on the vehicle.

The vehicle pulled over just north of Radio Lane. Sgt. Wingo approached the driver side and made contact with the sole occupant, later identified as Robert Harris. Sgt. Wingo identified himself as law enforcement and was wearing an agency issued tactical vest with SHERIFF and his badge prominently displayed. Sgt. Wingo advised Robert for the reason of the stop and asked for his DL and vehicle paperwork. Robert was looking down texting on his phone and did not respond at all to Sgt. Wingo. The driver side window was down and Sgt. Wingo again asked Robert for his DL and vehicle paperwork. At that point Robert stated "I AM NOT DOING ANYTHING UNTIL I CONTACT MY LAWYER". Sgt. Wingo informed Robert that he cannot call his attorney now and requested him to step out of the vehicle. Sgt. Wingo began to open the driver door in order to have Robert step out. At that time Robert put his phone down, reached through the open window with both hands and pulled the door shut obstructing Sgt. Wingo with his investigation. Sgt. Wingo pulled his Taser out with his right hand and opened the door again with his left informing Robert that he was now under arrest. Robert immediately reached up and forcible removed the Taser cartridge from the front of the Taser before the Taser was deployed. Sgt. Wingo, now realizing that the cartridge was removed, attempted to drive stun Robert in the chest. Robert then grabbed Sgt. Wingo's wrist that was holding the Taser and pulled Sgt. Wingo in to his vehicle. Sgt. Wingo attempted to disengage and get out of the vehicle but Robert grabbed Sgt. Wingo with both hands attempting to keep Sgt. Wingo in his vehicle. Sgt. Wingo then, fearing for his safety called out for help over the radio. Sgt. Wingo then punched Robert in his face with his left hand while Robert continued to hold the Taser attempting to pull it from Sgt. Wingo's grip. The Taser trigger was activated and was held down by the force of Sgt. Wingo and Roberts grip during the struggle. Robert then punched Sgt. Wingo in the left side of his face. Sgt. Wingo again called out for help over the radio as he struggled violently with Robert. After Robert

tried pulling the Taser from Sgt. Wingo's grip unsuccessfully, Robert turned the Taser toward Sgt. Wingo in an attempt to Taz Sgt. Wingo. This attempt failed and the violent struggle continued inside of the vehicle. Sgt. Wingo, again fearing for his life, continued to punch Robert in the face and chest area. Robert also continued to punch Sgt. Wingo in his face and chest. This entire struggle was inside of the vehicle with Sgt. Wingo on top of Robert. Sgt. Wingo was still attempting to disengage Robert and get out of the vehicle the entire time but Robert still held a strong grip on the Taser and Sgt. Wingo's hand not allowing Sgt. Wingo to disengage and escape the vehicle. A short time later backup units arrived (Sgt. Newell #2685, Sgt. Streeter #1928, Cpl. Shreeve #1328) and were able to open the passenger side door and spray Robert with OC Spray before being able to physically remove Robert from the vehicle. Robert continued to physically struggle with Sgt. Newel and Cpl. Shreeve ignoring more law enforcement commands to place his hands behind his back. After another short struggle Robert was placed into custody and arrested.

EMS responded to the scene and transported Robert to Physicians Regional hospital as he claimed he was injured and that he was blind and couldn't breathe. He stated his nose hurt and his shoulder hurt. Cpl. Pisano and Cpl. Gosselin escorted Robert to the hospital.

Sgt. Wingo suffered injuries to his right hand including bruising and scratching. He received injuries to his right wrist area where Robert was attempting to grab his Taser. He received swelling to the left side of his face from where Robert was punching him. He also received numerous scratches on his arms and neck. Sgt. Wingo was treated on the scene by EMS.

Robert was placed under arrest for Assault on LEO for attempting to turn the Taser on Sgt. Wingo while it was activated attempting to injure him. Battery on LEO for violently and physically attacking Sgt. Wingo. Resist Arrest with Violence, Obstruction and attach tag not assigned. The vehicle information was run and came back listed to a Thomas Brimmekamp and should have a tag on it 435PHG not 9959UZ.

The following is a quick SUMMATION of the initial traffic stop radio transmission as units responded to assist Sgt. Wingo:

SGT, WINGO - 3F10 (call sign) traffic stop

DISPATCH - 3F10 go ahead

Also a 911 caller by the name of Zach (786-545-6500) contacted dispatch and informed them of a physical altercation where someone was attacking a deputy.

The scene was secured and CID and Crime scene were contacted and responded to the scene. Sgt. Wingo's injuries were photographed and documented as well as the scene.

The radio transmission was placed in to evidence.

Robert was eventually released from the hospital and transported to the Naples Jail Center for processing.

I again called "10-24" with my left hand, however this time when I removed my left hand from Robert he reached over with his right hand at my Taser. Robert now had both of his hands on my Taser trying to remove it from my grip. As Robert did this I could feel the shock from the Taser on my right hand and running down my right arm. I again punched Robert in the face with my left hand. Robert let go of my Taser with his right hand and began hitting me in the chest, which struck my tactical vest. I used my radio again and asked for "HELP". Robert again grabbed at my Taser with both hands and again I could feel myself being Tased. I punched Robert in the chest with my left fist and Robert let go of my Taser with his right hand.

Robert struck me several times in the face and chest during this incident. I struck Robert two to three times in the face and once in the chest during this incident.

During this entire incident I was ordering Robert to let go of my Taser. At one point I even told Robert that if he took my Taser away from me he would be shot. There was no point during this incident where Robert let go of my Taser or my right hand. Robert's grip was so tight on my Taser hand that his finger nails cut into the skin on my right hand causing me to bleed. At some point during the physical altercation Robert called me by name "Wingo". When I could hear sirens approaching our location I told Robert that more deputies were almost in the area and that he needed to give up, Robert continued trying to take my Taser.

Backup deputies responded. I could see Cpl Shreeve #1328 outside of the front passenger side window trying to get in but the door was locked. I reached over with my left hand and unlocked the door. As the door opened I informed deputies that Robert was trying to take my Taser. Sgt Newell #2685 sprayed Robert with OC Spray. Deputies grabbed Robert's upper body and pulled him out of the passenger side of the vehicle. It should be known that even when other deputies arrived Robert was still trying to take my Taser from me.

While fighting with Robert inside of his vehicle a citizen walked by on foot and screamed out something about helping me. I screamed back for him to call 911.

SGT WINGO #2810 HAD CONDUCTED A TRAFFIC STOP IN THIS AREA AND WAS SUBSEQUENTLY INVOLVED IN A PHYSICAL ALTERCATION WITH ROBERT HARRIS (ARRESTED).

Sgt. Gustavo Santos, (ID# 1825) arrived at the hospital with Detective Russell, (ID# 2570) and asked Robert if he wished to speak with them. Robert immediately stated that he did not want to speak to them without his lawyer present. The Detectives left the hospital and left Cpl. Gosselin and I with Robert.

Once Robert began to see better after his eyes were flushed he began asking Cpl. Gosselin and I questions.

Cpl. Gosselin and I did not ask Robert any questions pertaining to the current case, as we heard Robert tell Sgt. Santos he did not wish to speak unless his lawyer was present.

Robert did ask Cpl. Gosselin and I where his car was towed and what company. Cpl. Gosselin stated he would double check on his computer, but the vehicle did not have a plate attached to it. Robert made the spontaneous utterance of, "It was going to have a plate today, because I just got paid." I did not answer Robert or acknowledge what he had just said.

After that utterance I decided to read Robert his Miranda Rights, and once I did he stated that he understood. I did not ask him any questions after reading him Miranda.

Robert later stated that he needed his glasses from his vehicle, and that they were knocked off his head in the altercation. I told Robert that since he was the owner of the vehicle he could go and retrieve them at a later time, or possibly have his brother pick up the glasses from the vehicle. Robert uttered spontaneously the following, "Well I technically don't own the car, I just bought it today and was just driving it home." I told Robert that Sgt. Wingo had observed that same vehicle in his driveway one day earlier. Robert asked me what time it was observed, and

and call 911 for help. Gary stated he could see the deputy inside the suspect vehicle but could not see the Taser. Gary stated he could hear the deputy yelling "Get out of the car". Within a minute of the man riding his bike to the store to call 911, deputies arrived and got the suspect out of the car.

I made contact with SGT. Wingo and he stated the following:

SGT. Wingo received intel that an older model Ford Station Wagon was being driven by residents at 696 Pine Vale Drive and had a unassigned Florida tag attached to it. On 12/20/2016 SGT. Wingo observed that vehicle traveling on Radio Rd and turned onto Palm Springs Blvd. Sgt. Wingo initiated a traffic stop on the vehicle. The vehicle pulled over to the right side of the road and stopped. SGT. Wingo approached the vehicle and made contact with the driver, Robert Harris. Robert was texting and ignoring Sgt. Wingo's requests. Sgt. Wingo opened the driver door and Robert grabbed the door through the open window and closed it. Sgt. Wingo drew his Taser, opened the driver door and ordered Robert out of the vehicle. Sgt. Wingo pointed the Taser at Robert. Robert grabbed the cartridge from the Taser, removed it and threw it on the floor board. Sgt. Wingo attempted to deliver a drive stun with the Taser but Robert grabbed Sgt. Wingo's wrist (same hand holding Taser), leaned back in the vehicle and pulled Sgt. Wingo inside of the vehicle. Robert and SGT. Wingo fought for control of the Taser as Robert was attempting to take it from SGT. Wingo's hand. Sgt. Wingo was able to radio for help with his free hand. SGT. Wingo advised Robert kept a grip on his Taser hand and held him by his tactical vesting, preventing SGT. Wingo from exiting the vehicle. Robert was able to turn SGT. Wingo's hand towards him so that the front of the Taser was now facing SGT. Wingo. SGT. Wingo gave several loud commands to " Let go of my Taser" but Robert did not comply. Robert struck SGT. Wingo in the face and chest several times before other deputies arrived on scene.

SGT. Santos #1825 and I responded to Physicians Regional Hospital and made contact with Robert. Robert was in the emergency room and had a towel across his eyes. I identified myself and asked him if he wished to make a statement. Robert stated he wanted to talk to his lawyer. I did not have any further contact with Robert after he requested his attorney.
