*On Friday, May 29, 2026, Detective Bello was notified of an in-custody incident involving the subject, inmate [REDACTED]. Preliminary information revealed that on Thursday, May 21, 2026, at approximately 8:40 PM, [REDACTED] was housed at the downtown jail medical floor inside cell 2F31. At this time, [REDACTED] as housed alone inside his cell and seen approaching his cell door for his daily medications when he lost balance, fell back and struck his head on the concrete floor of the cell.*

[REDACTED] down to the jail's sallyport as EMS was called for hospital transport. While in the sally port [REDACTED] began having a seizure and became unresponsive at that time. EMS arrived and conducted lifesaving measures on [REDACTED] as he was transported to Gulf Coast Medical Center.

*Detective Bello responded to [REDACTED] hospital room, located inside Gulf Coast Medical Center, ICU 2321. [REDACTED] did not show any signs of foul play or unexplained injuries; [REDACTED] and his room were both photographed. Detective Bello also responded to [REDACTED] cell at the time of the fall, located inside the downtown jail's medical floor, cell 2F21. Nothing concerning was observed inside the cell [REDACTED] no suicide notes or paraphernalia was observed anywhere. [REDACTED] cell was also photographed.*

*On Wednesday, June 3, 2026, [REDACTED] succumbed to his injuries and was pronounced deceased at 8:20 AM by hospital staff.*

*Medical Examiner Investigator Matt Gleason was notified and provided with details of the incident and next of kin information. MEI Gleason did not have any concerns of foul play. Transcon responded and transported the decedent to the Medical Examiner's Office for a postmortem examination.*

*Detective Bello spoke to the decedent's next of kin and notified him of [REDACTED] passing.*
