

To: Parents/Guardians of all Kindergarteners and 1st Grade Students

The safety and well-being of your student is paramount to Charlotte County Public Schools (CCPS). To that end, the School Board established policy 8600 requiring parents/guardians to escort students in kindergarten and 1st grade to and from the bus stop. The policy requires any student not met by the designated escort be returned to the school of attendance.

Our drivers have responsibility for ensuring the safety of all students assigned to their bus, including ensuring the proper escort is present to assume custody of the kindergarten and 1st grade students on the bus. This responsibility includes ensuring the student is in the physical custody of the escort when the student leaves the school bus. Failing to do so could result in a young student being injured, left at the stop without an escort, or otherwise placed in an unacceptable, unsafe situation.

As a parent/guardian, you or your designated escort (including daycare providers) must be at the correct stop, standing at the door of the bus to assume custody of your student. Escorts in a vehicle, standing away from the bus in a driveway or corner, or standing across the street cannot react when a student acts unsafely, nor can the driver make positive identification of the escort before releasing custody of the student. By standing at the door of the bus, you are able to assist your child and the driver can ensure the proper escort has custody of the student.

Please fill out the attached CCPS Transportation "Student Bus Stop Escort Form", and return it to your assigned bus driver as soon as possible.
