


On May 20th 2021, I, Officer M. Rubenstein N889 of the Florida Fish and Wildlife Conservation Commission Division of Law Enforcement (FWC) was on-duty, conducting law enforcement patrol in Collier County, State of Florida.

I responded to a phone call from a neighbor at 4275 22ND AVE SE, NAPLES COLLIER FL 34117 in reference to a Florida Panther attack on a personal pet (dog). The attack happened around 10:00 PM on the 19th about 3 feet from the front door of the house and was **119.071(3)(a) and 281.301**. The dog was taken to the vet with injuries to the eye.

I contacted Mark (Panther Bio) and had him come out and walk the property as well as put up a sign for panthers in the area and educate the block with literature.

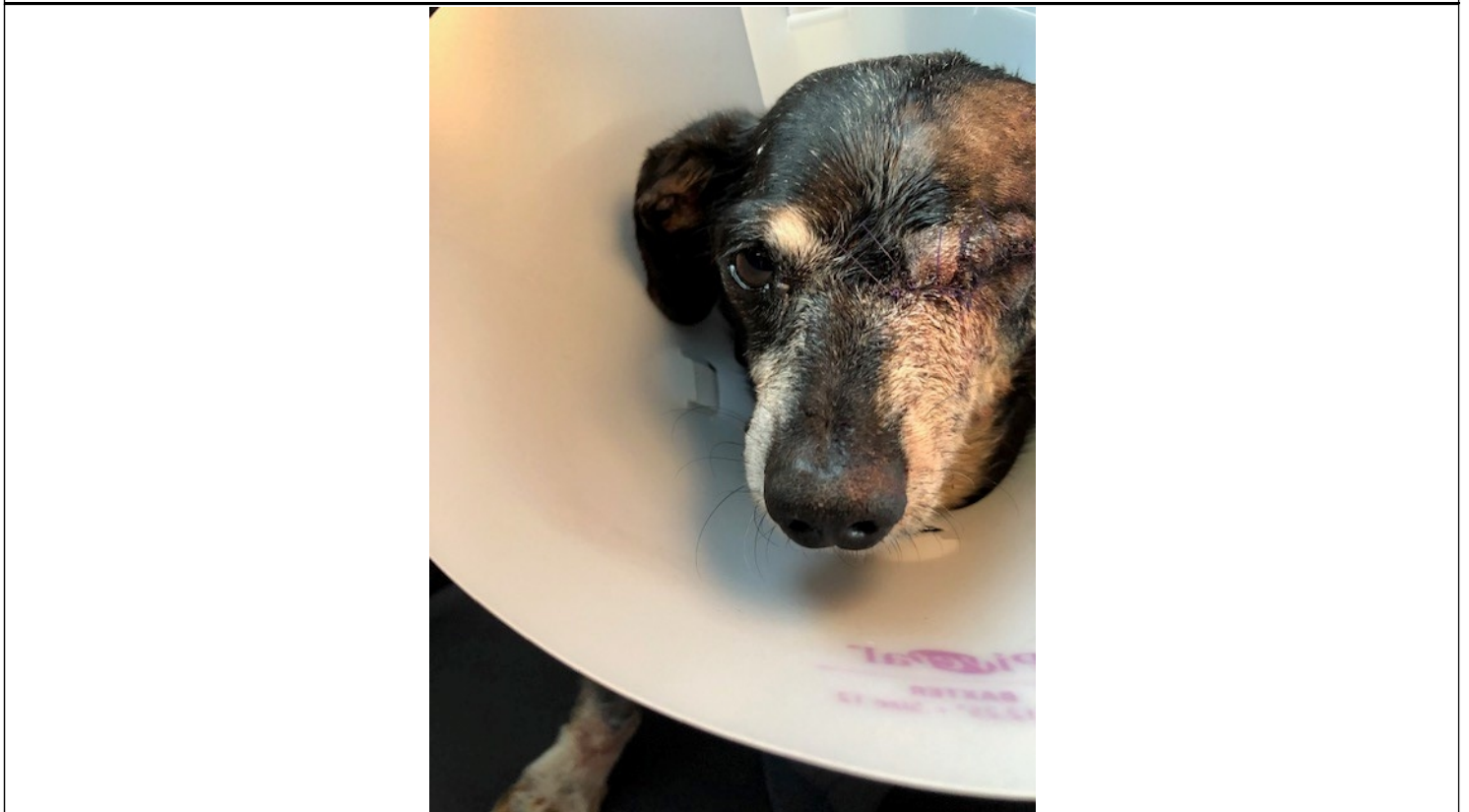
