· In · October 2023, Michael Whiting wanted to meet with me to discuss a case. He drove me to Round Valley because there was another matter I needed to tend to. While there, Michael pulled in to the Western Drug parking lot. It was after dark. Michael told ne to get out of the car and leave my phone in the car. the lasked him what was going on and he said get out of the cor and leave my phone in the cor. He said it was a "leave-your-phone-in-the-car conversation." I told hin that I felt I was either gotting murdered or Fired. He told me to get out of the car. We went to a nearby construction fence and he told me about the case, I was fearful and dish't know what to do because Michael's behavior was strange.

In April 2024, I received a letter from the County Elections Director. The letter was written by Fernando Madrid, who was a political opponent of Joy Whiting, Michael's wife. The letter indicated Madrid was introducing from the race because he was threatened, intimidated, and assaulted by Michael Whiting. Shortly thereafter is when the Trent series and Daryl Greer began Following Me.
