# INTRODUCTION

West Virginia University (WVU) provides this Campus Hazing Transparency Report (CHTR) in compliance with the Stop Campus Hazing Act, Public Law No: 118-173.

The purpose of this law, enacted in 2024, requires institutions — which were not already doing so — to take specific measures to prevent hazing through prevention education efforts, report allegations of hazing on the Annual Security Report, and address allegations of hazing through the student conduct code process.

The CHTR documents cases in which established or recognized student organizations, or a member or members of an established or recognized student organization are found responsible for a hazing violation at WVU.

## AVAILABILITY OF HAZING STATISTICS IN THE ANNUAL SECURITY REPORT

West Virginia University tracks allegations of hazing that were reported to have occurred on Clery Geography specifically for the inclusion in the University's Annual Security Report. No confirmation, investigation, or discipline is necessary for these hazing statistics to be counted. The University started collecting those statistics during the 2025 calendar year and they will be included in the 2026 and subsequent published Annual Security Reports. ## WVU HAZING PREVENTION PROGRAMMING

In November 2025, the "Hazing: What you need to know" eLearning course was created and is required for first semester WVU students at all campuses.

This course covers the definition of hazing, how to identify hazing behaviors, strategies for prevention, how to report hazing incidents, and the University's process for investigating allegations and handling disciplinary actions.

While completion of this training is required for certain student groups, it is strongly recommended that all members of the campus community — including faculty and staff — take the training as well.

# WVU, W. VA. STATE CODE DEFINITIONS OF HAZING

The Student Conduct Code and discipline procedure for the main campus of West Virginia University defines hazing as follows:

“Hazing” means to cause any action or situation which recklessly or intentionally endangers the mental or physical health or safety of another person or persons or causes another person or persons to destroy or remove public or private property for the purpose of initiation or admission into or affiliation with, or as a condition for continued membership in, any organization the members of which are primarily students. Hazing includes but is not limited to, acts of a physical nature, such as whipping, beating, branding, required consumption of any food, liquor, drug, or other substance, or any other required physical activity which may reasonably be deemed to adversely affect the physical health and safety of the person or persons so treated, and includes any activity that would subject the person or persons so treated to extreme mental stress, such as sleep deprivation, forced exclusion from social contact, required conduct that could result in extreme embarrassment, or any other required activity that may reasonably be deemed to adversely affect the mental health or dignity of the person or persons so treated, or any willful destruction or removal of public or private property. Hazing, whether with or without another’s consent, is prohibited. See generally West Virginia Code §18-16-2(1) (stating “implied or expressed consent or willingness of a person or persons to hazing may not be a defense . . .”).

Pursuant to West Virginia Code §18-16-2, hazing means:

“[T]o cause any action or situation which recklessly or intentionally endangers the mental or physical health or safety of another person or persons or causes another person or persons to destroy or remove public or private property for the purpose of initiation or admission into or affiliation with, or as a condition for continued membership in, any organization the members of which are primarily students or alumni of an institution of higher education. The term includes, but is not limited to, acts of a physical nature, such as whipping, beating, branding, required consumption of any food, liquor, drug, or other substance, or any other required physical activity which could reasonably be deemed to adversely affect the physical health and safety of the person or persons so treated, and includes any activity which would subject the person or persons so treated to extreme mental stress, such as sleep deprivation, forced exclusion from social contact, required conduct which could result in extreme embarrassment, or any other required activity which could reasonably be deemed to adversely affect the mental health or dignity of the person or persons so treated, or any willful destruction or removal of public or private property: Provided, That the implied or expressed consent or willingness of a person or persons to hazing may not be a defense under this section.”

The penalty for hazing, under West Virginia law, is set in W. Va. Code §18-16-3, and provides:

“Any person who causes hazing is guilty of a misdemeanor and, upon conviction thereof, shall be fined not less than \$100 nor more than \$1,000, or confined in jail for not more than nine months, or both fined and confined.”

## RESPONSIBLE FINDINGS OF HAZING

WVU monitors cases of alleged hazing on- or off- campus. Complaints of hazing against recognized or established student organizations which have been investigated by the University and the said organizations(s) and/or members of the said organization that have been found responsible will be published below. The results below reflect incidents reported and/or findings of responsibility have been made during the timeframe specified in the title of this report.
